

To the Class.

HIS little bundle of facts, that staggers under the dignified title of "Class Record," is offered to the friends and members of Ninety Six in an endeavor to fill a dual need. The primary and paramount motive of its publication is the hope that it may be

one more link that binds us together in class union as loyal Princeton men; and if it serves this purpose the labor preceding its issue has not been wasted. It also aims to satisfy a further practical need by enabling both the members of the class and all interested fellow Princetonians to know where any particular man is to be found, and what Ninety Six men are residing in or near our large cities, where it is often necessary to gather Princeton men together. The many requests for just this kind of information that have been addressed to the class secretary during the past year are a good index of the desirability of having it in printed form.

It has been the earnest endeavor of your secretary to have this little book give the latest information about each man, and to have the absence of errors a distinguishing feature. In theory this is delightfully possible, but the practical results will, I fear, be found unsatisfactory in many cases. The effectiveness of graduate organization largely depends upon the promptness and reliability of the individual members in responding to class correspondence, and upon their faithfulness in keeping the secretary advised of their changes of residence and occupation; but it seems that this foundation, being only human, is too often unstable. And, as there has not yet been discovered any subtle mental process whereby we can know of the lives of absent friends without either direct or indirect communication with them, paucity of information will often result in misstatement. So if the following information about yourselves is incomplete or out of date, it will undoubtedly be found that the cause is your own failure to write.

During the Christmas holidays this winter I was talking with a Ninety Six man whom I had not seen since graduation, and as the course of conversation drifted toward class matters, he said, speaking of my letters to the class: "Why, you don't expect us to answer those things, do you?" This, coming from a "rooter of the rooters," was rather staggering. And, judging from facts, it seems to be the attitude of not a few, who were most prominent in college, and of whose devotion to the Alma Mater there is no doubt. Against such opinions the most painstaking efforts of your secretary can be of little avail; but, fortunately, those who profess this heresy are in the distinguished minority. The larger part of the class are prompt in their responses, and much praise is due them for their efforts to strengthen our union. I trust it is not out of place here, if I allow the personal element to enter for a moment, in extending my heartiest thanks to those men on whom I can always count for an immediate response to the class letters.

With these few words of introduction the First Class Record is offered to the Class of Ninety Six, in the hope that its shortcomings will be overlooked upon consideration of the many hours of leisure that have been sacrificed in its preparation, and of the excellence of the motives that have prompted its issue.

T the very beginning of his work every class secretary is confronted with a difficult problem, namely, whether every one who has been a member of the class, no matter for how brief a period, shall be enrolled on the list of membership. Of those men

who leave college before the end of their course, there are some who, though their stay at Princeton may have been limited to a few months, give constant evidence of a loyalty to the Alma Mater unsurpassed even by the men who were fortunate enough to complete their four years' stay; others become members of sister colleges, and find their affiliations there; but there are still others who preserve a silence that tends to make the class forget them as they seem to have forgotten us. Our class is no exception to the rule, for the number of those who "fell by the wayside" is legion.

The fairest way seems to be to let the ex-members prove their interest or indifference; and this is the course your secretary has tried to follow. During the year after graduation, the ex-members received from the class secretary the same attention as the graduates of the class, and then in May last this letter was sent to those ex-members who made no response to the several class letters of the year 1896-7:

"MAY 24, 1897.

"During the past year I have been sending you, as a regular member of the Class of Ninety Six of Princeton, all the official letters and circulars issued by me as class secretary. Although your connection with the class did not extend throughout the regular four-years' course. I have, during the past year, considered you a regular member of the class. I have sent you letters that required the courtesy of an answer, leaving aside the consideration of devotion to the college. You have so far failed to reply to any of my letters.

"The unpleasant conclusion is being forced upon me that your interest in the class and in Princeton has decreased, and that you no longer desire to interest yourself in the welfare of your fellow classmates of Ninety Six. Your own persistent silence and failure to respond to my letters has led me to accept this conclusion. I trust that you will realize that the duties of the secretary of a class of 350 members are not slight, and that these duties are considerably increased by the failure of some members to reply to letters. Therefore, unless you answer this letter, I shall be obliged to make it my last communication with you on class matters.

"If I do not hear from you on or before July 1st, in response, I will accept your silence as a determination to no longer identify yourself with the class, and will drop your name from the rolls, and will send you no class letters in future.

"I wish to assure you of my desire to serve you in all matters pertaining to our class, and sincerely hope you will let me hear from you.

"Awaiting your reply, I am, yours for Ninety Six,

C. B. BOSTWICK, Class Secretary."

In sending this letter, it was not the desire of your secretary to deal arbitrarily with the men who had not answered the class letters, but rather his wish to be able to devote his time and services only to those men who evince their desire to be active, loyal members of the class.

Therefore, on July 1st, 1897, the names of the men on the appended list were dropped from the rolls, as no letters had come from them, although prompt response was made by many to whom the above letter was sent, who had previously been remiss in their correspondence. If any of the men whose names are given below wish to be reinstated upon the class rolls, and will write to the secretary, it will be both his pleasure and his duty to comply with their request.

Matters Financial.

T has been a cause of great regret to the class secretary, and undoubtedly no unqualified delight to the class, that almost every class letter has had to touch on the question of the class funds, and, more than that, has had to ask the members for assess-

ments for varying amounts. Class finances are hard enough to direct when the men are in college, but when the class is scattered the difficulties are multiplied. So often has necessary mention been made of the depleted state of the class treasury, that it has seemed best to include in the present book the account of receipts and expenses given in the annexed report.

It will be seen that, to supply a present deficiency of funds, it has been necessary to borrow from the Decennial Memorial Fund the sum of 149.25, which loan is covered by unpaid Class-Day and Sesquicentennial assessments amounting to 164. But it is manifestly unfair that money subscribed by a part of the class for a specific purpose should be used to cover a deficit in the general fund, caused by the failure of some members to meet their obligations; and it will be the persistent endeavor of the secretary to see that this temporary loan is repaid at the earliest possible moment. Of course this can not be more easily effected than by prompt action on the part of members in arrears in settling their accounts.

The class has at present no outstanding obligations beside this loan from the Decennial Fund, and the expenses of publication of this "Class Record," which latter will be amply provided for by the cash on hand and the receipt of subscriptions for the book, subsequent to its publication. Every man who has not yet subscribed for a copy of the book is requested to do so as soon as possible and thus assist in the reduction of the class liabilities.

UR First Reunion was held at the time of the Sesquicentennial Celebration, October 20th to 22d, 1896. Our class being in point of numbers Princeton's foremost class, it occasioned no surprise that Ninety Six had more Alumni back than any other

class. The register showed an attendance of about one hundred and seventy-five men. The class headquarters were on Witherspoon street, and were constantly crowded with the returning members of the class. Princeton was filled to overflowing with visitors, but the town offered so many unusual holiday ceremonies and festivities, that there were few opportunities for unity of demonstration as a class. In the Alumni Procession we were given the post of honor as rear guard, and after a long parade around town, sat down to a supper at the headquarters, after which the farewells were said.

In June, 1897, there was a second reunion at Commencement time, at which about eighty-five men were present. The only general gathering of the class was on the day of the Yale game, when we attended the game in a body, entering the varsity grounds in solemn state, preceded by the "Spoon Street" Cadet Band.

Last fall, there was a very informal reunion on October 30th, the day of the game with Dartmouth. The object in holding a reunion on that particular occasion was to avoid the separation that necessarily occurs when a class reunion is held at the time of important athletic events or college festivities of any sort. The reunion was an experiment, and a successful one, there being about fifty men present. The class attended the football game *en masse*, and in the evening met at the *Princetonian* office, where a procession was formed. Most of the men in line were somewhat transformed in appearance, owing to the use, as overcoats. of pajamas and kindred articles of apparel, and to the further disguise afforded by theatrical paint and false beards, which were tastefully distributed about our faces by the trained hands of some members who had once been shining lights of the Triangle Club. The "Spoon Street" orchestra was again in evidence, heading a parade that wandered around "the burgh" for two or three hours, giving the residents a treat and calling on the President and the Dean, who made speeches of welcome. The reunion was voted "good horse," though detracting from our graduate dignity!

Next June the class will have a reunion similar to last year's, at which the activity of the class as a unit will be confined to a parade to the Yale game and to any impromptu celebrations that may then be decided upon. The class will meet at the headquarters in Dickinson Hall on the day of the Yale game at one o'clock. There will be no general assessment to cover the slight expenses of the reunion, which can be met by "taking a collection" from the members present.
