

This is basically an updating of Exchange Bibliography No. 18, Residential Densities, by Robert D. Katz. Entries have been more than doubled, principally with material published subsequent to 1960. A few additional references prior to 1960 are newly discovered and did not appear in No. 18. I have listed items available to me up to February 1973.

Selection followed the sound pattern established by Professor Katz in the earlier bibliography, meaning that, in addition to specific references on residential unit densities, the following were included: (1) population densities implying residential standards; (2) writings on health and housing discussing specific housing types; (3) writings of planning theorists whose theories are based on clearly stated density standards, or on specific residential types than can be translated into such standards; (4) materials on housing types dealing with density indirectly; and (5) treatises on residential site planning and design which make possible the computation of residential densities.

In addition to the above categories, I have added a new one: resort unit density. There are very few writings on this subject, but resort use is residential in nature, even where residents are very transient. Some experienced resort and tourist destination area planners, especially in the warmer climates, find unit density standards a very important design element. Entries which deal with resort density are indicated with an asterisk. It is hoped that their inclusion will stimulate publication of additional articles on this neglected subject, or lead to discovery of other already published references.

Excluded from this listing are the growing numbers of references on crowding and population density, on the behavioral, cultural, physiological, psychological, and similar aspects of density. These areas have already been canvassed in the following bibliographies:


