RVAA will have an exhibit of members' work at the Somerset County Administration Building, in Somerville, just off Main Street.

Installation date--July 10, 1995 from 10 am to noon. (there will be no judging at this show). Categories consist of watercolor, pastel, drawing, and mixed media under glass. Works, such as oils, not under glass, are hung at members' own risk. No sculpture. No distinction between pro and non-pro. The show runs until Friday, September 1.

Works should not exceed 30" including frame. Ready for hanging by wire. One piece per member. VIP. 55 linear feet are available so there is room for approximately 20 works. Show fee is \$5.00. RVAA will pay \$50. to the Somerset County Cultural and Heritage Commission (Gallery sponsor/ owners). Therefore, there will be a first come, first serve and if there are too many works submitted, those after 20 pieces will get their fee back. Application must be made by Wed, June 15 and sent to E. A. Golubiewski 516 Thompson Ave., Bound Brook, NJ, 08805. Make checks out to RVAA.
