Debbie Tintle has arranged for watercolorist Ron Lent to give us our May demo, Monday, May 20th, Somerset County/Bridgewater Library, from 7:30-10 pm. Most of you know and admire his work, at NJWS and GSWS shows, and many other shows; some of you have studied with him. Ron's an excellent demonstrator (and quite amusing) and I know you'll have a good evening.

Upcoming shows include our Spring Members' Show at the Manville Public Library--just go down Finderne Ave. from Rt. 22E and hang a right onto Camplaign. Delivery will be Sat. June 1 from 10 to 12. Elsa Herrmann is our able show chairwoman. The show will be judged; you may enter in pro or non-pro categories. Minimum size painting is 9"x 12"; maximum 30" x 40"; all work must be originals. The show will be up for the whole month with pick-up Saturday, June 29. Manville Library has all sorts of concerts and programs, so there should be a lot of traffic there.

Also, our Invitational Show at the Somerset County Cultural & Heritage Commission Gallery in the County Administration Building (Grove Street in Somerville). Show delivery is Monday, June 10 from 10 to 12; pick-up is Wednesday, July 3. There will be no judging of this show. The categories are watercolor, pastel, drawing, and mixed media under glass. Works not under glass are shown at members' own risk. No sculpture can be exhibited; there is no distinction between pro and non-pro. 55 linear feet are available, so since there is only room for about 20 paintings, you must get your name, address, phone number, title & size of work, medium, price/value

(for insurance purposes) and local newspaper (for the Commission's publicity purposes), and fee A.S.A.P, first come, first served, to Dr. Ed Golubiewski, 516 Thompson Ave, Bound Brook, 08805. The fee for the show will be \$5. RVAA will pay \$50. to the Somerset County Cultural & Heritage Commission. 15% commission goes to the Commission, and they'd appreciate any photo of your submitted work for publicity. If possible, use a Somerset County theme for your painting. Because there is limited room, the fee for any painting submitted after the 55' is used up will be returned.
