#### Snowflake greetings!

Hopefully no snowstorm will interfere with our March demo, Wednesday March 20, 7:15 pm at the Somerset County Library, when artist Carole Katz will demonstrate. Carole, a fine art portrait painter in oils, with a BA and BFA, also studied with master portrait artist Marvin Mattelson at the School of Visual Arts in NYC for several years and has taken classes at the Fashion Institute of Technology; NYC: duCret School of Art in Plainfield, NJ; the Art Students League of NY; the New York Academy of Art and the National Academy of Art. Carole says "For me, the most interesting and challenging subject in art is portraiture. Every person or animal is totally unique and presents a unique and interesting challenge with every new painting. Working to create a 3 dimensional likeness of my subject on a 2 dimensional canvas and to incorporate the personality and emotion of the subject is the challenge that intrigues me and continues to inspire me." Carole will do a color mixing demo. Working with a controlled palette, she mixes all her values and colors and tubes them. She will demonstrate this process and show the controlled palette which she learned from an artist/teacher trained by Norman Rockwell and also from portraitist Marvin Mattelson.
