Here is a quick update:

### **GRYD Prevention**

**Barrio Action:** Barrio Action's appeal was denied, as expected. A letter will be mailed out to Barrio soon. However, GRYD Office will be using its discretion to carve out a GRYD Zone for El Sereno exclusively. That means Alma will be losing El Sereno but keeping Lincoln Heights. This also means a smaller contract for Barrio but it remains as the GRYD provider for El Sereno.

This may not be the best win but I think it is a win nonetheless.

**Legacy LA:** The appeal's panel requested further information from Legacy LA to share with the original evaluator's panel for it to reconsider whether or not anything was overlooked in selecting Alma Family Services over Legacy LA.

### **GRYD Intervention**

For the northeast area, Breaking Barriers, which is Raul Claros' group won the contract after all. The Appeals Panel rejected SEA's contract because it was late and granted the contract to the second bidder which was this group.

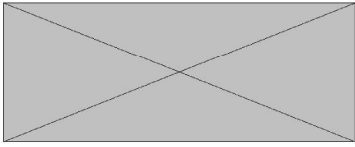

## MOTION

WE MOVE that the matter of the Rules, Elections and Intergovernmental Relations Committee Report relative to a proposal to use cannabis tax revenue to establish a Neighborhood Health Fund and other Community Benefit-Type programming, Item 9 on today's Council Agenda (C.F. 14-0366-S18), BE AMENDED to ADOPT the following recommendations in lieu of the recommendation in the Report:

1. REQUEST the City Attorney, with the assistance of the Department of Cannabis Regulation (DCR), City Administrative Officer (CAO), Office of Finance, and the Chair, Rules, Elections, and Intergovernmental Relations (REIR) Committee, to prepare and present the necessary election Ordinance and Resolutions to place a ballot measure before the voters at the November 6, 2018 State General Election entitled the Cannabis Reinvestment Act, and that the ballot measure would include the following elements:
  - a. Effective January 1, 2019, one percent special gross receipts tax on all commercial cannabis activity to be reinvested in the community with all funds going to a newly created Cannabis Reinvestment Trust Fund to be apportioned as follows:
    - i. 50 percent distributed between the Council offices based on the percentage of licenses by Council District. Taxes to be used within one mile radius of any licensed cannabis business for various public improvements (e.g. streetscape, façade improvements, sidewalk repair, building construction or rehabilitation, etc.) or child and youth programs (as defined in a(iii)), or at the closest City park, City recreation center, or City library. If money is unspent after five years, may be used anywhere in the Council District for the same purposes. Neighborhood Councils will give advisory recommendations to Council office April 1st of every year, beginning 2020, and Council will approve distribution via Council action. Cannot not be used to establish a new sensitive use under Article V Chapter X of the Los Angeles Municipal Code (LAMC).
    - ii. 25 percent distributed to the DCR for public education and outreach, equity programs, expungement clinics, illegal enforcement, and other cannabis-related programming. This cannot be used for license processing nor license compliance and enforcement.
    - iii. 25 percent distributed to the Cannabis Youth Prevention and Child Strengthening Program; Youth prevention defined as any youth and/or child development activities ages 0-24. Program administration, guidelines, and process to be established by Ordinance.
  - b. Effective January 1, 2019, a five dollar special surcharge on any test of cannabis products conducted by a licensed commercial cannabis testing laboratory with funds going to the Cannabis Reinvestment Trust Fund and distributed to the Cannabis Science, Technology, Engineering, and Math (STEM) Education Program. Program administration, guidelines, and process to be established by Ordinance.
  - c. Effective January 1, 2019, a five dollar special surcharge on any tickets sold for a temporary cannabis event with funds going to the Cannabis Reinvestment Trust Fund and distributed to the DCR for public education and outreach, equity programs, expungement clinics, illegal enforcement, and other cannabis-related programming. This cannot be used for license processing nor license compliance and enforcement.
  - d. Effective January 1, 2019, a one percent special gross receipts tax on a licensed cannabis event organizer and a registered cannabis management company with funds going to the Cannabis

Reinvestment Trust Fund and distributed to the DCR for public education and outreach, equity programs, expungement clinics, illegal enforcement, and other cannabis-related programming. This cannot be used for license processing nor license compliance and enforcement.

- e. Cannabis Corporate Responsibility Policy- requires all licensed commercial cannabis businesses to prepare and deliver a report to the DCR on February 1st of every year describing community engagement, corporate philanthropy, and relationship with surrounding neighborhood(s). Reports to be made public on the DCR website and will be scored by license category in combination with compliance status and any violations from the previous year.
2. REQUEST the City Attorney, with the assistance of the DCR, CAO, Office of Finance, and the Chair, REIR Committee, to prepare and present an Ordinance to amend the provisions under Ordinance No. 184841 (Proposition M) to be only effective upon passage of the Cannabis Reinvestment Act and then effective on January 1, 2020 and would include the following elements:
    - a. Reduce the medical cannabis gross receipts tax to three percent, increase back to five percent over four years.
    - b. Reduce adult use cannabis gross receipts tax to eight percent, increase back to ten percent over four years; unless on-site consumption, then remains ten percent.
    - c. Reduce distribution and testing laboratory gross receipts tax to .25 percent; increase back to one percent over three years.
    - d. Reduce cultivation and manufacturing gross receipts tax to .5 percent and increase back to two percent over three years.
  3. INSTRUCT the CAO, with the assistance of the Office of Finance, DCR, and the Chair, REIR Committee, to report back on a fiscal impact analysis and revenue impacts no later than 2pm on Friday June 15, 2018.
  2. AUTHORIZE the City Attorney, with the assistance of the Chair, REIR Committee, to make any technical modifications and/or legal corrections to the draft election ordinance, draft ballot resolutions, and any other related actions listed above in order to further the objectives as described in these recommendations.
  3. REQUEST the City Attorney to transmit the necessary reports, Ordinance, and draft ballot resolutions as outlined above to the City Clerk's office no later than 2 pm on Friday June 15, 2018.

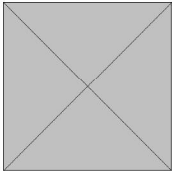



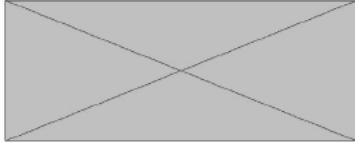

### **Old & New – History & Making It**

It's the 50<sup>th</sup> Anniversary of when these stairs were redone!! The stairs were originally built in 1929 so people could have a quick and direct walkway to the main street. They were completely redone in 1968 to the stairs we see today. As our neighborhood is becoming safer, people are starting to walk around again. As we can all see, these stairs are ready for some love.

We are planning to connect with El Sereno Middle School and other neighborhood kids to get our young community involved. The plan is to engage the young people of our community to come up with a theme for the stairs. Once the theme is decided on, we will provide the artists and the supplies to bring this vision to life.

Our goal is to create pride in our neighborhood and to do it through art and our connection with the young people in our area. We feel it is very important for them to feel this connection to all of us because they truly are the future of El Sereno. We believe if people have the opportunity to be involved in creating art for the community that it will be infectious and inspire more and more!

### **The Art & Artists - 14 Landings and 220 Stairs**

There are many ways to produce the results that we are envisioning but we feel it is very important to engage the young people of our community to bring this to life.

The young people create the theme and with the help of local artists we will all work together to physically bring this vision to life. The artists will create murals on the landings and the community will help paint all of the remaining stairs and railings in between.

We would like to bring in around 5-7 local artists and we will break into teams. Each team will be assigned a set of landings and stairs that they will be painting. All of the artists will bring their artistic visions through with the help of their teams.

There's a wall that's connected to Landing #2 of the stairs that has been an exhausting battle for the homeowners to deal with the gangs/taggers constantly spray painting it. We would like to create a beautiful mural here that will connect with the vision of the stairs and discourage future tagging.

Lastly, we plan to appoint an art director to oversee the full vision of this project and to ensure that all of the different art comes together perfectly. We want to make sure that the end visual is a pleasing one for everyone to enjoy.

### **The Future – El Sereno Works Together**

This is also a good positive publicity opportunity for the El Sereno community. We would like to start building a positive reputation and let the rest of the city see how special this little forgotten spot is. We've already started working on a short documentary about this renovation so we have a really fun visual to share with our local media outlets!! This is a win for everyone!!

### The List – Things We Would Like

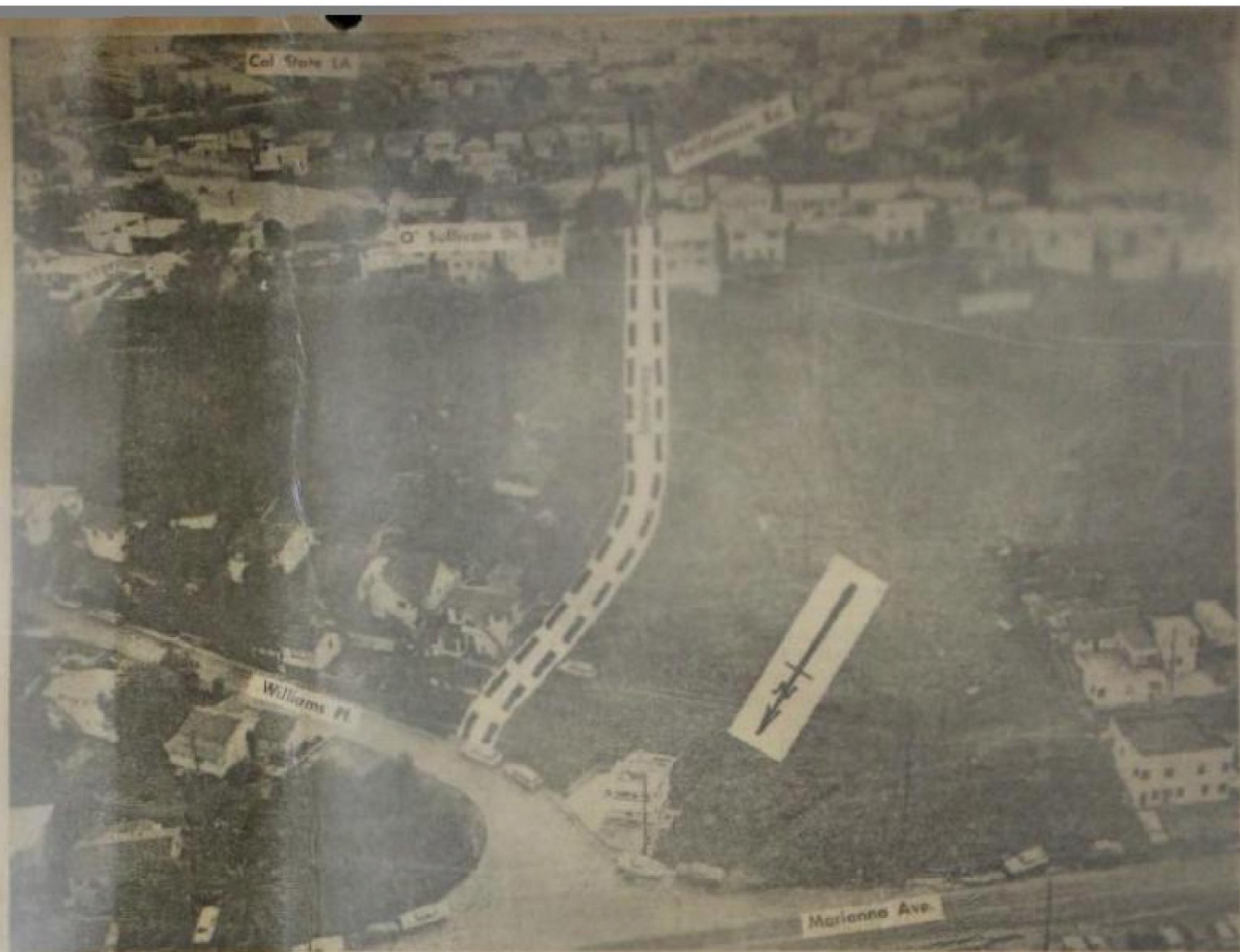
- \* Paint & supplies – exact needs will be determined by the artists

That rickety old stairway from Williams Place to O'Sullivan Drive in El Sereno, first built in 1929 and now condemned by the city, will be replaced early in 1968, according to Councilman John Holland's office. Design work on a new stairway will be completed this year with construction work to follow. The old walk has been closed pending reconstruction. The new stairway, estimated to cost approximately \$21,400, is needed to save at least a three block walk for nearby residents.

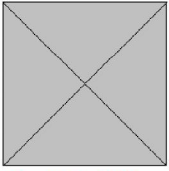

Xavier Becerra is the the 33rd Attorney General of California, and the first Latino to hold the office in state history. Professor Valenzuela holds a joint appointment in the Department of Chicana/o Studies and Urban Planning. His research is primarily concerned with the issues faced by minorities and immigrants in the U.S. His work focuses on three key areas, which are interrelated: 1) immigration and labor markets, 2) poverty and inequality, and 3) immigrant settlement patterns and related services. His work combines ethnographic, in-depth interviews, participant observation, and quantitative methods to document and explain the processes that govern the incorporation of immigrants into U.S. society. He is currently working on several projects looking at low skilled immigrant workers, the role of immigrant workers and disaster relief, and immigrant participation in civil society.

At UCLA, Professor Valenzuela Directs the Center for the Study of Urban Poverty. He teaches courses on immigration and U.S. society, urban poverty and public policy, labor markets, and planning issues in minority communities.

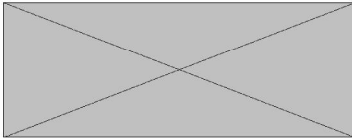
