No one was more surprised than I when I returned home one evening and heard a woman say, "This is Myrna Hansen. Could you please contact me?"

I was in a state of shock because I had been under the impression she had disappeared. Then I heard a rumor that she was no longer living. So you can imagine the happiness I felt when I heard her voice. So, I immediately contacted her.

Myrna is very much alive and well and I have promised to keep her whereabouts secret to protect her and her son from some of the UFO vulture fanatics out there in the world. I found her to be very kind and compassionate and was very impressed by her demeanor over the telephone.

Unfortunately, since I was unaware of what actually transpired between Paul Bennewitz and Myrna and APRO I quoted from her regression transcripts as I felt they were valid. Myrna expressed her disappointment with the way her abduction case was handled and told me that what was in the original transcripts was only half the story. I was getting excited at this point.

She told me of other strange incidents that happened which later surfaced and expressed an interest in possibly meeting me to discuss and hear the whole story. She insinuated that I hardly knew all of what transpired that one night in which she and her son will never forget. She expressed concern in once again going public after so many years. I did not want to push her into doing anything that would make her feel uncomfortable so I decided to leave her to her thoughts and give her some time to think about it.

We have spoken about doing a manuscript of both our experiences since they are so much alike, but I encouraged her to maybe do something on her own. Myrna has lived a normal life since her abduction and has a deep faith in God. As a believer myself, I felt even closer to her.

We think we know, we hope we have come close to some semblance of the truth but in reality only Paul and Myrna, Rick Doty, Bill Moore and Jaime Shandera know what really happened to Paul. We are going to be waiting for Bill, Rick and Jaime's 'SPECIAL REPORT' to hear their side of the story.

We want to thank Myrna Hansen for giving us this much of herself. She is to be commended and we hope to hear from her very soon.

UFOs: U.S. reports tell of five sightings in 1980 over Kirtland; city man claims alien contact

Just-released government reports document five sightings of unidentified flying objects during August 1980 over Kirtland Air Force Base.

The mysterious encounters, as described in Air Force reports and revealed through the Freedom of

Information Act, were:

On Aug. 8, "three security policemen... on duty inside the Manzano Weapons Storage Area sighted an unidentified light in the air that traveled north to south over the Coyote Canyon area of the Department of Defense Restricted Test Range on KAFB," the government reported.

The light traveled at high speed and stopped suddenly in the sky over Coyote Canyon and eventually landed in the canyon, according to the security policemen, who then witnessed it "take off and leave proceeding straight up at a high speed and

disappear.

• The next day, Aug. 9 a security guard at Sandia Laboratories on the base observed a bright light near the ground behing a building in Coyote Canyon. As he drove nearer, he saw a round, disk-shaped object and tried to rade for help. But his radio would

The guard, who did upt want his name divulged for fear of harassment, men walked up to the object_ armed with a shotgun. Suddenly, it took off, going

straight up at high speed.

The guard, a former Army helicopter mechanic, stated that the UFO was not a helicopter.

 The following day, Aug. 10, a New Mexico state policeman saw a flying object land in the Manzano Mountains between Belen and Albuquerque. When he reported the sighting to the Kirtland command post, he was told by the public relations office that the Air Force did not investigate sightings unless they occurred on an air base.

 Three days later, Aug. 13, radar equipment at Kirtland and the Albuquerque Airport experienced a total five-hour blackout from an "unknown cause." An Air Force report concluded that "the presence of hostile intelligence jamming cannot be ruled out," but went on to say "no evidence would suggest this."

Nine days later, on Aug. 22, three other security guards observed the same aerial phenomenon described by the first three guards two weeks

"Again the object landed in Coyote Canyon. They did not see the object take off," the report said. • The final Kirtland document is dated Oct. 28, 1980. In it, Air Force scientific advisor Jerry Miller concluded that a film taken by Four Hills resident

Paul Banewitz "clearly shows... some type of unidentified aerial objects" at Kirtland.

Miller is a former investigator for Project Bluebook, the Air Force's massive investigations of UFOs that ended in 1969.

Bennewitz, president of a local electronics firm, lives adjacent to the northern boundary of Manzano Base.

He said it was on Feb. 2, 1980, that he saw four "saucer or hat-shaped objects lined up behind the outside fence" of the Manzano area.

"A black spot and big blue halo appeared, establishing their force field. There was a flash under each one as they jumped off the ground in sync 300-400 feet, turned right and were gone to the south," he recalled.

He filmed the spectacle from about 2,500 yards away.

Bennewitz, according to the official Air Force report written months later, produced still photographs and 2,600 feet of 8mm motion picture film "depicting unidentified aerial objects flying over and around Manzano Weapons Storage Area and Coyote Canyon Test Area.

But investigator Miller reported only that "no conclusions could be made whether these objects pose a threat to Manzano-Coyote Canyon areas."

On Nov. 19, Bennewitz was told that the Air Force would not investigate the objects and "was not in a position to evaluate the information and photographs he has collected."

However, the sightings reportedly caught the interest of former New Mexico Sen. Harrison Schmitt, who inquired why the Air Force refused to investigate, the report said.

Within the past year or so, Bennewitz, who is convinced the UFOs are alien ships, has called Kirtland to again request an investigation, said George Pearce, Kirtland public affairs officer.

"He said he was in contact with alien beings through his computer and wanted us to investigate,

Pearce said.

'I told him we don't investigate those things since Project Bluebook ended in 1969 after 22 years of investigation. Of course, he wasn't pleased with the

Col. John Aday, chief of public affairs at Kirtland, Project Bluebook concluded that UFOs are no threat

to national defense.

He said he has "no idea" what the 1980 sightings could have been. "I could conjecture all day about what might have been going on out there, but I won't.

He said when the Air Force was investigating UFOs, it was often determined that they were

weather balloons or the like.

"I'm not saying that what Bennewitz saw or what the security police saw was anything like that, but because of the record of our investigations, it seems likely they were nothing dangerous to our national defense."

Bennewitz earlier this week in Albuquerque briefed a group of UFO enthusiasts on his personal three-year investigation into alien activities in New Mexico. He said he plans to put his observations into a book.

Among his conclusions are that there is an alien base inside an isolated mesa near Dulce, and that the

aliens intend to enslave the earth.

He said his study includes a statement taken from a New Mexico woman who was taken hostage near Cimarron by the aliens after she saw them mutilate a calf.

Bennewitz said he has seen the aliens on a video screen, and he described them as green and about 4

feet tall and "strong little bastards."

He told those gathered for the UFO briefing session that cattle mutilations are the aliens' source of supplies needed to build humanoids through gene splicing. They take the organs and blood from the animals while they are still alive in order to maintain a tremendous supply of DNA — the carrier of the genetic code - for this purpose, he said.

The Kirtland sightings in 1980 were described in reports sent to the Mutual UFO Network, a Texasbased UFO internation study group, by the Department of the Air Force in December 1982.

MUFON's effort to gather documents has been a tough, uphill battle with countless arms of government and military agencies.

"We call it our cosmic Watergate," Andrus said.

Entertaining the Government

There are not too many people in UFO circles today who haven't heard the name Paul Bennewitz. Many researchers, investigators and just curious people have flocked to Albuquerque, New Mexico in hopes of just getting a "few minutes" to spend with the eccentric gentleman. Some are lucky enough to be granted indepth interviews, while others are simply turned away at his door.

There are many stories and theories as to what Paul Bennewitz really knew and experienced. The whole truth may never be known. It reminds me of a black widow spider, stalking her prey like the U.S. government and Air Force encompassed Paul, surrounded him and kept watch on him for many years. All because of the subject of UFOS. But, I seem to be confused...didn't the Air Force dump the subject a long time ago because they just could not find any evidence that we were under any kind of threat from these unknown objects. If they came to that conclusion then my friends, the government must know more than what they are telling us, the American public.

As you will see throughout this whole intricate story, a pattern emerged and Paul Bennewitz became a very important target and a hero in my eyes. All we ask is to be told what really happened to this scientist and UFO researcher and so I will allow you, the curious ones alone to draw your own conclusions. I believe it will teach us all a lesson in trust and also an insight into the inhumane treatment some of our UFO researchers endure. Maybe all we can learn is strength and hope and praise Mr. Paul Bennewitz for his heroic efforts.

It is difficult to pinpoint just exactly where Paul's story begins so I will just state that Paul was a UFO Field Investigator for APRO which was a UFO organization headed by the late Jim and Coral Lorenzen in Tucson. It seems that in or around 1979 and 1980 Paul would immerse himself in several events that would forever change his life.

Paul Bennewitz was at that time the President of his own company, Thunder Scientific Corporation which sits just right of the gate to Kirtland Air Force Base. Apparently for almost two years Paul had been monitoring and recording activity seen in the skies over a large area around the Manzano Test Range near Kirtland Air Force Base. Paul obtained on film many UFOS flying over the Manzano Weapons Storage Area and the Coyote Canyon Test Area where nuclear materials are supposedly stored. Paul, immediately concerned, notified Kirtland Air Force Base and made a report to then a Major Ernest Edwards who was commander at the time for this restricted area.

Paul was invited to Kirtland to present his evidence to a number of individuals at which time he produced a film and photographs of UFOS taken by him over the past 15 months. But, Paul made another major error; he claimed also to have proof that he was in contact with the aliens flying these craft over Kirtland. - 3. On 26 Nov 80, SA DOTY received a phone call from an individual who identified himself as U.S. Senator HARRISON SCHMIDT, of New Mexico. SEN SCHMIDT inquired about AFOSI'S role in investigating the aerial phenomena: reported by Dr. BENNEWITZ. SA DOTY advised SEN SCHMIDT that AFOSI was not investigating the phenomena. SA DOTY then politely referred SEN SCHMIDT to AFOSI Dist 17/CC. SEN SCHMIDT declined to speak with 17/CC and informed SA DOTY he would request that SAF look into the matter and determine what USAF agency should investigate the phenomena.

 SEN SCHMIDT during the last few months regarding BENNEWITZ'S private research.

 SEN SCHMIDT has made telephone calls to BOEN BREOKSHER, AFOSP/CC regarding the matter since Security Police are responsible for the security of Manzano Storage Area.

At this particular meeting Paul met with a young Special Agent by the name of Richard C. Doty. Doty intimated to Paul that the AFOSI (the Air Force Office of Special Investigations) would not be involved in the investigation of these unidentified objects. In essence, Doty told Paul that the Air Force does not investigate UFOS.

This meeting with Richard Doty took place on November 10, 1980. Just a few months prior to this meeting Kirtland Air Force was visited by an unusual object that had been reported by a Sandia Security Guard.

Back to the November meeting first, apparently disgusted with the Air Force and their lack of interest, Paul contacted Senator Harrison Schmidt about the incident and knowing Paul and his UFO research was of great importance to Paul, he called Richard Doty requesting that the Air Force please look into this sensitive matter and see which agency or agencies should investigate.

On August 8, 1980, three security policemen assigned to duty at the Manzano Weapons area sighted the same UFO that was reported by a Sandia Security guard. The object was a bright light hovering near the Storage Area. He radioed that the object was disk-shaped. He tried to radio for back-up, but his radio suddenly was dead. May I clear up one error in my story here, the Sandia guard that he observed this disk-shaped object on August 9, 1980. Then on August 10, 1989 a New Mexico State Policeman sighted another object landing in the Manzano's. (See OSI Form #2-Exhibit Two)

All of these men stated flatly that it could not have been a helicopter. Apparently the object performed some pretty sensational aerial maneuvers which had to exclude any of our Earthly air craft.

Again this report was taken by a one Richard C. Doty who insinuated in the November meeting with Paul Bennewitz and other officers and to then Senator Harrison Schmidt that the Air Force was not in a position to investigate such objects.

This statement alone shows how wishy-washy our Air Force is with the subject of UFOS. Why wouldn't they hear Paul out in November after viewing his film and photos when all the time they were aware that unknown objects were flying all around our nuclear storage area. This seems to me to be important enough to ruffle someone's feathers!

On August 13, 1980 all hell broke loose at Kirtland Air Force Base. Coming from the area around Coyote Canyon the Air Force concluded that Radar Approach Control equipment and scanner radar was rendered inoperative. There was a total blackout including Albuquerque Airport which was in effect between 1630 hours to 2215 hours. We are talking several hours of frantic searching by the Air Force to determine where the jamming frquency was coming from. They concluded that the presence of hostile jamming cannot be ruled out. They never found the source of the problem. (See OSI Form #3- Exhibit Three)

Determined not to give up, Paul Bennewitz began contacting many government sources telling them of his plight. Some probably wanted to be of some help but felt the sensitivity of the subject could cause problems of their own. But soon after, Paul suddenly became the object of an AFOSI Congressional Inquiry. - - 1. On 2 Sept 80, SOURCE related on 8 Aug 80, three Security Policemen assigned to 1608 SPS, KAFB, NM, on duty inside the Manzano Weapons Storage Area sighted an unidentified light in the air that traveled from North to South over the Coyote Canyon area of the Department of Defense Restricted Test Range on KAFB, NM. The Security Policemen identified as: SSGT STEPHEN FERENZ, Area Supervisor, AIC MARTIN W. RIST and AMN ANTHONY D. FRAZIER, were later interviewed separately by SOURCE and all three related the same statement; At approximately 235Chrs., while on duty in Charlie Sector, East Side of Manzano, the three observed a very bright light in the sky approximately 3 miles North-North East of their position. The light traveled with great speed and stopped suddenly in the sky over Coyote Canyon. The three first thought the object was a helicopter, however, after observing the strange aerial maneuvers (stop and go), they felt a helicopter couldn't have performed such skills. The light landed in the Coyote Canyon area. Sometime later, three witnessed the light take off and leave proceeding straight up at a hight speed and disappear.
 - 2. Central Security Control (CSC) inside Manzano, contacted Sandia Security, who conducts frequent building checks on two alarmed structures in the area. They advised that a patrol was already in the area and would investigate.
 - 3. On 11 Aug 80, RUSS CURTIS, Sandia Security, advised that on 9 Aug 80, a Sandia Security Quard, (who wishes his name not be divulged for fear of harassment), related the following: At approximately 0020hrs., he was driving East on the Coyote Canyon access road on a routine building check of an alarmed structure. As he approached the structure he observed a bright light near the ground behind the structure. He also observed an object he first thought was a helicopter. But after driving closer, he observed a round disk shaped object. He attempted to radio for a back up patrol but his radio would not work. As he approached the object on foot armed with a shotgun, the object took off in a vertical direction at a high rate of speed. The guard was a former helicopter mechanic in the U.S. Army and stated the object he observed was not a helicopter.
 - 4. SOURCE advised on 22 Aug 80, three other security policemen observed the same



aerial phenomena described by the first three. Again the object landed in Coyote Canyon. They did not see the object take off.

- 5. Coyote Canyon is part of a large restricted test range used by the Air Force Weapons Laboratory, Sandia Laboratories, Defense Nuclear Agency and the Department of Energy. The range was formerly patrolled by Sandia Security, however, they only conduct building checks there now.
- 6. On 10 Aug 80, a New Mexico State Patrolman sighted awaerial object land in the Manzano's between Belen and Albuquerque, NM. The Patrolman reported the sighting to the Kirtland AFB Command Post, who later referred the patrolman to the AFOSI Dist 17. AFOSI Dist 17 advised the patrolman to make a report through his own agency. On 11 Aug 80, the Kirtland Public Information office advised the patrolman the USAF no longer investigates such sightings unless they occurs on as USAF base.
- 7. WRITER contacted all the agencies who utilized the test range and it was learned no aerial tests are conducted in the Coyote Canyon area. Only ground tests are conducted.
- 8. On 8 Sept 80, WRITER learned from Sandia Security that another Security Guard observed a object land near an alarmed structure sometime during the first week of August, but did not report it until just recently for fear of harassment.
- 9. The two alarmed structures located within the area contains HQ CR 44 material.

It was in July of 1981 when the AFOSI conducted this Congressional Inquiry on Paul Bennewitz because now Senator Peter Dominici was seriously interested in hearing about Paul's findings and so he asked if the AFOSI had ever conducted a formal investigation of Paul Bennewitz? Senator Dominici's aide was told by the Air Force that there had been no investigation whatsoever. (See OSI Form #4 - Exhibit Four)

Thinking that would be the end of the story Paul continued on with his private research with APRO. In early 1980 Paul came across a most unusual case in which a woman and her son were abducted near Cimarron, New Mexico and witnessed a calf being taken aboard the UFO crafts. What was so unusual and terrifying about this case was the mutilation of the calf was witnessed by the mother and her son. To date, I don't believe I have ever heard of another situation in which abductees witnessed the actual mutilation of cows.


For those of you who aren't familiar with the case of Myrna Hansen and her son Shawn, I would like to quote from some of the actual hypnosis sessions that were held at the home of Paul Bennewitz. I will summarize most of the transcript but I feel it says so much more to the reader if they can actually live through some of the trauma Myrna and her son experienced that evening.

I also believe that it was this particular case that at this time two separate government agencies became intimately involved in monitoring all of Paul Bennewitz's activities. Already considered a possible threat to Kirtland intelligence, the story of Myrna Hansen was of such importance that I could understand why a special investigation was covertly arranged to try and establish just exactly what Paul knew, and if he indeed was truly communicating through his computer terminal with extraterrestrials.

Referring to a letter I received from Richard Doty not too long ago he stated that the information Paul received through his computer was never of interest or analyzed by their agency of the Air Force. ² He also told me that Paul was definitely on to something though and so another government agency stepped in and it was then that this other agency asked the OSI to continue investigating. The statement that shook me up was that Doty told me Paul never really new the full extent of what he had wondered onto and so to protect a vital government operation, Paul was fed disinformation! Back to that later as I want to continue on with what happened to Myrna Hansen and her son.

The regressions and investigation began at Paul Bennewitz' home In Albuquerque.

THE MYRNA HANSEN CASE

Myrna Hansen lost four hours of time in her life. She hears voices inside her chest, even while she is working at the bank. What led up to this abduction can only be speculative. Maybe she was in the wrong place at the wrong time. Maybe she witnessed something of such importance that she was picked up, drugged and detained as was her young son Shawn. In Myrna's first regression she remembers seeing bright lights. The story continues:

On May 12, 1980 Myrna Hansen recalled getting out of her car and then remembers the aliens lifting her up over a fence. They take her son, Shawn to another craft near by. She is terrified because she's separated from her young son and it is then she sees a cow. She also notices a strange insignia on the left chest of a dark orange suit. She notices three lines with a line across the bottom. Myrna senses she is somewhat smarter than these aliens, but feels physically they are in control of her body. She then notices a man in white coming in to restore order and she feels respect from him for her. He seemed very old to her.

When they take her out of the craft she states she feels like she is in a garage. The man assures her that Shawn is fine. The next thing she remembers is stepping into something like an elevator. For her it is frightening because she hates closed spaces.

She again is placed on a table and a bright light is shining down upon her face. They (the aliens) want her to know that they regret that this is happening to her. She asks about the cattle and they reply, "It is necessary." Then she hears them saying it is regrettable that she and her son must lose their memory of this event.

She then remembers being placed in a prone position, with her head resting on a pillow when she feels a sharp pain in her neck and shoulders. She believed that she had been drugged as she remembers her body feeling very heavy.

I would like to interject a moment and go back to a previous communication I had with Richard Doty concerning Myrna Hansen's case in which he was very familiar. He told me that Myrna and her son had a very real encounter with something very strange. What she did state made Doty believe she was somehow describing an underground are that he felt fit the description of an underground weapons facility. He stated he was quite taken aback upon hearing her describe this area because the information he had would seem to definitely indicate she had been taken to "the underground weapons storage area." He also stated that Myrna and her son may have accidently encountered a highly classified government project and was legally detained until she could be possibly drugged and then removed from this area. So in essence, Doty is stating that abductions such as these types could happen. But what struck me as odd is his description to me. It seemed like Doty was telling me something he had knowledge of in this particular case. I could be wrong, but it is just a hunch.

Continuing on with Myrna's regression, she describes being taken or removed from a smaller craft in what she calls "the garage". She feels she is in need of water, but is afraid of what might be given to her.

The next event she recalls is landing somewhere important. (A strange statement). Next she sees five aliens come in and two of them are different. They have narrow eyes and they do not look green or have eyes like slits in the case of the aliens on the first craft. They are huge, but she feels

they are important aliens that are like doctors and scientists.

She notices they are kind and when they move, they shuffle their feet. They seem graceful and to be six feet or taller with no hair at all. It seems important to these particular aliens that Myrna forgive them. She feels they are very sensitive and do not make her feel inferior. She notices their arms are longer and also one alien was a woman. They wish to examine her once again. Myrna cooperates, but her head begins to hurt once again. They ask Myrna if she knows who they are and she replies that she has no idea.

She next describes a lot of water, like in a plant of some type. She hears rushing water and is confused as to how she got to this place. It is a base she claims...a base of operations. It is a very important place to these aliens.

At one point she asks if they plan on killing her. She stated that they were startled and taken aback at the thought of such a thing, yet she believed they <u>had</u> thought of keeping her with them. Wherever she was taken, she noticed the lighting was different, not flourescent. The terrain was hilly and she saw three or four UFOS take off and eight to ten land inside.


This was the end of her first session. Myrna Hansen was then a normal 28 year old and her son Shawn was 6 years old. They resided in Eagles Nest, New Mexico where she worked in a bank. The UFO incident occurred near Cimarron, New Mexico.

In Myrna's second session she recalls once again the bright light approaching her car. She is terribly frightened as she notices a cow that is still alive and they are pulling the calf apart. They take both Shawn and herself along with the calf on board the craft. She keeps asking the aliens questions, but never receives a reply. She isn't aware of where they take the calf, but she knows one thing; she is certain it is alive. She then recalls a knife and then remembers calling them "barbaric"!

Soon she feels them placing some type of metal device inside her vagina. She complains that it is uncomfortable, but not painful. They are curious as to what the scar is on her abdomen. The next thing she recalls is seeing the calf dead. She is unsure when it died.

in the late '50s-early '60s by a neuroscientist named Jose Delgado. The stimoceiver is a miniature depth electrode which can receive and transmit electronic signals over FM radio raves. By stimulating a correctly-positioned stimoceiver, an outside operator can wield a surprising degree of control over the subject's responses.

Speaking in 1966—and reflecting research undertaken years previous—Delgado asserted that his experiments "support the distasteful conclusion that motion, emotion, and behavior can be directed by a electrical forces and that humans can be controlled like robots by push buttons." He even prophesied a day when brain control could be turned over to non-human operators, by establishing two-way radio communication between the implanted brain and a computer."

According to Victor Marchetti, Delgado attached the stimoceiver to the tympanic membrane, thereby transforming the ear into a sort of microphone." "Yet the ramifications of this technology may go even deeper than Marchetti indicates. I presume that a suitably-wired subject's inner ear can be made into a microphone, it can also be made into a loudspeaker -- one possible explanation for the "voices" heard by abductees."

Martin Cannon's research in this area has been debated, bashed and praised. His conclusions make for a fascinating new area of research into alien abductions and implants. A flyer where you may order this courageous piece of work on mind control and who the "controllers" really are will be added to the final portion of this manuscript. I urge the reader to have an open mind and consider these possibilities raised by Cannon.

The aliens Myrna describes are naked from the waist up, very thin, their ribs and clavicles sticking out. She sees that they have more ribs than humans. She notices they shuffle when they walk and drag one foot behind.

Myrna describes once again being taken to a room where she now sees stars everywhere. She says it is beautiful and can even see a planet. She observes a very large TV screen and she has the feeling of being outside.

The aliens again reassure her that Shawn is alright. The she hears the words "Necessary arrangements." She feels that they are just trying to reassure her so she will cooperate by being calm and quiet.

Her next remembrance is being on the ground in a rugged area where they are on a mesa where she observes craft landing and taking off. It's familiar to her--the countryside. She realizes she is on Earth.


Next she recalls being on the elevators going down very fast. She notices crowds of people with different uniforms, colors and patches on the left chest. They seem to be walking hastily by. The lighting is different somehow. Strange, she recalls. Then she comes to a door with no doornob which opens electronically.

The next recollection is one I know all too well. Myrna hears water rushing and smells a pungent odor. ⁵ She makes the odd statement, "I hate caves worse than elevators!" She ventures on and comes across what only can be described as "an incredible base city of operations." ⁶

Going through another examination, she feels like she has been a victim in Auschwitz and then she weeps and sobs. They, the aliens, do not want her to remember or tell anyone about this incident. She makes the comment, "Even when I was telling Paul--in my heart, I was thinking that there are so many things worse than death!"

Myrna continues her horrifying account by describing walking back to a trestle, to a doorway where she is able to observe a generator, pools of water with "submerged things" in them. Then it occurs to her that what she is viewing are body parts! She tells of seeing the top of a bald head, an arm with a hand, Human. She also sees something like tongues—they look larger than human tongues.(Note) Many cattle, found mutilated have been found missing a tongue or a part of the tongue. It has been stated that cows have a certain enzyme that is useful so this makes since to what Myrna is describing.) She continues as she describes seeing containers that seem to be made of metal. The smell is repugnant, like a gassy odor. She feels weak and nauseous, but remembers looking down and seeing the body parts which some were internal organs.

This is a drawing of the tanks seen in an underground facility in 1987. The description is almost identical to Myrna Hansen's.




Then Myrna's regression winds down. She is tired and wants to just let it rest. She does recall the word "alterations", "necessary alterations" in order to take her back. The torture, the experiments make her feel like a specimen. Suggestions are then given to Myrna to just let go of the past and to be a peace with herself.

One aspect I saved for last was the fact that Myrna was aware these aliens were trying to confuse her. Her impressions were that these aliens want to control Earth. She is adamant about the fact that she was indeed the recipient of some type of mind programming. She dreams of mind control over the Earth and she has feelings of fear over thoughts that she feels were beamed to her about her own suicide! Her uncle and brother committed suicide. She doesn't want to die, but has strange feelings about having no conscious memory of the "drugs" used on her.

These copies of the original "Dulce Papers" were circulated among the ufological community in 1987. They were drawn supposedly from original photographs from a man mysteriously referred to as "Thomas C." who worked at the underground installation, but escaped with film and photograph evidence of the goings-on in this underground base. They certainly resemble the description given by Myrna Hansen and others who claim they too have been abducted and taken to this facility where experi ments are performed upon them.

To no avail since my research began, have I been able to meet with this mysterious character "Thomas C." I have reason to believe the man does not exist and is the product of another hoax perpetrated against UFO researchers and the abductees they try to help. There seems to be only two people I know of that claim they know this man exists and are in contact with him. They claim to have seen the real evidence, but so far have refused to make it public.

I would like to remind the reader of the statement made to me by Richard Doty that Myrna could have stumbled onto a highly classified government project and was possibly drugged and removed from the area. Interesting comment from an Air Force agent. 9

In conclusion, no one really knows who abducted Myrna and why? I do know this much, Paul Bennewitz was deeply concerned for the welfare of this woman and her son. 10 It is interesting to hear Paul's conclusions in a letter written to now deceased Jim Lorenzen of APRO about Myrna Hansen. I am enclosing a copy as there were many interesting aspects of her case that were later addressed by Paul.

It is obvious by then that Paul had already come to his own conclusions about her case and it seems that Paul had direct knowledge of the area in which Myrna and her son were taken. This case possibly was the catalyst of what urged Paul to enter into the Dulce, New Mexico area. I believe Paul had knowledge of an exisiting underground facility at Archeleta and continued his flights and investigations into this highly suspected area even after Myrna Hansen's case was brought to an end.

What was interesting is the conclusion that Myrna indeed was being beamed from some type of alien force and many steps were taken to protect her from these beams. Paul was convinced Myrna Hansen was dealing with a malevolent society of aliens. This is where I question the validity of the entire investigation and how it turned out.

What about the possiblity of a government-sponsored abduction of Myrna Hansen? Could our government somehow beam alien images in our minds from some type of implant? Could the aliens really be our own government agents carefully manipulating us into belieiving we are being abducted by extraterrestrials? Did Paul Bennewitz ever address this possibility? I believe he had already made his mind up and to this day has carried his own hypothosis to the extremes of reality. But, what if Paul is right? Let the people decide as we continue on with the story of Paul Bennewitz and God help us if both the aliens and our government are in control of these abductions!

We again address the same question—why would the Air Force or any other government agency become obsessed with the activities of Paul Bennewitz when they continue to emphatically state that they do not investigate UFOs or UFO abduction claims?

As Bill describes in his speech, it all began in the year of 1980 when a certain man from Kirtland Air Force Base supposedly recruited Bill so he could befriend Paul Bennewitz and provide Air Force intelligence with as much information as possible on Paul's UFO activities and research. 11

The wheels had already been set in motion as Paul had already by this time introduced his 'PROJECT BETA' Report to certain members of the AFOSI and to one man in particular who Bill Moore code-named 'FALCON'. 12 Many people have speculated that all this time Richard Doty was 'FALCON' but after many interviews with other researchers and deductions of my own, which are only speculative, plus Doty's own admission that he indeed was not 'FALCON' but knew him, I believe our birdman 'FALCON' most likely was Major Ernest Edwards. Richard Doty only took orders from 'FALCON' and supposedly received a more inferior code name of 'SPARROW'. These names, Moore claimed were purely inventions of his partner Jaime Shandera. This had all the makings of a great spy novel!

Bill Moore found himself in the middle of having to supply the AFOSI about Paul's activities and in return the 'AVIARY' would supply Moore with certain information to help him with his private research. So he accepted the position, reported back to Doty on Paul Bennewitz and his activities not realizing the negative affect it would ultimately have on Paul's mental and physical health. I do not believe Moore or Doty deliberately knew this would cause such repercussions with Paul, but somehow power and knowledge of secrets maybe seemed more important to Bill Moore at the time.

Note: (Since the first printing of this manuscript I have learned more about the goings-on behind 'THE BENNEWITZ AFFAIR' and maybe jumped to unfair conclusions about Bill Moore. I was accused of lying about the facts. I think what happened was I could only report what I saw on paper or from firsthand interviews with Bill Moore from other researchers. So I apologize if any of the facts were reported wrong in the first printing. I have nothing against Bill Moore personally because I have never met him, but I feel I can disagree with the tactics used in certain methods used in retrieving and reporting information about an American citizen like Paul Bennewitz. I, like any other interested party would welcome knowing all the facts that went on behind the scene and who better to write about it than Bill Moore.)

Moore made the statement that he felt Richard Doty found that carrying out these orders were distasteful and upsetting. I believe this to be a very accurate statement. Doty told me the same thing in a letter. He did find this particular counter-intelligence campaign very hard emotionally to accomplish and I am sure Doty found it very upsetting. He and Paul were friends. But he had a job to do. It must have been difficult to get out of bed in the mornings and face himself

in the mirror. ¹³ From a personal letter from Rick Doty to the author, Doty basically stated the exact words Bill Moore used in his speech. Doty agreed that dis-information was deliberately fed to Paul because he had stumbled onto "something of great importance" to the Air Force and the government. He told me he felt bad for Paul and was sorry it caused so many problems for Paul. He also stated that he did have to perform some duties that he personally did not feel right about morally, but he had no other choice because he had a job to complete and he was dedicated and loyal to the Air Force. As I read through the lines of his letters to me I saw a man with sincere feelings and emotions and also a man who was placed in a delicate situation in which he had a job to do and so he did it. Doty also told me that he had considered Paul a friend and special feelings for the man. His last comment about Paul was that Paul Bennewitz went through HELL!

After having my own personal conversations with Paul, he told me of horrid people following him, breaking into his home to install wire taps, Air Force men showing up on his doorstep at all hours and then he began telling me an even more bizarre story. He felt sure he was being drugged and was convinced aliens were coming into his home and sticking him with needles. He was a frightened man. He also felt like the government was possibly behind some of these happenings. I sympathized with Paul because we both suffer from severe insomnia and health problems. Harrassment of this type should never be tolerated in anyway!

Bill Moore claims the government was responsible for giving Paul data on UFOs, abductees, evil aliens who occupy underground bases for bizarre experiments and eventually Paul started deteriorating quickly and emotionally could not cope with the information he was being fed by these government men.

And so seizing a great opportunity, Bill Moore saw the opening to really get involved and become somebody important. He stated in his speech that there was no way he was going to allow this opportunity to pass by without learning atleast something about what was going on.

To me this statement sums up Bill Moore's character in full. In a question and answer period in his speech he asked the question whether he was ever on any government payroll. His answer was obviously NO!

In a conversation from a well respected ufologist and researcher, this person stated emphatically that Bill Moore had told him that he was literally paid "under the table". Now whether this statement was ever truly made to this researcher, we may never know. But, in my past dealings with this particular UFO researcher who I respect deeply, I have to believe that the conversation indeed took place.

Never being allowed to interview Mr. Moore, I cannot judge him in anyway. I am only relating facts from himself and others who do know him well and know how he operates. But, a final judgement cannot be made by me until Bill Moore actually grants me an interview. So until that time, the jury is still out on Bill Moore. 14

Dear Sir;

On July 16, 1980, at between 10:30 - 10;45AM, Craig R. Weitzel, 644 Wind Glove Rd, Marietta, Georgia, a Civil Air Patrol Cadet from Dobbins AFB, GQ, visiting Kirtland AFB, NM, observed a dull metallic colored UFO flying from South to North near Pecos New Mexico. Pecos has a secret training site for the 1550th Aircrew Training and Testing Wing, Kirtland AFB, NM. WEITZEL was with ten other individuals, including USAF active duty airmen, and all witnessed the sighting. WEITZEL took some pictures of the object. WEITZEL went closer to the UFO and observed the UFO land in a clearing approximately 250 yds, NNW of the training area. WEITZEL observed an individual dressed in a metallic suit depart the craft and walk a few feet away. The individual was outside the craft for just a few minutes. When the individual returned the craft took off towards the NW.

On July 17, 1980, at about 2210hrs., Weitzel was in his temporary billets on Kirtland AFB, NM, when an individual dressed in a dark suit, came to his door. The individual was described by Weitzel as being: 6'3" tall, weight, 170 lbs, slender built, dark black hair, dark eyes, wearing sunglasses, narrow shaped face. The individual identified himself as a Mr. Huck from Sandia Laboratories, a secret Depart of Energy Contractor on Kirtland AFB. Mr. Weitzel, not being from the Albuquerque area, did not know what Sandia was. After obraining an explantation from the individual, Weitzel allowed the individual in. The individual told Weitzel that he saw something yesterday near Pecos that he shouldn't have seen. The individual stated the craft was a secret craft from Los Alamos, NM. The individual demanded all the photographs. Mr. Weitzed explained that he didnn't have any photographs, that all the photographs were with a USAF airman and Weitzel didn't know the individuals name. The individual warmed Weitzel not to mention the sighting to anyone or Weitzel would be in serious trouble. After the individual left Weitzels room, Weitzel wondered how the individual knew of the sighting because Weitzel didn't report the sighting to anyone. Weitzel became scared after thinking of the threat the individual made. Weitzel call the Kirtland AFB Security Police and reported the incident to them. They referred the incident to the Air Force Office of Special Investigations (AFOSI), which investigates these matters according to the security police. A Mr. Dody, a special agent with OSI, spoke with Weitzel and took a report. Mr. Dody also obtained all the photographs of the UFO. Dody told Weitzel he would look into the matter. That was the last anyone heard of the incident.

I am a USAF Airman assigned to the 1550th Aircrew Training and Testing Wing at Kirtland AFB, NM. I was with Weitzel during the sighting, however, I did not see the craft land. I spoke with Weitzel after this Mr. Huck visited him. Weitzel was very upset and wanted something done about it. But after Weitzel spoke with the OSI, Weitzel changed his attitude. Weitzel didn't want to talk about the matter anymore. I called and spoke with Mr. Dody. He disavowed any knowledge of the photographs and stated Weitzel decided not to make a report of the sighting.

I have every reason to believe the USAF is covering up something. I spent a lot of time looking into this matter and I know there is more to it than the USAF will say. I have heard rumors, but serious rumors here at Kirtland

that the USAF has a crashed UFO stored in the Manzano Storage area, which is located in a remote area of Kirtland AFB. This area is heavily guarded by USAF Security. I have spoke with two employees of Sandia Laboratories, who also store classified objects in Manzano, and they told me that Sandia has examined several UFO's during the last 20 years. One that crashed near Roswell NM in the late 50's was examined by Sandia scientists. That craft is still being store in Manzano.

I have reason to beleive OSI is conducting a very secret investigation into UFO sightings. OSI took over when Project Blue Book was closed. I was told this by my commander, COL Bruce Purvine. COL Purvine also told me that the investigation was so secret that most employees of OSI doesn't even know it. But COL Purvine told me that Kirtland AFB, AFOSI District 17 has a special secret detachment that investigates sightings around this area. They have also investigated the cattle mutations in New Mexico.

I don't expect you people can do anything about this, but I thought I'd let you know. I must remain anonymous because I ama career ariman with time remaining on active duty. I feel I would be threatened if I disclosed my name. I know that you people can't guarantee my anonymity.

This letter was received at the doorstep of APRO (Aerial Phenomena Research Organization) in late 1980. There has been much speculation as to who is the author of this letter. Several of the Air Force agents names seemed to be deliberately misspelled. Speculation is Richard Doty is the anonymous author, but there has never been any proof of that.

There seem to be a lot of correspondence and data circulating about what was really behind the dis-information campaign against Paul Bennewitz. So in January of 1983 a telecon from an attorney, Peter Gerston was circulating in the UFO circles that gave some very interesting information about a meeting that occured in Albuquerque with Richard Doty, Peter Gerston, and Bill Moore. It is an interesting perspective on what information was being given to Paul Bennewitz and if any of the information is true, then it gives one a feeling that we are indeed being lead on by certain individuals in government circles and ufological circles. No matter, I will reproduce the telecon as I have it with corrections of minor typographical errors. The meeting gave us insight on Richard Doty and what he really knows. 15

For the readers convenience I will try to interpret by identifying the persons involved in which initials were used:

D- Richard Doty
BM- Bill Moore
PG- Peter Gerston
Lankus-Ron Lakis
PB-Paul Bennewitz
LF-Larry Fawcett
JM-Jerry Miller
ED-Edward Doty
ST-Stanton Friedman

Re: trip to Albuquerque and meeting w/D.

D. claims "gov't is studying UFOs & knows theyr'e extraterrestrial".

Various agencies- espec. military have depts. into this.

NSA - - a "primary mover"

- D. indicates that the gov't is or may be "in communication with the aliens".
- D. says there have been 3 crashes where bodies were "retrieved" one was Roswell- one was in the late 1950's, one in the 1960's.

Two meetings w/D. - dinner on Mon. night (Jan. 10); BM present, also-PG turned off somewhat by BM; PG & D. met again Tues.

- D. indicated retrievals once stored at Kirtland, but no longer there.
- D. had device to determine whether he was being taped. He said at outset he knew he wasn't being taped.
- D. talking "as a civilian"-if they asked questions about classified matters, he would not be able to discuss much.
- D. involved mostly in UFO matters over the last 5-6 years-began when he was at Ellsworth at time of 1977 incident near there-landing of craft(s); some sort of guard(military? fired at humanoid(s) that got out'they shot beam which burned/disintergrated guard's weapon & burned him to some degree; later or next day, a missile was found to be missing from silo area. Nat'l Enq. got wind of story, sent someone up, but brass, etc. were able to convince Nat'l Enq. that incident was a hoax. The investigation into that incident is still going on. (FBI involved). (Author's comment) In a letter to me from Richard Doty told me and the Enq. the exact thing. 16 That the Ellsworth incident was a disinformation practice excercise that got out of hand and an emphatic "NO" was told to me when I asked if a missle ended up missing)

PG asked D. if D., if D. were PG., & wanted to go somewhere to invest. a really good case-where would he go- D. said he would go to Ellsworth. A farmer & lawman(deputy sher.) were apparently witnesses and were debriefed & told not to discuss it byt D. knows how to get to them & told PG he thought they might talk anyway.

D. was given briefing papers about various cases-some back to 1940's, some published & known, some still classified. Something about those briefing papers going to President-which one? All?

From what D. has read in briefing papers, he concludes gov't & aliens are probably in contact; tho he has no direct knowledge of it.

CR44- could be nuclear materials, but when PG asked D. what else it could be, "I can't talk about it". "CR44" means Command regulation 44" & is a 4 or 5 P. document; obtained under FOIA, but very heavily censored.

BM has had the Kirtland/1980/PB documents over a year. BM gave them to Ron at KPIX in San. Fran.

The "jamming"-BM went to local airport (Albq) to inquire, because they allegedly were blacked out in some fashion-they claimed they knew nothing about it BUT - a similar incident <u>had</u> occurred either one year before or 1 year later; if it was 1 year later that would be '81' when HE detected anomoly. But Doty claims none of that had to do with UFOS.

PG acquired document (from BM??) ("if it is a document") - re: project Aquarius and MJ-12. Aquarius supposed THE project involving ET/gov't contact. According to D., that contact occurred in the late 1960's; he did not mention where. 17

PG asked D. point-blank about mutes and was told "Its classifed". However, seems PG may have asked what was behind mutes & D. said maybe cults were involved, and at least implied to PG that aliens might be involved in some but when PG persisted in questioning, he was told, "Well, it's classified".

PG & Lankus (sp?) (4 people present at dinner) were "aghast"-just couldn't believe they were hearing all this.

D. says aliens are coming from 50 light years away, but location is classified.

Why was D. not hesitating to talk about this?:

In NYTIMES reported requested some documents(from where?) (Nat. Security Council or White House) - included by mistake was a Presidential briefing paper that had been declassified - apparently it said that the gov't knew UFOS were of ET-origin - the reporter wrote article & article appeared tho document was then re-classified. But D. feels that once it was declassified, it could not be re-classified - he feels it should be aired out or in the public domain.

D. seems to indicate that most people in the military know about this and they just don't talk about it.

D. said if he told them everything he knew, they wouldn't believe it.

The reason for secrecy - fear of panic.

D. says there is indeed "programming" going on via movies, media - to help population accept ET presence.

D. says UFO organizations are "basically inept" and that there are gov't employees in some groups - present both to misinform and to collect information.

Another reason for secrecy is that we are trying to learn as much about their technology as we can before Soviets get in on it.

D. says gov't feels aliens do not pose a threat. (He said this "several times)

Reference to "CR44" - in some of the 1975 documents.

D. refers to sightings in N. Hampshire/Vermont & at Pease AFB in 1982.

PG referred to aliens inordinate interest in our weaponry and nuclear facilities, military bases and asked whether this might suggest that they might pose a threat—no comment from D. (at least not in direct response to that).

D. & BM feel that Paul B. has gone overboard in interpreting what he has; for instance, PB <u>interprets</u> stuff on his computer as being alien communication, but D. and BM think that's hogwash.

PB says ETs have ability to "cloak" themselves (invisible); that they are interested in our water supply & want to control the world for our water. Parts taken in mutes are used to make humanoids.

AFOSI uses very sophisticated hypnosis in their own UFO investigations. Twice a year D. is de-breifed and once a year he's given a lie detector test while under hypnosis.

D. spoke to woman in Cimarron Case and says "It's an interesting & extraordinary story she tells" --implant in her neck--D. confirmed X-rays revealed the implanted object. 18As far as gov't is concerned, they've had no doctors look at the woman (tho P.B. has)

Cimarron witness saw aliens & military types together in underground installation --tanks with organs in them--she was told they were making humanoids (Fawcett says Andreasson was told this too--this was not in either book; something she told L.F.)

PB says in 1979 aliens & military had some kind of "fight over weapons" & 66 military people were killed by the aliens.

PB feels the aliens are coming into his house at night - "cloaked"- but you can tell they're there by the odor--either a heavy perfume odor or a sulphurous odor--they've stuck needles in PB's hand--plus they've implanted PB's wife.

D. on Cash/Landrum: gov't device, an article relating to device appeared in some publication - D. said at first AVIATION WEEK. PG had Klass look for it to no avail; PG told D. on ph. later & D. said, 'Well, maybe it wasn't A. WEEK, but maybe some other publication--so PG doesn't know if he's getting the run-around here.

D. has quite a different demeanor on phone as opposed to in-person.

PG reiterates that D. says UFOs are ET based on what he's gleaned from papers, no direct knowledge (so D. says)

D. says there was (or is) someone in FTD bootlegging UFO photos.

CR44 -- a common denominator.

PG asked D. if the military can predict when UFOs would be seen--Doty "couldn't talk about it".

D. assured by PG that their conversation was off the record--PG wondered, tho if maybe BM planned to use some of this material in a book (w/SF?)

BTodd-at PG's request--has been bombarding for FOIA requests on Pease & Ellsworth (especially the latter) (& Aquarius)--A Washington contact of BM's called BM & asked what was going on--did someone leak about Ellsworth?? BM called PG to tell him about this--BM worried about protecting his source--but "his source had nothing to do with Ellsworth"--that was D. (that is D. was the source re: Ellsworth) and D. is not his (BM's) source from what I gather".

"I was led to believe that BM wouldn't even have spoken to D. when BM was down there other than for me being there & seeing D. "

"I showed D. a couple of documents that hadn't been released yet that BM showed me. He (D.) seemed to indicate he hadn't seen them before".

BM denies that D. is his Kirtland source.

D. told PG that Miller wouldn't talk to PG because he was burned once by the press. JM, a "civilian" who went to Wright-Patterson on his "off hours" (?) had no formal connection with FTD; according to "certain documents", JM never worked for FTD; he just had "certain expertise" --Another document--"one that hasn't been released yet"--seems to indicate that JM is de-briefed regularly.

PG not familiar with "Dr. Lehman".

PG says that about a year ago "we" sent a standard FOIA request to Ellsworth; they replied that they knew nothing (about 1977 incident??)

Gov't/alien "agreement"--they can do mutes and we'd receive some technology plus we gave them land for a base.

PG told that last scene in "CEIII" may have been close to reality--re: "pilot exchange"--rumor is that Spielberg met Reagan at W.HOUSE & Reagon told S. that the movie was "more real than people think" Spielberg supposedly has confirmed this to BM.

"Contact" may have been made in 1969.

Edward D. with Project Twinkle--PG asksRD if E.D. was his kin; R.D. "couldn't talk about it".

D. asked: "How do you know that I'm not here to either give you mis-information or give you information which is part of the programming, knowing you're going to go out and spread it around?"

PG: "When you take what he (D) says and what PB says together, you really leave New Mexico with a strange feeling."

PG would like to contact Emenegger; wondered if that was a pen name.

D. said there was a "Grudge 13" report, but he claimed he didn't know what was in it. Also D. says there is another non-military group. BM said these were ex-military people who disagree w/gov'ts position and would rather get this info. out. BM doesn't necessarrily believe that. He thinks it's an "international group". Insignia on craft filmed by PB is a trilateral. PG wondered if T.Commission was involved.

D. says "some announcements" & release of data will be made soon by an agency that he is aware of. Press conference to be held.

End of telecon...

This telecon, if it provides "solid information" tells us a little about how Richard Doty works. Richard and I corresponded only a few times and I appreciated his answering all my questions posed to him as best he could.

At this point in time, I do not think Richard Doty was feeding Peter Gerston dis-information, but I do find it interesting to note the fact that on several occasions when people had a meeting with Paul Bennewitz, they would show up only to find that Bill Moore was sitting right there along side of Paul.

Again this goes along with what Bill Moore stated in his speech in Las Vegas in 1989. I believe he wanted to know anything Paul may be sharing with other researchers and so Paul, thinking Bill was "the good guy" informed him of probably every time a meeting was to take place. I again am only speculating. But, it is true that in the early 80's Thomas Adams and some other researchers visited Paul in Albuquerque only to find Bill Moore present. This made Tom very suspicious and nervous. 19 So concern for Paul at this point was top priority!

Apparently Richard Doty and Bill Moore at some point had a "parting of the ways" as when I mentioned Bill to Rick via a telephone conversation, Rick said he had nothing to say about Moore and his tone of voice and other comments made to me lead me to believe their friendship ended a long time ago.

MY 1987 TRIP TO NEW MEXICO

In November of 1987, I was invited along with two researchers to visit Roswell, New Mexico, Albuquerque, and then finally Dulce, New Mexico. It would turn out to be a trip of a lifetime and certainly gave me some input on the little town of Dulce, Gabe Valdez, the State Policeman in Dulce and what really went on at Archeleta.

When we started out from Chama, it began pouring down rain. We all were singing and having a wonderful time even though we knew it would be raining when we entered Dulce. It was in the evening and Tom Adams had arranged ahead of time for us to meet with Gabe Valdez as he had done every year he made the trip in the past. Gabe was expecting us and we finally arrived and made our way to the only place in town tostay, The Best Western". It was nice to finally get a room and stretch my legs as it had been a long drive up from Roswell.

As soon as we were settled in our rooms Tom immediately called Gabe's home. He couldn't wait for me to meet Gabe and tell him about what I knew of the underground facility there. But, even during the drive into Dulce, Tom, his buddy Gary and I felt a strange sense of danger for some reason.

There was no logical explanation for it so we decided to just forget about it. That evening we tried many times to catch Gabe home and his son kept telling us he was out in the field looking for some lost hunters. Well, in this rain storm we certainly could understand, but we felt somehow that his son was covering for Gabe.

Later on I decided to call over and ask for Gabe. Again his son answered and I left a message that Christa Stevens had called and really wanted to speak with him this evening if possible because we were heading on out the next day. His son paused for a moment, left the phone then came back on and said his dad was probably going to be gone for the rest of the night. Right then and there I had an eerie feeling he was lying to me. It was just the start of a series of weird events that would take place to us while in Dulce.

We all gathered in one room and decided to settle down with a drink and just relax until we heard from Gabe. I felt that Tom and Gary felt this was a little strange for Gabe as he had always left messages before if he was not going to be able to make it.

Hours passed without a word from Gabe and the rain was still pouring down like millions of needles. As I gazed out the window, I noticed what looked to be a police car parked right behind Gary's van. I immediately notifed the guys who were busy playing some board game and they came to the window. Tom immediately said, "That looks like Gabe's cruiser". Gary agreed. So we waited, thinking Gabe would be knocking on our door at any moment. We waited and nothing happened. So I went to the window again and noticed the police car was gone.

This made all of us feel very uncomfortable but, we couldn't place our finger on just exactly what was wrong. Tom stated that Gabe had always welcomed them with open arms and so we just waited. He never called.

The next morning we decided to visit the Dulce Police Station, just a small building right around the corner from the motel. We piled into the van and then when Gary tried to put his car into gear, it wouldn't go anywhere! Gary was dumbfounded because he had always kept up with his van repairs especially if he knew he was about to undertake a long trip. He stated he had never had any problems like this before. Beginning to get really frustrated, Gary finally got in gear just long enough for us to make it up to Gabe's office.

When we walked in the station we again found that Gabe was not in. This was beginning to get on everyone's nerves by now. Gary was befuddled as to why his van wouldn't run, Tom was astonished that Gabe had never even called and left a message and I was feeling "very strange".

Suddenly some of the native Jicarrilla Indians pulled up beside the van and asked if they could be of service. So the guys began trying to fix the gear and I waited inside hoping Gabe would call in. Soon, Gabe pulled his cruiser up, smiling like a Cheshire cat. He was a short, stocky fellow of Hispanic descent, dressed fit to kill in his black uniform. I was immediately impressed by his smile and his demeanor.

The guys at this point were basically asking Gabe for help in getting the van in running order as we had planned on leaving soon that day. Gabe stated that there was really no mechanics available, but he would try and find someone to help. Inviting us to jump into his cruiser, I jumped into the front and the guys sat in back.

We explained to Gabe why we were so persistent in seeing him and we needed him to drive us up to where the underground facility was located. Gabe indicated that it (meaning the road) was probably blocked off because of the torentous rainfall the night before and there was no way his car could make it anywhere near the area. Anyway the guys decided to drive me up to the general area to see if I recognized anything.

Driving north, Gabe kept looking at me and smiling. Later I would be kidded the rest of the trip because the guys felt Gabe was infatuated with me. I wanted basically for Gabe to show us the areas where they had seen UFOs flying into the sides of the mountains. Gabe seemed fascinated as I talked about what I knew about the underground facility. He became very quiet and then began asking me questions. He seemed genuinely interested and glad he had finally caught up with us.

When we reached as far north as we could in Gabe's car I asked them to stop and allow me to get out and walk a way up the hill. It was so rocky and muddy that I soon realized I would never be able to hike up any farther. But I stopped and just looked around at the mesa and the cliffs of rock. Then all of a sudden out of nowhere I heard a voice say, "No, you are in the wrong area." I knew this was not the area Gabe was supposed to take us to for some reason, so without insulting Gabe, I got back in the car and said, "Gabe, how about us driving south?" He looked surprised, but said "Direct the way." I had him drive south and toward the east a ways and I then told them that Archeleta was not the place anymore. Gabe looked over at me in astonishment and just kept driving.

We approached a small lake and I asked Gabe to stop the car immediately. I recognized this area. (But, consciously I had never been to Dulce in my life). We stopped and I got my camera and began shooting towards a long mesa area that followed the lake south and east.

As I stood there looking across the lake at the mesa, I realized that the facility was not in the same area as Paul Bennewitz had originally stated. I asked Gabe why I had this feeling and he stood there, just shaking his head and looking over at Tom and Gary in disbelief. Then Gabe said, "Christa, you are pointing to the exact area where our townspeople have seen lights going in and out of the side of the mountain!"

At this point, I think everyone was convinced that I maybe had been there before. I pointed towards another area (Soldier Canyon) where I stated flatly that I believed the facility had been moved towards that direction. Again Gabe nodded his head and said, "Yes, that is where all the UFOs have been seen in recent years." That was all we knew at that point and it was then that Gabe suggested we drive with him on a call he had. So we all piled back into the cruiser and drove east.

It seemed like we drove forever until Gabe pulled into a gravel drive which took us back to a large steel fence that looked like a baracade. Two men were standing there with rifles in hand as if they were expecting Gabe. Gabe asked if we would mind staying in the car and then he jumped out and went up to the fence and began chatting with these two strange looking fellows.

As we were sitting there waiting, Tom, Gary and myself noticed that Gabe and the other two men would start talking and then turn and look at us in the car and just smile. At first we didn't think a thing about it but the talking continued and continued for almost thirty minutes. We kept noticing that the two men were staring at us and they were not smiling. Maybe we were just paranoid because they were armed, but we got suspicious when Gabe never came back to his car to explain what was going on.

I turned to the guys and reaffirmed what I was feeling and they too agreed that something didn't seem right. Here we were out in the middle of no where and then we became very nervous. The guys were fidgeting and I had to go to the bathroom badly, but I was afraid to get out of the car. In fact the guys insisted that we stay in the car. I suppose it was because of their paranoia that I soon got really scared. Then I turned to them and said, "Do you get the feeling this call was about us?" Gary and Tom agreed. We all felt something was just not right.

About that time Gary mentioned to Tom that there was a rifle in the back seat where they were sitting. We all agreed that if we felt threatened in anyway, they would go for the rifle. Well, it turned out that it never got that far because soon Gabe was back in the car and we were on our way back into Dulce.





Flying in we passed a strange lake that looked like it had a facility next to it, but it seemed to be deserted. We then headed into Soldier Canyon and were able to fly right on top of the mesas. 

And so it begins, the letter to one of Paul's only confidentes. Written in his own hand Paul reveals his innermost feelings about what has transpired throughout the 1980's. This is the real Paul Bennewitz! In his own words he writes:

These individuals that met with Doty are in my book precise examples of the psuedo-scientific dogma that haunts this whole business. They apparently get an enormous kick out of make believe cloak & dagger worrying about telling an OSI agent that they don't have a tape recorder. You can bet that Doty, to protect himself at some later date if required, was wired for sound. I know him all too well. 20

I am forever amazed at individuals such as these that think they can walk in and talk with one such as Rick and that he would bare his soul, "talking as a civilian" and tell them everything. It just does not happen that way, And also I am forever at a loss to explain why invariably all of them constantly, in one way or another, will never give credit where credit is due in areas where they are not experienced nor have the credentials—such as the Computer Thought Communications Link. They apparently, even to this day have never thought deeply and analytically enough to realize communication with Alien Lifeforms is not cut and dried. One must build upon this type of research, expanding in a route to fully understand Alien Psychology, what their culture is, how it communicates or expresses itself—it's emotion—it's level of thinking.

To be honest about it, the alien cultures look upon these so-called experts as a bunch of "one-half scientific, unmitigated narrow-minded, ego-oriented asses! They literally have their heads in the sand, a pitiful discourse to say the least.

There is so much in this and so much has happened to me for seven years that I don't really know where to start first. Unlike others who have studied or researched the saucers at more or less arms length, their having never seen one, my involvement has been a direct "hands on" experience. So it is not as if I am guessing. I speak, unfortunately from direct experience. In one sense some might say, "Hey, that's great!" But they really do not know what that experience consists of. If they did, and would listen, they wouldn't touch it with a ten foot pole. In a way it is a disadvantage because once in a while I tend to get carried away explaining some part of it, assuming one knows what I am talking about...but they don't, and I end up talking way beyond their reference frame and they retain none of it.

It is truly "Alice in Wonderland", "Star Trek" and beyond. Understanding each facet, and there are many, not only opens up a new world for one but it also creates a new way of understanding and a new way of thinking. I do not yet know it all in depth, but I am close. I am not saying it is all good in any stretch of the imagination. A large amount is very very bad and some down-right abhorrent! But believe me in any extent, it is what I say it is.

I think probably the best approach is to start out with some explanation in the way of statements relative to cultures here on planet Earth, their social structures, physical makeup, all of which has been gleaned from the direct communications by computer, visual observation, psychological evaluation, and in particular personal interaction.

I would urge you to accept the statements as fact to save time. I can assure you it is fact! I do not accept, nor believe in fantasy. At anytime however if you want further explanation or backup please do not hesitate to ask and I will comply.

Contrary to all that has been published, I deal only with personal experience. No other. I rely only upon my own research and photographs to support the thesis. Because it is directed at both the layman and some scientists, the language is couched in such a manner as to provide the reader with the exact same experience. In other words, the reader goes along for the ride. Though I can and will support it periodically scientifically, don't expect a lot of scientific mish-mash. Also be prepared for a religious experience because it is that too, in fact, may shake some of your concepts to their foundations.

First, relative to level of culture there are the Low, High, and Very High. In the Low there are very sharply defined levels from slave level and up. There is no freedom there. No one crosses these lines within. Cross them and you are dead! Each and everything is watched with optical equipment, on the ground, within the caverns, on the ships, opticals levitated and 'floating above the base and their perimeters—all comings and goings. A switching system switches to each optical unit in adjustable time sloto. Readouts appear to be monitored by both computer lexicon and individuals called Keepers. Sphericals of various sizes from very small, maybe one inch in diameter to near two feet in diameter float throughout. Each has facilty to monitor audio, visual and probably thought. Each can be interrogated—I.E. can be talked through audibly.

They can, if desired, cloak so that unless one catches a reflection or force field flash, they are totally invisible. They can be photographed and seen periodically with a motion picture camera or detected electronically. They are not magic. The electronic command signals to them can be detected and displayed. The control signal can be broken down to varying components of AM and FM. So, there is no trust in this type of society. Everything is watched and monitored.

The Command Structure is near totally unbelievable. In the North, at the river, the Orange Insignia or at the Diamond as the Alien calls the one base, the ruling factor is a King. The Alien refers to him as such. Their GOD is called TA.²¹He may be living.

The Ruling Class method is Monarchy. The King wears purple. The next levels wear various colors, mainly green, yellow and white. The lower levels wear robes of the above colors. In addition these levels are physically imperfect. They all limp, dragging the left foot. The others below shuffle. Their government, if it can be called such, is Totalitarian. The individual entities behind it are totally pragmatic. They observe no social or moral principles nor can they be swayed to any other. Their credo apparently is total control and/or kill. They are totally ego-oriented and throw totally illogical threats.

Their body metabolism is very high, estimated 110-115° F. Elimination by osmosis. Skin color of the ruling echelon varies from a jaundiced yellow to white. No hair of any kind is noted, arms long, near to knee level. They have very long arms extending to knee level with very long narrow hands and fingers. All look underfed and very thin. They also have big heads and eyes.

The humanoidal types below are generally light green. Some with no genitals or buttock configuation. Many run around naked. Then in need of formula or when dead they turn grey. The formula feeds them. Here are the insignias employed on ships and uniforms.



Insignia portion is a multi-spectrum - discountinuous - Orange is prevalent and the background on the uniform patch is Greenish-Blue.

Insignia on the Socorro Ship could be of two similar shapes:






(Information about the insignia seen by Lonnie Zamorra proves to be an interesting story and so I will add it here to show comparisons to Paul Bennewitz' insignias)

Quoting from "Socorro Saucer in a Pentagon Pantry" by Ray Stanford, Hynek's official report stated that this was the symbol drawn after Zamorra was questioned.

The law enforcement officers claimed to have seen this version:

The body was carefully placed in cryo-capsule.

"They, the North, as described are "The Low"...and anachronism that is totally real. They invade the privacy of mind and body of the human and his home. They appear to be of an extremely jealous nature and resent the human totally. Their anger is fantastic, extending to out of control rage. So they are, despite being totally pragmatic, have some emotions. Unfortunately the wrong kind.

"There is a Council in the North called The Nine. All of these aliens seem to be cut from the same pattern. All appear to be highly vindictive and ego-oriented. So you can rate The North and their so-called GOD, "TA" as Low.22

"The High is apparently the culture of IO or JO. They don't limp for one thing. They do exhibit kindness, empathy and extreme intelligence in transmission through my computer. IO's group culture is of the Homosapien variety. Based upon input by IO, the indication is that their hair is brown. I assume IO is a female. Either her hair is red or the insignia is such.

"They did give one indication from their telecon today (3/18/86) that they have some "greys" with them. Also that bodies of their group are here in Albuquerque in cryogenic containers and the location is tentatively in the FAA Complex, north of Albuquerque. It is a fenced and highly secured area and as indicated by the computer eight craft were shot down and eleven eventually crashed elsewhere. True? I do not know for certain, but I would bet on it. I knew the bodies had been removed from Maryland and are presently under Navy jurisdiction.

"I was shown a color photograph by Richard Doty two years or more ago of a purported alien lifeform being held prisoner. Supposedly it was taken to Las Alamos. He was alive, a light green color, had large eyes and stood directly in front of the camera. He may have been from IO's group.

"So far I know very little about "The High" except for what I have experienced. They are Homo-Sapien and I would guess are some of the same type who zapped Travis Walton. If the numbers are correct from my computer, they number over five thousand. Indications also are they are operating from a Star Ship in a far orbit.

"The culture has apparent social values and emotions. They display kindness and concern for individuals such as you or I. Their technology is superior to ours and The North's. The North group try to block communication with The High. They try to play GOD with very badly distorted logic.

"The Very High are just that, Very High. Apparently few in number, their entire structure of knowledge, social interaction credo and way of life is so far advanced that it is nearly impossible for us to relate. They are God-like and near "GODS" as aligned with knowledge and power, yet they apparently lord it over no one. They are at such an advanced state that if you confronted one with a weapon, and though he might be totally able of taking YOU out, he would stand and allow you to shoot him. Again, please know that much of this information is based upon personal input of which I have never spoken to anyone about and in fact, you are the first.


PART TWO

Paul Bennewitz, President of the Thunder Scientific Corporation was also and investigator with the Aerial Phenomenon Research Organization when Jim and Coral Lorenzen were alive. Bennewitz was interviewed in his office in 1983 and stated that he was investigating the case of one Myrna Hansen and her son, Shawn and on his commputer terminal he received pertinent information about her case and was able to decifer the area in which the underground facility exisited; underneath the Jicarilla Apache Indian Reservation near the little town of Dulce, New Mexico. Bennewitz had information that this installation is operated jointly as a part of an ongoing program of cooperation between the U.S. Government and extrater-restrials. ²³ Paul's description of these aliens continues:

"The Very High obviously are the ultimate. I would guess that these Very High aliens are quite old, one thousand years is not unrealistic. They are few in number and I would guess there are a few on this Star Ship preserved and cared for by the others - the High.'

"Then in conjunction with them, and the grays they fly the ships of Light with or without the High on missions for them. I would guess in a sense, they are the "eyes" of the "high" and the "Very High".

"Now lets expand further - eons ago in the universe 16 billion years old by our estimate, probably billions beyond that $(1 \times 10^9 - 1 \text{ billion.})$ The Very High reached status. That status being so far advanced that they understood <u>all</u>. To the extent of understanding how to create life and human or near human form. (The aliens are using the DNA from the cattle and are making humanoids. He got the pictures of their video screen. Some of these creatures are animal-like, some are near human and short with large heads. They grow the embryos and after a year of training, presumably that is the time required for them to become operational. When they die, they go back into the tank. There parts are recovered)

"One approach would be to say that in their travels in Star Ships they did seek out "New Worlds". "Incubators" created by the Great Creator - The Law of the Universe. They created those in the North to be pragmatic deliberately. Pragmatic, but perhaps quite physically perfect. And due to their "incubator environment" they were made vegetarian and because of a less temperate climate they were given high metabolisms. Then they took the next step and created Humans. The Humans were given emotions and were given full span control and because of the atmosphere and a very ideal climate, Earthwide, gave us lungs and by our standards, climate temperatures and a different method of elimination.

"The North, because they were the first, were at some point in time given the "enlightenment" to create Ships of Light and so they advanced further than we and more rapidly. Then the North, now stating via the computer, they control the cosmos and because of their pragmatic nature became aggressive and war-like.

"The High and Very High thus seeing this did declare war, following them throughout the Universe. This war as indicated by the High has been ongoing for three hundred years.

"Now, it's either that, Cold Turkey, or we came up from the dirt - figuratively speaking and not by the Grace of GOD, but by the Grace of the Great Creator - The Law of the Universe. Or then at some point, as evolvement occurred, we came about through progeny--Star Progeny.

"I tend to believe the first hypothecate, though the second could hold easily and may well be the case. Yet now, in either case of evolvement, one has to recognize the "Teaching Step".

"First, the Very High obviously due to extreme intelligence gained by eons of experience, would have recognized the "Great Creator", the Law of the Universe. You could literally call it, in advanced terms, "The Force", believe it or not!

"They would also recognize the one basic requirement for any evolving lifeform regardless of conformation and they would spread it throughout the Universe.

"The lifeform evolvement naturally runs through a near animal state of total ignorance and then step by step, in many ways, it is elevated to intelligence. So one must consider the following rule of what is needed and required."

"A culture or cultures created either by natural forces of the Law of the Universe or by direct Recombinate Advanced Genetics or by deliberate Progeny by and of the Stars must be nurtured or taught.'

"If not nurtured or taught, the culture or cultures will eventually either at the outset or later, encounter Genocide from within, in its most raw form."

"Initial teaching and control must be accomplished by controlled fear and therefore a "GOD", a mentor form of wrathful appearance, was constructed for both primitive man and also primitive pragmatics. A created "GOD" in the sense one has the wherewithal to make it look as such. So... in simplicity.

"Initiation <u>is</u> GOD, sacrifice and Law. Progression is Mentor created with special attributes. Mentor is terminated, sacrifice <u>is</u> Mentor, History is kept. <u>Reference</u> established.

"And then the final rule or requirement:

Culture follows Progeny - New reference established - Teaching must occur - New keys must be made available and co-existent. Star Progeny is established and History must now be shown as History!"

"*Isn't that Great?! TRUE SPIRITUAL ENLIGHTENMENT FOR ALL! So there you have the basis if you can yet understand it. In time you will.'

"I suggest you read it not only once, but many many times. This is the Quantum Leap, in mind, total mind and near total understanding in thought."

"It stands to reason and good logic that this thesis does lock totally in place. It also stands for those who might question the origin of Jesus. I believe it does fairly describe the origin of "GOD" for those of superior logic and intelligence. Jesus is no different. It is fairly evident that in any experiment there must exist a control. The obvious is that no mentor-sacrifice was supplied to the Pragmatic. Theirs is still the GOD of Wrath and they would understand no other. So then it does follow:

Jesus was supplied to meet the next criteria at the time required, exisiting in mind to this day. He was supplied only to Humans to teach love, empathy, kindness and friendship. He was a teacher. I believe it is quite evident he was supplied to a Virgin by Progeny by the Very High. It was in a sense, at that time, a "Virgin Birth". He (Jesus) had no lineage. So one could say JESUS and GOD are ONE! Perhaps he was a man..he was not a Jew.'

"So I have looked in the mirror and now understanding is far more clear. See what I mean? TRUE SPIRITUAL ENLIGHTENMENT FOR \underline{ALL} !

"To show you the ill logic used by those weak ones with their false God "TA" in the North, they again showed their ignorance during the night. It would appear they are near frantic to stop me from talking to IO; "JO" via the computer.

"This morning I have a dark red streak down the left side of my face about two and tthree-fourths long and a quarter inch wide. Based upon past experience, I would guess it was done by a spherical in the bedroom during the night. This is typical of their totally distorted logic. They think they can operate upon the basis of fear--though with me--they have a problem. I do not experience fear; never have! All they acheive is that I totally ignore them and continue until I find a way to meet this IO. So for all the trouble they showed me, by their actions, only one thing...and that is their fear. "To me that is quite childish and in fact all of their logic tends to be childish and weak. In point of fact, though so very obvious, from the very onset seven years ago, they have never recognized one fact:

Had they only shown "friendship" that easy, they could have "wrapped me around their little finger." I would have really been sucked in for good! Scientifically, that is extremely rare.

I would imagine it is not even in their dictionary. Their psyche, from a strict scientific and analytical point of view is near unbelievable. You see, theoretically, if "friendship" is left out in a pragmatic creation, then much drops out. Note: To understand this, you have to imagine a creature deliberately created to the pragmatic side of the emotional bracket; emotion, as the human, is left out entirely. That is creation, fine line targeting at its best!

"So if "friendship" drops out, so does "Trust". Not only will they not know nor experience it, they flat would look blank if you asked them what the words mean. Do you now see some of the Science of it?; what I said I was doing at the beginning of this long letter?

"Knowing just this miniscule part, you can now begin to see through their "Mind Mirror". You can see why they watch everything, their type of government, methods of control in their society. You are seeing total and absolute Paranoia.

"Note: Why don't you add to these lists? Follow examples and see how many we can get on both sides."

"This in itself would make a terrific scientific study all of its own! If I am correct in this brief analysis, look at the "Big F" up there under Unbalance Result. FEAR, and I would believe it is total in its extreme...total incomprehensible fear! If that is the case, where does BRAVERY go? I doubt that it exists. Is it possible that this could be a key to their defeat? I wonder.

"If you don't mind, having picked up a skein of thought here, I am going to carry it further at the expense of turning this letter into a "book".

"I think this may well be a very significant key and I think you should know it here at the ontset. Though, in a sense, based upon what has happpened to me in the past, this logic I am expressing is the next logical step for me; it may well be a "Quantum Leap" to understanding for you.

"This is directly in line with what the "Voice" told...that knowledge must be gained first, then technology. This is also right on target for me and in direct agreement with the "Whisperings" I have heard and transcribed. Thought I would never tell anyone of that...you are the first! Don't worry about being insane, we are far advanced beyond that.

"All of a sudden in writing the previous down, I think maybe I stumbled onto a very significant key as to who we are dealing with and what we are. When you look at the chart again you become quite aware of something:

Being of strong fiber within, he can be and become all that is the Good...love, trust, moral, friendly, etc. If he is weak, he will express the other attributes. Because of this broad and flexible psyche of emotion, all of which is expressable, depending upon which he has become, he is of both "warring" and "peaceful" nature and he has a choice.

"If and only if he deliberately and adamantly limits himself to the good, his knowledge will expand to a near limitless extent. And thus he will know and understand the God of Technology and automatically forever cancel war from his mind; even though the technology can be converted to war machinery, He will not.

"Now he has no need for war technology and can in a near limitless way <u>help</u> and <u>assist</u> humanity. He can cure and heal humanity at will. If he has not crossed the line of emotional frame permanently then he will be subject to the weakness on the "Bad" side and therin can rest his tragic end.

"Now that I am beginning to understand this, I can see why, because of our broad emotional frame, we have not progressed more rapidly and why the alien in the North has. We have literally kept a constant drain upon not only ourselves but our resources over the centuries. This literally has caused our war-like nature. So we see a new technology and we turn it into a war machine. That cannot be. We have not, in this sense, crossed the line!

"Physically we are near perfect. We do not limp. Those in the North do. Some of us do, but knowing' we could cure that. Now if you look at the North, totally pragmatic, they have because of the inherent trait taken a $\frac{1}{2}$ science and tried to make it into a whole science... only they too have failed. They have distorted it. Though they have, due to the Unbalance, fear and paranoia achieved the ideal in War machines and weapons. They have tapped that to its near depth. So their fear and paranoia is offset by their machines. With their machines and weapons they are brave (in their minds) without them, they are a quivering mass of "fear"!

"Deprived of that, they are useless. To further enhance their bravery, they seek full control knowing that with "the implant" they can control anyone. That is, providing those selected are below the norm in both memory and I.Q. They also know that they can, without implantation, control the masses of lower intelligence by subtle shotgun manipulation of "the beams". With that beam they can and do create mass unrest and probably uprisings.

"Now let us take a giant step. IO, the one who has popped up on the computer just recently, all appear to be the "High" and also "Connie" would appear to be "High". If I were to envision these aliens and where they are, I would put them on a Starship, a very large ship, kilometers in length and breadth.

"Each, Connie and IO sitting at consoles, their responsibility to certain individuals here on Earth that are becoming near or totally cognizant as to what is going on. (Monitored by a beam) I would feed them data by computer or "Mind Energy" and I would get them in contact with each other and get them to pull together, so in time, through superior logic and intelligence, get them to enlighten the people. "I" would give them "The Mission".

"Taking this brief expansion of logic further, the "High" by logic would be responsible to the "Very High" and directed by them. In point of fact, it would seem we are being prepared to make the "transition" to step into The Universe.

"Need it be more clear? We are speaking to the High, directed by the "Very High". In retrospect, I would say I am certain the "High" and the "Very High" do not use implants of the type used in The North. They do use other types, generally implanting the individual by selection at a young age, ten years or younger; with no memory of such.

PART FOUR

To state that I understood all Paul had to say in his letters is ludicrous! Paul Bennewitz had stored up all this data and finally found someone he could share these ideas with, in hopes others, like ourselves would realize he was not an insane man, but very coherent and caring and desparate to help our flailing planet. Sounds like a dedicated scientist who studied in depth so far that he made the mistake of "knowing" too much. Our government does not like civilians to know more than they and so the story continues with the description of Paul Bennewitz and his flight over Dulce, New Mexico and his accidently stumbling on to a Top Secret government blunder. He describes the trip in what was to be his book, "The Cyanon Gauntlet" and so we find ourselves once again possibly coming to understand how and why this information was received by Paul and why he felt it was so important to we, the people.

"From the Chapter of "The Hunter of the Gods" Paul continues his adventure:

"The low hum of the alarm on a local station permeated my sleep, which had been quite fitful until the very early hours of the morning. My sleep had been restless, interrupted by the incessant unrelenting whine of the ever present alien beam ever-probing and for what reason, I did not know. The time was 0500 hours, November 8, 1985.

"I had made the astounding discovery on August 5, 1985, about midday on my 12th mission reconnasaince flight over Archeleta. That day had dawned clear and the flight in had been uneventful other than the ever present vanguard of ships that periodically would dart in to within about 1000 feet forward of my flight path. Viewed head on as they would uncloak to look, giving the impression of coming to a dead stop; one could get a glimpse of their wings and the upper convolutions of the fuselage. Generally they looked black and you were totally aware you were being watched. I often wondered what they might be thinking each time I flew into the north.

"Seeing the mesa from the air is quite an experience, particularly when you know what lies hidden within its steep canyon walls. Invariably I could not help but look in wonder as it would slowly rear up into view as I approached. Like a slumbering giant, it would appear to jump into view as if awakening to watch my dive in over its cathedral-like walls and slopes.

"Generally I would descend from 15000 MSL in a long sloping dive both to conserve fuel and to increase my approach speed during the last phase of the trip. Each time Archeleta Peak would jut up abruptly at 8100 foot altitude looking for all the world like a flat-topped pyramid, requiring no stretch of the imagination to see the similarity between it and the imaginary version employed in motion picture, "Encounters of the Third Kind". There was a gross difference; however, this "pyramid" was real and the other "fiction" or one wonders, was it?

"Normally I would fly directly north over the middle of Archeleta Mesa then transit the peak going to the west and then fly a grid pattern, photographing as I went to the east. However, this time, for some reason it was almost as if directed even though I had the flight plan on my knee clipboard. I went directly to the west to the ground insignia by the river, which I had located several flights before.

"Dropping to about 1000 feet or less above terrain, I could see the white " X " of the insignia and its integral arrow aligning the ship on the arrow and taking a resultant compass heading, I flew up the arrow toward Archleta Peak. Then below on the south ridge of the peak I visually picked up the next guide—on deliberately placed in full view by the symbolically inclined alien. Invisible on the ground, at this altitude it was highly visible pointing directly to the Alien basing area in the cliff about $\frac{1}{2}$ mile north of the peak.


"I had both a highly sensitive airborne scintillator and a magnetometer with me this trip as in those previously primarly to attempt to outline the abnormalities created in both background radiation and magnetic fields by the giant caverns known to be below ground.

"Gamma background over the cavern areas was generally quite low as compared to the surrounding uplifts making detection of the main cavern areas quite definite. And it was such as I approached in over the second white guide arrow to the area.

"Out of the corner of my eye, I caught a glimpse of some bright metal; a flash by the north cliffs to my left. I glanced quickly in that direction and I was able to catch an object visually, fairly large floating along the cliff face. It was cylindrical and quite large; I was later to find in photo analysis that it was apparently a levitated alien transporter. In seeing this, I dropped the flaps, slowing to near stall, and reached quickly for one of the cameras. Just as I reached, preparing to bank the aircraft around, I looked at the scintilator meter readout. It was dancing about, running abruptly up and down the scale far above normal. I knew instantly that was not correct, way above what I had seen on previous flights.

"By now, trying to prepare the cameras, read the meter, fly the airplane with my feet and try to see the transporter, it was obvious I had a very busy cockpit! So I ignored the transporter, concentrating upon what the radiation indication might be. Now looking ahead I see I have let my altitude deteriorate and the tops of the pines are about 200 feet below me on the approaching ridge so I climb out, leaving the flaps down to increase my climb rate. I circle to the left, heading west and around over the arrow then east toward the south plateau of Archeleta Peak. I slow the aircraft down and watch the needle. Normal background, low-minimal excursion. I think it must have been a fluke then, it jitters up and then once again the known indicator ever approaching a prime radiation source!! I immediately think, "Great, what can happen next?" Then the needle really starts to jut upward, not dropping back and then I am over and beyond and then the needle falls abruptly.

"I yank the aircraft around to an immediate reciprocal heading, fearful of losing the indication and then up it comes again, this time even more demanding. Now in my ever lonely search, alone in the sky, just me, my GOD and the aircraft, it is essentially talking to me. "Listen stupid!" "You had better look!!" So I do and I see nothing but rock, trees then black! I look again...black wings!! I can't believe it!! "What have the Gods given me this time?" I look closer, banking steeply, now ignoring the counter. It looks like a black delta winged jet aircraft anchored into the side of the plateau by a tree. It is broken; its' back is broken! I thought at the time, "I have never seen a jet like this, particularly not one that is hot with radiation!" Then like a shot out of the blue, sitting there floating over Archeleta, "Its the damned Atomic Ship!" Strange that I never once thought 'Atomic Bomb', just Atomic Ship.




"Then I could see the spilled reactor shell or what appeared to be such, a black oval. Then recalling the moving object a transporter by the cliff, I looked at the fuel gauges, checked the time which was now growing short and so I thought I had better get pictures first, evaluate and be certain later so I climbed, leveled and began photographing. Though I saw only one, visually there were two. I was to find not only that but much more later in photo evaluation.

"Later, following further careful analysis of those photos, I flew back and on October 14, 1985 I found the reactor shells of both ships, one in a continuing meltdown condition, the ground charred around it and where atleast one set of wreckage had been sealed within a ledge. 

"So now it is November 6, 1985; the wheels of government move ever so slow. I fly into this "Valley of Death", the deep box canyon where the reactors were last photographed. The scintillator goes wild which means they are still there. The alien had apparently had taken them there due to the lethal radiation."

"Now it is November 8, 1985, 0530 hours. I am again this time with a State Environmental Engineer. Delay after delay has been instigated it seems by all. Senator Domenici states through Paul Gilman, "We are at a loss as to how to react". "It has never happened to us before." And he goes silent.

"It is quite strange. <u>Lethal</u> radiation <u>is</u> detected. Normally the top would blow, but not in this case. Reaction? Zero. Silence. So I fly the State EID Engineer in. Strange again. Since when does a civilian without compensation have to react to a potentially deadly situation? Though compensation was not sought nor asked for, helicopters were and all sources, government, military and state refused and stonewalled. The statement made by an "official"..."Can't provide helicopter <u>at this time</u>."

"So the alarm goes off and I climb out of bed and go to the airport. I pre-flight the airplane in the dark and load the gear. Jerry, the State EID man shows up late, his eyes still loaded with sleep. He knows nothing, has not been briefed, just told, "Go check the radiation at Dulce."

"We take off into the dawn sky with a front moving in from the north. It is cold. We fly past Cuba, pass Lindreth, over a moon-like landscape. We fly past what I call, "the lookout", where I have repetively seen the large ships gather on a mound-like mesa just at dusk. On to the north, over points, all with significance where sightings, mutilations and crashes have occured over to the west of Dulce airport. I can see all them waiting for us below, on over the prime radiation site. Confirmation that the road is clear, I then circle back, slide-slip in and land. We taxi to the ramp where Gabe Valdez and the Jicarilla police and trackers wait.

"Then it becomes quite clear. Gabe greets us, introduces us to the others. I look into his eyes and I know, without question. One look and it is so obvious. I know the answer before I even ask the question. "Gabe, can we plan to go to the Prime Radiation Site first? The reactors are still there." "I have driven the airplane through two days ago and it's still hot!" And out came the answer. "The road is blocked and we can't go in. We have to go to the crash site. The road is blocked." Gabe looked at me, not directly. His eyes downcast; the voice not firm. He lied to us. And I knew it instantly. He would say it again and again throughout the day, "The road is blocked, can't go in."

"Well, the road was never blocked. Jonah Washington, a Jicarilla detective knew Gabe was not being truthful. Though I had confirmed as we flew in, Jonah then went in secretly later, up the road past the box, but not in. He called me later that evening, his voice terse, knowing something was totally amiss. The statement was clear. "The road was fine and it was not blocked!"

"And so it was. Someone got to Gabe. He was either threatened; told to back off or possibly bought off. I hope not, but he was gotten to. He tried at the onset to stop us from even coming up; however, I prevailed. Later as we tried to go in following the storm that came in the night, he would say repetively that it was too wet. I had known that it wasn't too wet as I had known the countryside intimately for near eight years.

"It was quite strange, here was a man of courage. I had seen him demonstrate it time after time when on patrol with him. No one could push him around! The Gabe I saw then, with downcast eyes, a voice that sounded near broken, my friend for seven years in which I knew him so very well, but now I did not know him. The man I knew before would look at you directly in a piercing way, directly into your eyes, now he would not.

"Later in the day I gave a last ry to go in. I spoke to Gabe by phone and after hearing the words, "still too wet", yet I knew it was dry he diverted the conversation with the news of seeing ten the night before last. I said, "Saucers?" He hesitated, stumbled and then said, "No, just lights." Before a man who would call a Spade a Spade, a UFO or saucer just that, and now all he can say is, "No, just lights."

"So that day we went in in a four-wheel drive vehicle up to near Archeleta where a near three foot diameter green pine tree had been deliberately cut and placed across the road. We walked from there on up confirming finally the site of both ships. Again, to me it seemed like Gabe was delaying each time taking us up hill and down until I, with the photographs protested saying, "Gabe, it is over there." And finally Jonah, in his quiet way said the same thing. Both crash sites were there, but the ships were not. Both had been apparently cut up and moved by the Alien. Obviously moved to the box to the south and elsewhere and hidden.

"The ground had literally been swept clean. There wasn't a "bolt" to be found, if in truth the aliens use bolts. However, the one ship contaminated the ground totally was removed and replaced. The skid cuts of the anhedral wings showing clearly in "after" photos of the ship that went in upright. They walk with blinders, leaving their "mark" in their minds consistent only with self and import. That, and no more, titillating the senses of self satisfaction and never seeking to conquer more, living within a "space" waiting for what? They do not know.

"Yet, those other few, go on to other worlds with "stars" on their shoulders or insignia on the breast leaving their mark in other ways and other places, walking an edge so fine it contemplates only danger and death skirted by will, daring and cold judgement.

"It is these that travel in company, each within his own, each reaching for knowledge and each recording in the log history. They look up at the Sun and all encompassing vision and so goes ones destiny.

"And as does human, so goes alien in literal, direct and sybolic manner, leaving their "mark" clearly upon the cliffs and shoulders of Archeleta.

"So the Hunter goes, the Hunter finds and records to log those things consistent with his destiny. For others who do not look up, but down, who close their eyes and ears to the truth, not recognizing nor showing intent or interest to one within what truly lies without, losing forever a glory of knowledge bereft of discovery because they never looked nor cared.

"And as I stood upon the shoulder of Archeleta on the south plateau looking east, again I looked at the face of a God and was stunned and taken somewhat aghast I could not believe the "mark", the Mentor symbol dead or alive was there. It easily was the size of the face of the Sphinx of Egypt. It hung on the cliff dead in front of me, it's glowering eyes and hypnotic stare looking to mine.

"I was not totally cognizant of how long I gazed before I was aware of Jonah, the Jicarilla Tracker standing by my side. He had come silently from behind and I had not heard him. "And as I turned and looked one last time, walking backwards, it seemed the eyes swung with me. I shook my head as if waking from a very bad dream, turned and walked away from another God. Not one of my choosing, but one in direct conflict to all I would ever believe, yet in direct alignment to Jicarilla Legend of Archeleta, the mountain and the kingdom of the Gods. The alien mark was very clear, "Human, you are in the wrong place!"

At first I agreed, but then later I became a little shaken by the idea that I would be leaving with a man I had never met face to face and one that the government seemed to like to follow, so I suggested another plan to Paul. Overnight I began to have second thoughts about this meeting. Why, I have no idea, but call it intuition, but I felt we would not be alone? So all through the flight to Dallas and then to Albuquerque I decided to ask Tom to invite Howard Burgess, a man and friend of Tom's that had worked at Sandia for a number of years. He knew Bennewitz and the whole Dulce story and more. Our meeting with Howard was to take place for breakfast at the little restaurant right in front of our hotel.

To get to the lobby of my hotel you have to drive under a canopy and it was visible from the back door of the restaurant. I had previously told Tom that I did not feel comfortable about meeting with Paul alone and so I had a hunch that Paul would not even show after his distressed phone call the evening before.

During breakfast, several times, I excused myself to go to the restrooms. There happened to be a back door at the end of the hall that led to an exit. I opened the door and could see clearly the front of the hotel and the front drive and lobby in which I was to meet Paul.

From around 10:00a.m. to 10:45 a.m. I realized Paul was not going to show up. I walked over to the hotel lobby and asked if they had seen a black car, the description in which Paul had given to me the evening before and they said no and that they usually notice any cars that drive up to the lobby door. I explained that I was to meet this man and that I was having breakfast in the restaurant in front of them. I asked if there was any messages to please have them directed to my room. I even gave information of where I would be in case he showed up late. To my dismay, Paul never came to that meeting. He never called the hotel, never left a message at the lobby for me, it was just silence. I did not bother to call him at his home to respect his privacy.

It was obvious, though Paul had met with Tom years before, that he did not feel comfortable meeting at this time. I felt there was something more sinister at work and later on, upon arriving back home, I would understand why.

Paul had left several messages on my answer machine stating that he was so very sorry he did not show for our meeting and he wanted me to know that he did so want to meet me as we had struck up a friendship over the phone and had mutual things to talk about. His voice was stressed and he seemed genuinely sorry. The next part made more sense to me. He described two men in official military uniforms that had showed up at his doorstep right before he was to leave for our meeting. Over the phone he did not say what they had wanted, but that they kept him for over an hour and by then he figured it was too late.

At Paul's request, I called upon my arrival home and he described the same incident. He seemed frightened to speak about it and so I decided to just let it be and write him later about the details. Paul was so upset that he even offered to pay for a round-trip ticket back out to Albuquerque for me because he felt so bad that he had missed our meeting that we had been planning for so long. I told Paul to calm down and that he needn't do that. He explained that he just couldn't remember what these fellows wanted with him and he felt it was a deliberate diversion from meeting with me. Well, I wasn't that paranoid, but felt it had some validity to it and so I decided to fly out at a later date to meet with Paul. His last words to me were, "Christa, just let me know when and where and I will be happy to meet with you and I will even pick you up at the airport." I thanked Paul for being so kind and we said our goodbyes.

After the call, I felt an emptiness in my heart for Paul. This is how he has to live each day of his life...looking over his shoulder. He cannot trust anyone fully until he is sure in his heart about them. The more I thought of what had happened the madder I got! I had gone to such lengths to try and meet with Paul and it was frustrating to know the government still in 1988 was visiting him for unknown reasons.

So for those of you out there that tried to contact Paul and couldn't, now maybe you can understand the stress this man was experiencing and the intense paranoia.

The one thing Paul kept stressing was to be sure and contact him if I ever came back in his area. I think Paul felt I had some information that was possibly the same type he had been receiving through his computer. It is just a guess, but I do know he did want to meet me for some reason.

Our meeting with Howard Burgess turned out to be just as fruitful. He was full of strange stories of aliens in and around Albuquerque and we spoke a lot about his relationship with Paul and Gabe Valdez. He seemed to feel Gabe had been paid off by some government agency, although, he had no idea what agency it would have been. We speculated, but could never come up with just one hypothosis.

I left Albuquerque with an empty feeling inside. Driving by Kirtland Air Force Base and Paul's place of employment next to the base left me with an eerie feeling that I may never know what truly happened to Paul Bennewitz.

Paul Bennewitz seemed to need a friend or just someone to talk to every once in awhile. He would call sometimes, distressed saying the aliens were bothering him once again. I wrote to him off and on for quite awhile and tried to establish some kind of rapore with him. I was careful because I didn't want him to get paranoid of me, but what I found so astonishing was his staunch defense of Richard Doty. I think Paul became dependant on Richard Doty and trusted him. I feel there was mutual admiration between the both of them which continues to this day.

It makes me feel better to know Paul does not hold Richard Doty responsible for any of his troubles, although Doty's contribution to the dis-information campaign of Paul led to his mental health deteriorating. As Richard stated before in a letter to me, "he felt bad because he knew Paul went through Hell!"

There must be so much more we, the public are unaware of that took place in this dis-information ploy. We may never be told the truth and maybe no one knows what the truth really is.

Paul and I have always had a friendly rapore as you can tell from the insertion of two letters of correspondence I had with him. But, on my last visit to Albuquerque I called him, which he had always told me to do if ever I got in town, and the man I spoke to was not the same man I had corresponded with so many times in the past. His last words to me were, "I just wish people would quit calling me and leave me alone." He then hung up on me.

I somehow was not angry, but sad that this is how things had turned out for Paul. Isolation, pure and simple. This is his only peace of mind and so it is because of my deep admiration for this man that I write this paper. Because so many of you out there want to know this man, but never will. I hope my relating some of the facts have helped you to understand this tormented man and please understand that what ever was done to Paul has ruined him for life. Trust is not in his vocabulary any longer. So I will let go of him now and give him some peace of mind he so richly deserves. May God Bless Paul And Keep Him Safe From The Aliens That Keep Him Awake At Night.

SUMMARY & REPORT OF STATUS [WITH SUGGESTED GUIDELINES]

PROJECT BETA

Investigator - Physicist - Paul F Bennewitz

The following are key mile posts established or discovered during the continuing scientific study concerning Alien intervention and the result. (Study limited solely to New Mexico)

- Two years continuous recorded electronic surviellance and tracking with D.F.
 hr/day data of alien ships within a sixty (60) mile radius of Albuquerque plus 6000 feet motion picture of same daylight and night.
- Detection and disassembly of alien communication and video channels both local,
 earth, and near space.
- 3) Constant reception of video from alien ship and underground base viewscreen;
 Typical alien, humanoid and at times apparent Homo Sapiens.
- 4) A case history of an Encounter Victim in New Mexico which lead to the communications link and discovery that apparently all encounter victims have deliberate alien implants along with obvious accompanying scars. The victim's implants were verified by x-ray and Cat Scan. Five other scar cases were verified.
- 5) Established constant direct communications with the Alien using a computer and a form of Hex Decimal Code with Graphics and print-out. This communication was instigated apparently after the US base was vacated.
- 6) Through the alien communication loop, the true underground base location was divulged by the alien and precisely pin-pointed.
- 7) Subsequent aerial and ground photographs revealed landing pylons, ships on the ground - entrances, beam weapons and apparent launch ports - along with aliens on the ground in electrostaticly supported vehicles; charging beam weapons also apparently electrostatic.

- 8) Cross correalation and matching by triangulation, etc., to official NASA CIR (color infrared) high resolution films confirmed base locations and resulted in revealing US Military envolvement yielding precise coordinates and the US base layout.
- 9) Prior alien communication had indicated military envolvment and the fact the USAF had a ship but due to studied alien psychology this was ignored at the time.
- 10) Subsequently, the alien communicated following verification with the CIR, that there was indeed a ship; actually more than one that two were wrecked and left behind and another built this ship is atomic powered and flying. The alien indicated its basing location.
- 11) It was learned as stated that two women and a boy near Austin, Texas were exposed to severe radiation at close range and the ship was last seen going West with helicopters. In addition, the US Government was quietly picking up the expenses.
- 12) Subsequent inspection of motion picture photographs taken during the study revealed the US ship or one like it flying with the aliens. These match the CIR where two can be seen on the ground and in the later photographs taken on the ground after the base was abandoned.

So in very brief form the prologue to learning within reasonable accuracy what transpired prior to the end of 1979 or shortly thereafter.

The computer communications and constant interaction with the alien in this manner without direct encounter has given a reasonably clear picture of the alien psychology, their logic and logic methods and their prime intent.

It is important to note at the outset, the alien is devious, employs deception, has no intent of any apparent peace making process and obviously does not adhere to any prior arranged agreement.

In truth they tend to lie, however their memory for lying is not long and direct comparative computer printout analysis reveals this fact. Therefore much "drops through the crack" so to speak; and from this comes the apparent truth.

It is not the intent of this report to criticize or point fingers. Obviously whoever made the initial agreement was operating upon our basis of logic and not that of the alien and in so doing apparently walked innocently, in time, into a trap.

The alien indicated that the "Greys", apparently the group initially envolved in the agreement were still upset about the initial capture and subsequent death of the first eight of their co-fellows.

Another group, calling themselves in the Computer language, the "Orange" - their base is on the west slope of Mt. Archoleta - directly west of the south end of the US base and near NW of the apparent main landing area they call, in the Computer language, "The Diamond". This, because from a distance, it looks diamond shaped in the photographs when looking somewhat south west past the observation tower toward the ridged peak SE of Mt. Archoleta. This ridged peak has no name, I call it South Peak. The base extends north of this peak to the edge of the cliff down which goes a road past a large alloy dome thirty-eight (38) foot across the bottom and with a twenty (20) foot hole in the top.

Based upon some of the aerial photographs during which the alien was caught in the open and launching - some launches appear to be coming from the direction of the dome. I would guess it is an underground launch egress facility. In the NASA CIR there is what appears to be a black limousine alongside the dome on a ramp. Surprisingly it is precisely the size of my 79 Lincoln Town Car. Wheeled vehicles and what appear to be Snow Cats or Catapillars can be seen throughout the CIR - car and truck tracks, trucks and jeeps. I don't believe aliens have wheels - humans do.

Numerous road blocks extend northward through the US base along a well maintained road thirty some-odd feet wide - apparently gravel - near all weather - numerous turn arounds and wheel tracks into launch preparation areas with the ships; pads marked with twenty-six (26) foot Xs and servicing facilities, tanks, etc. - two domed polygon high voltage buildings on north on the east side of the road, also an apparent foundation for another or a helo pad - test stands, human housing, water tank (thirty-two foot across) - and at one of the main road blocks, two large vehicles parked across the road. Also at that point another apparent black limousine with tracks leading to it to the west of the road. All tracks and vehicles have been dimensioned and match military vehicles. If I were to make a guess, I would estimate the likelyhood that the apparent black limousines are CIA.

This is but a limited inventory of what was there on Sept 8, 1978 - included only as evidential matter for your perusal and confination. The road, which incidently the natives, the tribal chief, reservation police and highway patrolman know nothing about, comes in off of a trail from the north. Starting at the trail, line of sight to the large plateau area and the alloy dome, the road, in the middle of nowhere on the Jiccarilla Reservation, is precisely 12,888 ft. long airline distance. The total alien basing area, which apparently contains several cultures (now all under the designation "Unity" in the Computer language) is approximately three (3) Km wide by eight (8) Km long. A conservative guess based upon the number of ships presently over this area and the number on the ground in the CIR and photographs, the total alien population at this point is at least two thousand (2000) and most likely more. The alien indicates more are coming or on the way.

I won't attempt to speculate in this report as to how the initial US contact was made - what transpired, nor how many were able to escape. The alien has communicated his account, and if totally true, it certainly is not palatable.

Much detail has been omitted for future discussion if desired - however the import is this. Constant computer communication - full on line in February of this year - manual prior to that - has allowed a constant accounting of what is and has been going on - conditions of morale and a total insight into "what makes the alien run". This is very valuable data.

1) Most importantly, the alien will allow no one to go without an implant and after knowledge of it is wiped out. They simply will not allow it. All indications are that communication or language cannot result without the implant. (with the exception of the Binary and the Computer). This would indicate a possible immediate threat or danger for anyone - military, Air Force, or otherwise that has been at the base. They will not remember the implant in any case (the contactee here included).

The reason for the implant is multiple for both language or communication by thought (there is no apparent language barrier with thought) and also <u>complete</u> absolute control by the alien through program - by their beam or direct contact.

I have tested this and found that during this programming the person is totally alien; once one learns to recognize the signs and the person then has no memory of the act/conversation afterward. If this has happened to the military, I need not elaborate as to the possible consequences. The victim's "switch" can be pulled at any time and at the same time they are "walking cameras and microphones" if the alien chooses to listen in with the use of their beams.

No classified area of any endeavor in the US is inviolate under these conditions. However - realize - the scars, barely visible - can be seen - all are exactly located and all are accessible by x-ray.

- 2) Also note that all of the aliens human, humanoid alike all must have implants without them, no direct communication is apparently possible. So one can most generally arbitrarily say that if a person states he/she communicated by thought with an alien he/she most likely has been implanted. They may also claim to be overly psychic and be able to prove this again through the link transplant, he/she is given the information by the alien and does not realize.
- 3) Most importantly, the alien, either through evolvment or because the humanoid is made will exhibit tendencies for bad logic (bad by earth logic comparison) so they are not infallible in point of fact they appear to have many more frailties and weaknesses than the normal Homo Sapiens. To the alien, the mind is key and therein lies a great weakness which will be discussed later.
- 4) They are not to be trusted. It is suspected if one was considered a "friend" and if one were to call upon that "friend" in time of dire physical threat, the "friend" would quickly side with the other side.
 - The computer indicates in comparison, that no known earth protagonist Russian or otherwise exhibit these tendencies to any major degree indicating the danger involved in making any kind of agreement with these aliens at least of this species.
- 5) The alien does kill with the beam generally. Results on a human will exhibit a three to four cm purple circle. If done from the rear, on one or both shoulders. The results on cattle are the same, essentially exhibiting purple beneath the hide, with burned circles on the outside.

6) Cattle mutilations are the other side of the coin and will not be delved into here though they are a part of the overall. It appears the humanoids are fed by a formula made from human or cattle material or both and they are made from the same material by gene splicing and the use of female encounter victim's ovum. The resultant embryos are referred to by the alien as an organ. Time of gestation to full use as a utility, ready to work appears to be about one year. A year in alien time - I do not know.

Solution: I doubt there is an immediate total "cure" per se - however, they must be stopped and we have to get off dead center before we find time has run out. They are picking up and "cutting" (as the alien calls it) many people every night. Each implanted individual is apparently ready for the pull of their "switch". Whether all implants are totally effective I cannot predict, but conservatively I would estimate at least 300,000 or more in the US and at least 2,000,000 if not more worldwide.

Weaponry and Inherent Weaknesses

Weaponry is one of the keys and in the alien's present state we <u>can</u> prepare an effective offense.

One tends at the outset (I did) to look at their machines and say - there is no defense or offense. One is overwhelmed by their speed, apparent capability of invisibility and "cloaking", and other covert capabilities not discussed at this time. In particular - the beam weapons are themselves a direct threat and obviously one that must be seriously considered but not overly so.

Let us first look at just what this weapon is. It is an electro-static weapon with plasma generating voltages - and an internal storage device - it is pulse powered. The beam, totally effective <u>in atmosphere</u> can be loaded with hydrogen or oxygen. Range? Average, ground weapons - maximum two (2) Km if it is dry, capable of sustaining just so many full power discharges - slow leakage occurs continuously,

therefore, they must be recharged periodically. If it is raining the weapon becomes ineffective and is swamped, thus discharged. The range is near totally lost at that point.

On the disks and saucers, the weapon is generally on the left side or top center and has a maximum range of two hundred (200) meters at which point it will plow a trench in desert soil. When fired - it fires both to the front and to the back equally. Reason? Because of their mode and methods of flight. If equilibrium is not maintained, the saucer will spin out.

Hand weapons? Estimate based upon visible damage observed, not too much velocity nor staying power but at short range - deadly (less than a .45 cal automatic). At one meter range, estimate of beam temperature 1600°F or higher; it can vaporize metal. Apparently the disks and weapons operate from a storage source. In time, without periodic recharge, this storage is depleted. The design they traded to us was at least thirty years old - employing an atomic source. Possibly they may still have some - it would appear so - their staying power is obviously much longer.

Aircraft Helicopter Vulnerability

Any of our aircraft, helicopters, missiles or any <u>air flight</u> vehicle can be taken down instantly with no use of weaponry. The alien simply need do no more than make one invisible pass and their bow wave or screen or both will take the air lift vehicle down. The pilot obviously will not even know what hit him.

For human on the ground, the alien can use weaponry or bow wave. The partial pressure envelopecan hit with the power of a tornado - shock rise time and G force is instantaneous. However, they dare not hit the craft physically because they are fragile and in fact, under slow flying conditions within our atmosphere, hold a very tenuous position. Without power, balance or equilibrium, they lose it.

In brief - these are apparent capabilities observed and gleaned through the computer communication and observation. You may know of these, however, they are directly related to the last and final portion of this report. What can be done?

1) Because of the alien's apparent logic system (they appear to be logic controlled) a key decision cannot be made without higher clearance. All are under the control of what they call "The Keeper"; yet it would appear this is not the final say. Therefore, dependent upon urgency, delays of as long as twelve to fifteen hours can occur for a decision. How short/long this time frame under battle conditions may be, I do not know.

Because of this apparent control, individiual instantaneous decision making by the alien is limited. If the "plan" goes even slightly out of balance or context, they become confused. Faced with this, possibly, the humanoids would be the first to break and run.

The same applies to their Mission Master Plan, if one can call it that. If pushed out of context, it will come apart - they will be exposed to the world so they will possibly run before they fight in the open. They definitely do not want that to happen.

Psychologically, at present, their morale is down - near disintegration. There is pronounced dissension in the ranks; even with the humanoids. Communication can encourage this (no necessity to expound upon this other than to say because of their own internal vulnerability mind-wise to each other, therein lies a prime weakness). Inter-echelon or individual "trust" appears to be totally lacking so suspicion of each other is rampant. They are highly segregated as to levels - a "low" dare not conflict with a "medium" or "high" or it literally means death. Death being, to the humanoid, deprogramming or, in the end perhaps total physical death.

They appear to be totally death oriented and because of this, absolutely deathfear oriented. This is a psychological advantage. The computer also gives indications of a real possibility of adverse or "ground programming".

2) Consider their ships - most if not near all run on charge. That source depletes and so dependent upon size - depletion can occur for some within a week or less. Ships can replenish each other but only up to charge balance. This is done with antennae-like extensions and the charge is distributed observing conservation of energy laws. They can replenish from power lines - but again only to a point - so time of flight is limited. Deprived of their base recharge capability, it is indicated that all ships will come down within six months to a year unless they can get transported out - that is back to the prime launch ship.

The disks and saucers in general cannot fly in space because of their mode of flight. Therefore, deprived of home base, it is not likely they can survive. Their capability in power survival outlasts their capability in food or formula survival. It they do not get formula/food within a certain period of time they will weaken and die.

In the case of Mt Archuleta and South Peak, they are dependent upon the Navajo River for water supply and water to them is totally life. Without water they have no power; without power, no oxygen or hydrogen to service the ships and weapons. No water to sustain the organs and feeding formlula.

Simple? Not really. However, there is a water intake and there is a dam upstream that can be totally cut off and the water re-routed to Chama, New Mexico. Should this occur, at least three of the internal bases will go down. They could possibly go atomic periodically but obviously problems without cooling.

- Once the bases are pressed on a large scale, all disks and saucers will go airborn immediately. Troops on the ground can gain terrain cover to quite a degree it is rough terrain.
- 3) Our need is for a weapon, workable and preferably not like the alien's. I believe unless the alien is caught unaware (with their screen up their weapons are equal so they are like children pillow boxing) there can be no result; the weapon must penetrate their screen and it must also penetrate the ground. I believe I have that weapon. Two small prototypes have been funded and constructed by my Company. Tests conducted to date indicate they do work and work rather well considering their small size. Because of this weapon's present status and proprietary nature (a basic patent is in process), the theory will not be explained here. However, the weapon appears to do two things at very low power. 1) The disks within its range begin to discharge when exposed to the weapon beam. To counteract, they must apply more power and so doing consume more power. Again conservation of energy laws strictly apply.

This effect can be observed on the detection instruments as they back away in response to slow discharge. Discharge, at low power is slow but at high power in the final sophisticated weapon, the rate can be increased by many orders of magnitude. 2) Most importantly, this weapon can penetrate the screen - hull alloy, everything. They cannot shield it in any way. Lastly, because of the implants, the weapon's beam gets to them mentally; they lose judgement and indidate almost immediate confusion, particularly the humanoids.

It is believed at this early stage - based upon present testing that the weapon when full on and full size will kill or bring down disks at substantial range. The alien weapons operate substantially the same as their disks using a charge source and charge distribution. So, in the same sense it is indicated that this weapon design will pull their charge weapons down very rapidly.

The range of my weapon exceeds that of their present weapons and in its most sophisticated form can be readily computer controlled to allow extremely rapid tracking and lock-on regardless of speed along with electronic wobbulation of the beam. It is a beam weapon and even at this early stage of miniature prototype testing and development, it indicates eventual superiority to their weapons.

4) Initial logistics would indicate a plan sequentially implemented as follows:

This plan does not include all requirements and preparatory safety measures to be employed by the ground force; however, if Air Force Intelligence desires to pursue the approaches suggested in this report, each significant requirement will be discussed in depth.

An attack must be directed near entirety on the ground for obvious reason. One would, if familiar with the alien capability, indicate that vehicle ignition problems will be encountered. This is precisely true; however, the reason for this is not mysterious but is based upon good solid laws of physics and are known. Experience gained through my study, it is now known how to prevent this from happening and will be discussed in detail at some later date. All electrical and electronic equipment must be "hardened" using these specific techniques prior to implementation. Because of the known capability of the alien (by use of scanning beams to know in advance details of planning) only the initial outline is presented in this report.

Again through the communicative interaction with the alien, testing has simultaeneously been done upon this facet, i.e.eavesdropping, and ways to abort this capability have been tested and proven.

The program would be instigated in phases. The first phase - planning and logistics - would include continued implementation and testing of the final weapon prototype

thru the pre-production stage. Production of at least fifty minimum quantity should be planned. Additional backup spares should also be included.

On a full time shift basis, it is estimated that at least one year or less would be required to arrive at the pre-production stage. A team would be organized by Thunder Scientific to accomplish this. The key work is now and would be done by an associated company, Bennewitz Labs., Ltd.

Specific attack phases would be incorporated.

- River. This dam would be held closed for the duration. Internal to the one cave, there is a small dam for water storage. Its capacity is small. There is also a discharge outlet downstream that could be closed, causing waste water to back-up into the caves. The water is vacuum pumped apparently by some electrostatic means from the river. At close range, the weapon will take out this cabability.
- 2) Once deprived totally of water for a minimum period of four weeks, conditions in the alien bases under discussion will have badly deteriorated. Psychological shock is extremely effective with the alien; total advantage can be taken by instantaneous action or planned observable deviation from the norm. At least three bases will go down.
- 3) If they follow their normal strategic patterwas when pressed previously, they will launch most if not all ships.
- 4) Prior to the implementation of water deprivation, the weapons should be deployed at strategic hardened locations and activated in a certain pre-planned manner determined by final weapon coordinate locations.
- 5) This will put an immediate power drain upon those airborne and the alien weapons ringing their bases.

- 6) Because of the inherent psychological aspect of the alien, much can be done in the open with no attempt to preserve secrecy. Much of what is done can be of a diversionary nature. Under most conditions they will attempt to harass but will not openly attack.
- 7) Throughout and prior to this, the open computer communications link will be operational for continued psychological interrogation.
- 8) At some point in time again resting upon battle status, the deployment of offensive forces will begin. This deployment should be done in a near instantaeneous manner under certain special conditions that can be discussed.
- 9) The weapon system should be kept powered up throughout. In this manner, the disks will be made to stay airborne. They cannot land in the interval the system is powered.
- 10) When the weapon is used in one specific power mode, in addition to continuous discharge on the disks that are airborne and the ground based weapons, the mind confusion and discrientation will build in those personnel at the base and underground. At the end of four to five weeks or less, all weapons should be totally discharged and power out on the bases. Most personnel if not all, will be totally incapacitated. The feeding formula will be down and its critical processing ruined. All embryos should be dead and all hydrogen and oxygen consumables depleted.
- 11) Based upon data gathered on the miniature prototype weapons, the full power weapons should have no problem holding off the disks. In many cases some will break within the first forty-eight hours without being directly hit.
- 12) At that point, standard weapon technology and logistics can come into play and used to the extent of destruction desired at the direction of those in charge.
- 13) The communications can be used throughout to determine status and near the end to attempt to instigate surrender. If no response results, then they should simply be closed in and waited out.

Summary

It is important to note that the initial implementation of the computer communications was not instigated for the purpose of talking to the alien for the "fun of it"; but was <u>deliberately</u> instigated to use as a tool to study, in depth, long term without physical confrontation, the <u>strengths</u> and <u>weaknesses</u> of the alien.

The weapon theory and prototypes were built to capitalize upon and test the two <u>key</u> and prominent weaknesses discovered. This in-house funded program has been expensive, in excess of \$200,000; done on behalf of our nation and handled in the best representative manner humanly possible.

- 1) The <u>prime</u> and weakest area discovered, probed and tested is exactly what they have used thinking it is their key strength that being, the manipulation of and control of the mind; not only of command but also humanoid. Manipulated in reverse psychologically and by the language (computer) and due to the extreme of mental distortion and incapacity caused by the weapon, it has been found that this facet is for them a disaster and a directly vulnerable integrated weakness.
- 2) Though their ships are magnificent, they are also weak solely <u>because</u> of their method and unique mode of flight. They do not have a stable fighting platform. Charge distribution <u>can</u> also be discharged. The weapon does this even in its present miniature prototype stage.

It is not the purpose of this report to imply that the overall problem will be solved with the capture of these bases. Obviously it will not, but it is a firmly based beginning with a high degree of rated projected success ratio. It is not intended to imply the alien will not fight; they may - though their inclination is generally the opposite - this basing area is <u>key</u>. Without it, their mission is in very deep

With a conservative estimate using typical logistic support numbers, it is not unrealistic to say there are 50,000 aliens within the ecosphere of earth and near space. Some of us will be lost in the endeavor that is obvious - however, done now the advantage is gained along with new additional technology to prepare for the next stage. The key to overall success is - they totally respect force. And with them, the most effective method is to stubbornly continue to pick and pull at their defense with no letup. Faced with the total loss of a base that has taken years to construct, it is believed that their mission will be grossly weakened and badly slowed.

As Americans, in this particular instance, we <u>must</u> realize - that we in this case cannot rely upon our inherent moral principles to provide the answer. Negotiation <u>is out</u>. This particular group can only be dealt with - no differently than one must deal with a mad dog. <u>That</u> method they understand. They <u>have</u> invaded <u>our</u> country our air and they are freely violating the personal and mental integrity of our people. Therefore, in eliminating this threat most certainly we cannot be called the "aggressor", because we have literally been invaded.

In final conclusion A) They cannot under <u>any</u> circumstances be trusted. B) They are totally deceptive and death oriented and have no moral respect for human or human life.

- C) No negotiation, agreement nor peaceful compromise can be settled upon in any way.
- D) No agreement signed by both parties will ever be adhered to nor recognized and respected by the alien, though they might attempt to make us believe otherwise. E)

 Absolutely no quarter can be allowed under any circumstances. Once the offense is instigated, it cannot be abandoned. If it is, reciprocal reprisal will immediately result. They must be made to come down destruct themselves which is a standing order if the ship is failing or leave earth immediately no leeway of any kind can be allowed nor tolerated.

'THE AVIARY'

Webster's definition: Bird; akin to Greek aeros Eagle: a place for keeping birds confined.

In almost every conversation between researchers today the word 'Aviary' is often discussed. Who are these people and why are they so interested in certain UFO researchers and scientists? The code names vary from Sparrow, Bluejay, and Hawk to the infamous Falcon and Condor. It's a mix and match game that we, the American public have been playing for too long. Someone has to win and the stakes are high.

The past few years I have worked with various sources who have close ties to these birds. Just recently, my most trusted source gave me a call and we began discussing 'THE AVIARY' and who might be a member of this covert highly organized government group.

The source told me that two associates with this group have ties to parapsychology, UFO researchers and government intelligence agents. He said they may be tampering with our citizens who have connections or interests in the above subjects. My source also told me that we cannot trust the motives of 'THE AVIARY'.

I asked him to tell me more about this group and to name names if he could. A man by the name of Scott Jones who was a former assistant to Senator Claiborne Pell of Rhode Island. Senator Pell just happens to be the Chairman of the Senate Foreign Relations Committee. (Author's note: Don Ecker of UFO Magazine wrote a wonderful outline of this man in the most recent issue of his magazine, Vol. 7, No. 1 1992.)

What was so strange is that the names of Bill Moore, Jaime Shandera and Richard Doty came up and my source alleges that these men are a conduit for 'THE AVIARY'. It came as no surprise to me because who better to circulate messages and information for these high government officials than these three men.

Apparently, and we can only speculate, there are anywhere from six to twelve members of 'THE AVIARY'. They are apparently making contact with other UFO researchers mainly in the scientific community. We started a guessing game...could they be in touch with someone like Stanton Friedman, or David Jacobs or even Bruce Macabee? We were just speculating. We could start calling some of these scientists and just ask them, but we knew we would never get any straight answers.

Then my source began telling me a strange story about these birds. It seems that some of the members are involved in a remote-viewing project and that even one member helped Uri Geller when he came from Israel to the United States. The names Pell and Jones might have been involved in experiments with the Pentagon in which dream implantation experiments were being performed on certain susceptable individuals. My source was even telling me to stop sleeping with my television on and radio and telephones were also involved in these experiments somehow. This whole scenario was beginning to make sense to me because we all know that Paul Bennewitz began having problems after Moore and Doty befriended him.

I then began remembering some vivid dreams I had been having about none other than Saddam Hussein. And now I have to tell an account that will boggle the mind! To make it stranger, in my dream I was in Saddam, s bunker. My mission: to assasinate Saddam Hussein. Absurd? Maybe not.

IN OUR MIDST ?

The story I am about to relate to you is a true one. It involves a person who I know to have very high standards. The person has always been honest and very knowledgable in the field of ufology. To protect the person who I refer to as 'The Target' and the two conduits of the 'AVIARY, I have deliberately whited out the names of these individuals. The others directly involved will be left in this piece as they are involved with 'The Target', the two conduits and THE AVIARY. All of these people exist and what makes this story so strange is the fact that besides myself, I have run across several other people who have complained of having strange paranormal experiences involving dreams, remote-viewing and out-of-body experiences. The Aviary seem to be able to keep in contact at all times with the people who are having these strange experiences. As more time goes by, I am beginning to question my own beliefs in alien abductions. Why couldn't people like 'The Aviary' be involved in certain projects which might involve producing holographic projections to select people who feel they are UFO alien abductees? It is just another way-out theory, but one we must look into and fast!

Here is the story as it happened to the person I refer to as 'THE TARGET'...

Throughout my. life, I have had some highly unusual things happen to me that I cannot explain. Some prefer to call these experiences paranormal, others may call them supernatural, but whatever you may call them it isn't until one experiences such a thing for himself or herself that it becomes real. I didn't ask for these things to happen nor did I try to make them happen. They began when I was a child like all the other natural body functions and I have had to live with them and try to understand and cope with them whenever they occur. In October, 1990 a series of strange occurrences began that I cannot explain. This time, however, there may be someone that can explain to me what happened since these events involve other people who seem to know more about what is going on than I do.

In October, 1990, called to tell me that a high-level intelligence official from the Pentagon had contacted one of their intelligence sources and had told him (__) and to maintain a close relationship with . When told me this, I thought at first it may be some type of Psyop by the counterintelligence boys for some unknown motive. Afterall, it had been used on Bennewitz according to Moore who had participated in it. But __sounded serious and perplexed; I could hear it in the tone of his voice. If it was some type of Psyop, then was a victim as well. It didn't make much sense, since I was no longer active in ufology and had been inactive for nearly five years. I had nothing to offer, so why me?

Over the next few weeks, I had several telephone conversations with asking him about this mysterious intelligence source and why this high-level intelligence source would want and him to stay in contact with me. I could not get any straight answers, since told me that he didn't know any more than I did about it. did tell me that this high-level official contacted his intelligence contact and it was through his contact that he had received this information. I also asked what he thought about this matter and he said he didn't know any more than I did.

During these telephone conversations between and me, I learned that was in contact with Dr. Scott Jones, an aide to Senator Claiborne Pell, Chairman of the Senate Foreign Relations Committee. Senator Pell and Dr. Jones have been involved in parapsychology research for some time. It was Senator Pell that helped Uri Geller establish himself when this Israeli psychic first came to the U.S. and Dr. Jones had apparently known each other for awhile. I also learned that was in contact with a number of people that was apparently involved in parapsychological studies, i.e., remote-viewing, etc. And that these contacts led directly to other people in high political offices, the Pentagon and the White House.

- In a conversation with on November 9, 1990, I asked some questions about this mysterious high-level intelligence official in the Pentagon who told . . and him to stay in contact with me. A part of the conversation went as follows:
- : "This scientist that you are supposedly working with that is involved in remote-viewing....is he working with the Pentagon?"
- "Uh...yea...he ties into a whole lot of stuff...all the way up to people in Congress...uh...and the White House."
- ""Uh.huh... Well, when this other individual from the Pentagon told you and ""...I don't know whether he told first or told you both together...but when he told you that, and then said something to the effect of staying in contact with me...."
 - 1: "Right.."
- .: "...and I am not really involved in the ufological community at this point-in-time..."
- "Why...I thought it was very curious because it wasn't like a list of names or anything else...you were the only person that they said maintain contact with. They asked if we knew you...and they said maintain a relationship with him."
- .: "That's what I am saying, because I am just an average, ordinary individual out here...you know...in the community. I am not anybody with a string of credentials or anything like that and I haven't done any work in those areas, so-to-speak, like Uri Geller and some of the rest of them....and for someone. If his credentials are legitimate....you know....for him to tell you and that. Did you react to that or did you ask him why
- : "No. Because we have learned over the years in terms of relationship and stuff...that usually if there is more that they want to tell you at that point, they will tell you."
 - .: "Uh. huh."
- _: "We figured the proof would ultimately be in the pudding. Something ultimately would develop somewhere along the lines."

About two weeks after this most mysterious telephone call from ', I began to have some unusual dreams about Saddam Hussein and what felt like "out-of the-body" experiences or remote-viewing about details of the war with Iraq. In these dreams I could see that Hussein was going to have three dreams that were of a religious nature, actually warnings about the actions he had already taken and what was to take place. It appeared that Hussein was also in contact with his psychics and seers. These dreams and remote-viewing experiences were so impressive that I felt compelled to call and tell him about them as well as requesting that this information be given to "higher authorities".

contacted Dr. Jones. Dr. Jones, which I learned later, contacted the proper authorities which I presume were in the Pentagon.

called me the next day and told me that Hussein had had his second dream as had heard about it over the news. He sounded a little amazed by the fact that what I had said to him was coming true. I told that Hussein had one more dream to go. I then proceeded to ask if he had given the other information (details about the war) to the proper authorities and he told me he had. I never did hear about whether he had his third dream or not.

During this time period, I felt like I was in the middle of some type of "psychic warfare". It's the only way that I can explain it. And the previous events such as the mysterious telephone call from telling me about this "high-level intelligence official" apparently in the Pentagon and then the unusual dreams and remoteviewing experiences or whatever one wants to call them had me wondering what was really going on.

I recalled that there have been a number of UFO associated incidents in which some people have a UFO experience and then later have unusual dreams. Une in particular come to my mind during unusual events, the Capt. Coyne incident which happened on October 18, I will not elaborate on the details of the Coyne incident since it can be found in UFO literature, but after the incident " someone involved in "metaphysics" in the Pentagon called Capt. Coyne to ask him if he had had any unusual dreams since the UFD experience. Coyne, indeed, reported that he had had two unusual dreams. As time passed, the Pentagon would call the crew members of the helicopter who were also involved in this UFO encounter and ask them if they had ever dreamed of "body separation", in other words out-of-the-body experiences. What I find interesting about this Coyne incident is the nature of the case - unusual dreams and the Pentagon apparently knowing about them. Also, the time period is interesting since the two events, the Coyne encounter and my paranormal experiences, happened during the middle of October. In my case, a "high-level" happened during the middle of October. intelligence official in the Pentagon tells and to "stay in contact with me" and then I have these unusual dreams and paranormal experiences. All of this may be purely coincidental.

Months went by without or contacting me, and then the Persian Gulf War was over and our troops come home. I thought to myself that if and was supposed to have "stayed in contact with me", they didn't do a very good job. I made no effort to stay in contact with them after I told them about my unusual dreams and other paranormal experiences concerning the war. I didn't know what the name of the game was, and I couldn't say that I was pleased with the past actions of when he was dealing with Bennewitz. So, I dropped contact and played the waiting game.

I was determined to find out what was going on, so I called Dr. Scott Jones for the first time. I introduced myself and politely asked him several questions about his involvement in the field of ufology and parapsychology and if he knew . Dr. Jones told me

he indeed did know , and then I asked Dr. Jones if he had received any information from to give to the "proper authorities" about the Persian Gulf War. He was a little reluctant to answer me until I told him that it was me that had given this information to . Dr. Jones said, "So it was you". I said, yes. And he said, "Yes. I gave the information to the proper authorities". Dr. Jones would not elaborate on this matter, and I did not pressure him about it. We discussed other matters and he gave me his home telephone number in case I needed to call him about anything I felt important.

About a month later, I began to have another disturbing dream and psychic impressions during the day about a catastrophic earthquake soon to hit California. These were exceptionally strong psychic impressions. So I called Dr. Jones at home and explained what was happening. He suggested a wait and see situation, and told me that he would give this information and my name to a friend of his in the Library of Congress who had a research project called "The Migraine Project". The time period that I felt this event was going to occur came and went without anything happening. Later, I learned through a contact of mine that a group in Sedona, Arizona was claiming to be in contact with "higher intelligences" and they were reportedly receiving exactly what I was receiving. I wondered if I had been picking up what they were doing in Sedona rather than an actual premonition. Again, why me?

In October, 1991, I called to see what had become of the intelligence contact and he told me that he just seemed to have mysteriously disappeared..."no one seems to know where he went." I questioned about this, and he said, "I don't know any more than you do about it."

In a November 18,1991 news article from Washington entitled "ESP used in Iraqi weapons hunt", I noticed that it was about "remote viewing" being used on Iraq. A U.S. Army Maj. Karen Jansen working with a UN team took data obtained by psychics via remote-viewing, who were associated with Edward Dames, president of a company called PSI Tech, to Baghdad. This intrigued me because I felt this was apparently connected to what had transpired between me, ... and Dr. Jones during the war — especially the remote-viewing aspects.

On December 26, 1991, I called to question him about this news article since he had told me that he was associated with some people involved in remote-viewing. said, "one of my CIA contacts said the news report on remote-viewing was not true". He also said that "the CIA became extremely interested in the news story when it first appeared." The CIA contact told him that Edward Dames, who said he had done certain things with psychics, had not done them and that "the story was merely a marketing scheme concocted to promote Dame's company". I told that I found this a little hard to believe in view of the names and what was said in the article, not to mention what I had experienced. said this is what he was told by his CIA contact.

A few days later, I called Dr. Scott Jones and ask him if he had received my letter since I hadn't received a response. He replied that he had. I realized that he had been taking trips out of the country and had been extremely busy. I then questioned him about the mysterious "high-level" official and my unusual dreams and remoteviewing experiences. He said, "You are still not clear on this?" I told him, no. He did not elaborate on this. As I explained my confusion over the matter of the paranormal events he said, ", I will tell you confidentially without getting into details that there were a number of people getting input in addition to yourself". I was kind of shocked and surprised at this statement. Again, I did not pressure him on this matter since he said he couldn't go into any details.

I then asked him if he knew about the news article on remoteviewing by a company called PSI-Tech and proceeded to explain what
had told me his "CIA contact" had told him. He said, "both
statements are true" and he went on to explain how publicity was
generated on this matter by CBS. He said that he knew Ed, President
of PSI-Tech, very well, and that what was stated in the article about
remote-viewing being used to obtain site locations on lraqi
installations was true and the information supplied by the psychics
was accurate.

It is now the beginning of 1992, I am still in the dark on these most unusual events. I thought it was all over until today, January 9, 1992 around 10:05 a.m. I had just walked in the door when the telephone rang. I answered it thinking it was my wife, but instead it was a man on the other end that said, "Is this?" I said, "yes." He then said, "I am the one who contacted intelligence contact and told him to tell them to stay in touch with you. You, along with a few others on this planet, are going to be contacted by the visitors according to the program." I thought this was somebody pulling a practical joke on me, but he continued to tell me things that only I knew. I tried to question him about who he was, but he continued by saying that, "you have been watched for a long time because of your genetic development, in other words, a mutation of a new species over a long period of time." He then said, "we will be back in contact with you."

I called and Dr. Scott Jones, but I could not get in touch with them. Dr. Scott Jones was apparently out-of-town and no one answered the phone at shome. I then called and explained the scenario. I am not taking anything seriously, except for my own personal experiences.

This leaves me with several questions about this whole matter.

Who was the mysterious "high-level" intelligence official that told and ... to "stay in touch with me?" Why didn't and ... stay in touch with me? Who is the Pentagon scientist involved with remote-viewing that knows? Why did I have these unusual dreams and paranormal experiences immediately after contacted me? Who did Dr. Scott Jones give this information to that he called the "proper authorities"? Who were these other

people that received "input" and just exactly what did Dr. Jones mean by this? Was PSI-Tech and others involved prior to the war using remote-viewing and I happened to pick up on it? Does this apply to the Sedona, Arizona area as well? Was my paranormal experiences the reason this "high-level" official contacted in through his intelligence contact in the first place? And who is this individual that claimed to be the "high-level intelligence official" that told me he was the one who was in contact with intelligence contact? Is somebody playing games with me? Something doesn't add up here!







William Moore Update " THE USEFUL IDIOT "

In Howard Blum's book, 'OUT THERE' Mr. Blum describes the Bennewitz scenario much like I have only he had the inside knowledge of Bill Moore's character and background. As I have stated before, Mr. Moore has refused all interviews with me, Christa Tilton. I have never met Mr. Moore and probably never will.

By Mr. Moore's own words, he has the uncanny ability to size people up whether he has met them or not. Howard Blum used the same statement in describing Mr. Moore in 'OUT THERE'.

In the beginning I spoke to Bill Moore via telephone in 1987. We discussed my marriage to Lt. Col. Wendelle Stevens and the accusations that had been made that Bill Moore had something to do with getting Wendelle sent to prison on a morals charge for five years.

I found Mr. Moore to be a soft-spoken person, not the 'wicked agent' that had been described to me by countless others who either knew him intimately or had met him through interviews. And so, after five years of searching on my own, I decided to write Bill in hopes he could shed some light on my abduction experiences. I knew of his connections with the government and I knew of his broad knowledge of the subject of UFOs. I had heard many horrid rumors about Moore's 'dirty tactics' and had been warned never to get on his bad side. At first I was intimidated by those comments, but I felt they were not fair to Mr. Moore. How could I judge a person and his credibility by never meeting with him face to face? It is not the way I operate or evaluate fairly another individual. And so I assumed that Bill Moore would judge me after he had met with me...WRONG! I tried to chalk it up to maybe jealousy, as women researchers in ufology have had a hard time achieving some semblance of credibility from the male researchers in the UFO field.

I have one confidential source with whom I confided in about this delima. This man has never met me, has heard all the dirty rumors about me and my past, but considers me a wonderful researcher and writer. He mentioned that maybe there was some jealousy involved on Bill's part. I appreciated this researchers' concern and helpful information about Moore, but I still felt it delved deeper into something else. It is nice to know there are people out there in the field who are willing to give someone like me, a beginner a chance. I credit this researcher with pulling me through this ordeal. It shows that he is intelligent enough to see through all the bullshit people have spread about me over the past five years. He has never met me, but he treats me as an equal and a lady. Why couldn't Bill Moore?

Just recently I heard Mr. Moore was having a hard time financially. I think all of us that do any research in this field can relate to that. I had just returned from Japan after appearing on a television documentary and for the first time in a long time I had some extra money to spare. I decided to show Bill my good faith in truly wanting to gain his trust and friendship by sending him an undisclosed

amount. I wanted to send it in the form of a donation to FOCUS and it was carefully sealed up in a double envelope, addressed and ready to be sent. It then dawned on me that I should call Bill and tell him that he would be receiving a 'Return Receipt' letter just to make sure he received it. I asked if he would be the only one to pick up his mail as I wanted to make sure this large amount of cash would get into Bill's hands personally. The idea was to just bury the hatchet and truly let Bill know that I never had any ill feelings towards him personally. The reaction I received almost made me faint! Bill told me that he was on to me and knew exactly what I was trying to do. I said, 'Excuse me?' in shock! His next attack with words left me in a 'limbo' that I haven't been in since my breakup with my last husband. He told me and I will try to quote as accurately as I can because I was not taping the conversation, "You are a desparate, manipulative, lonely and insecure person who is nothing but a failure! Look into a mirror, he said matter of factly. You see Christa, I am a Scorpio and I have the advantage of seeing the kind of person you truly are from the very beginning. You are nothing but an annoyance to me and to everyone else. No one wants to have anything to do with you and neither do I so I just wish you would leave me alone." Trying to hold back the tears, I agreed I would never bother him again. No letters, no tapes or calls...nothing. Well, over the years I have developed a hard outer core and learned to try and not let words get to me. I have been called many horrible things, but I learned from a very intelligent person that people who say these hurtful things are nothing but pitiful failure themselves and to justify their own downfall they attack others, especially the ones who are most vulnerable in their eyes. So you see, Bill Moore knew how vulnerable I was. He knew what I had been through in the past. He knew it must have devestated my life and he knew that the only way to justify his failure as a person was to zone in on someone like me... A person who had once asked to meet with him because she admired his work. This was his response to me. My cuter core crumbled that day and I let my guard down and I let him hear me cry! I am angry with myself for my own insecurities.

Bill was just 'calling a spade a spade' as he had told me in so many of his past letters. But everytime I tried to pin him down as to who all of these enemies I had he never would name any names. Sure I admit I have had personality conflicts with certain individuals that became emotionally involved with me and I admit and I think we all can say that we are at times very lonely. In this field it is almost a sure thing to be alone in searching for the truth. We are all insecure at times also. I am the first to admit that Bill Moore had me pegged on those personality quirks, but there is one thing I am not!!!! I AM NOT AND NEVER WILL BE A FAILURE! To call me a failure I then realized that all along he considered me a threat to his research. He knows of my past government connections and my knowledge about certain areas in which the covernment wishes I did not have. Also, I cannot help the fact that my mother and father worked in intelligence at The Pentagon in the forties. My mother was a chief assistant to Hap Arnold. I had mentioned this to Bill early on in my correspondence. My father also worked in intelligence with the Army and Navy, but he died when I was fifteen. This does not make me a coverrment agent myself. It is just a portion of truth that fits into my past family background. I cannot state that this is a threat to Mr. Moore, but maybe he thought I was tooting my horn by telling him this information. I was not. I am proud to tell anyone about my mother and her work at the Pentagon in the Mar Department. She received outstanding awards for her dedication to Hap Arnold and Col. John Marsh. Whether she had knowledge of any TOP SECRET information on the subject of UFOS is for my mother to answer.

I would like to state for the record that I was not trying to buy Mr. Moore off. In the letter with the money I stated I did not want an interview or did I expect anything from him in the future. I told him to use the money and not to tell anyone that I had given it to him as I did not want any credit. If this is proof that I am a manipulative failure of a person then so be it.

FINAL COMMENT FROM THE AUTHOR

Paul Bennewitz is still alive. There are so many conclusions that we as researchers have talked about and written about, but I do not believe I even touched the very surface of what really was and is going on in Paul's mind. This is why I urge the readers of this manuscript to push yourselves to the very edge of possibilities and learn more about the governments' use of mind control. Below I have quoted just two paragraphs from Martin Cannon's wonderful manuscript, 'THE CONTROLLERS'. He offers a very believable alternative way of thinking...a new way of seeing the UFO controversy. I hope all the readers will order this valuable manuscript to help them in further research on the subject of abductions and mind control.

Once you've read it, you will automatically see that the questions of abductions can easily be explained. You may not want to believe it, but it's one persons' viewpoint that needs to be studied in depth.

It solves many of the questions I had about Paul Bennewitz and his dealings with these 'aliens' of his. It also gives me another way to explain what happened to me in the course of my lifetime.

The Hypothesis

Substantial evidence exists linking members of this country's intelligence community (including the Central Intelligence Agency, the Defense Advanced Research Projects Agency, and the Office of Naval Intelligence) with the esoteric technology of mind control. For decades, "spy-chiatrists" working behind the scenes — on college campuses, in CIA-sponsored institutes, and (most heinously) in prisons have experimented with the erasure of memory, hypnotic resistance to torture, truth serums, post-hypnotic suggestion, rapid induction of hypnosis, electronic stimulation of the brain, non-ionizing radiation, microwave induction of intracerebral "voices," and a host of even more disturbing technologies. Some of the projects exploring these areas were ARTICHOKE, BLUEBIRD, PANDORA, MKDELTA, MKSEARCH and the infamous MKULTRA."

As a result of this research, I have come to the following conclusions:

- 1. Although misleading (and occasionally perjured) testimony before Congress indicated that the CIA's "brainwashing" efforts met with little success, striking advances were, in fact, made in this field. As CIA veteran Miles Copeland once admitted to a reporter, "The congressional subcommittee which went into this sort of thing got only the barest glimpse."
- 2. Clandestine research into thought manipulation has *not* stopped, despite CIA protestations that it no longer sponsors such studies. Victor Marchetti, 14-year veteran of the CIA and author of the renown expose, *The CIA and the Cult of Intelligence*, confirmed in a 1977 interview that the mind control research continues, and that CIA claims to the contrary are a "cover story."9
- 3. The Central Intelligence Agency was not the only government agency involved in this research. Indeed, many branches of our government took part in these studies including NASA, the Atomic Energy Commission, as well as all branches of the Defense Department.

To these conclusions, I would append the following -- not as firmly-established historical fact, but as a working hypothesis and grounds for investigation:
