Interrogation of Dr. Werner LIEBKNECHT
on the Organisation & Personalities of Wa Pruef 7.

Introduction

Dr. LIEBKNECHT feels that he can only give a very incomplete picture of the organisation since the nature of his work did not necessitate contacts with other branches of the Department. The only Divisions of the department in which LIEBKNECHT worked were Gruppen II and III. Hence he was able to give a somewhat fuller account of those than of the others. The Department was reorganised several times during the last 18 months of the war and he finds it difficult to recall with any accuracy when and how these transformations occurred.

Organisation

Wa Pruef 7 was that department of the Heereswaffenamt concerned with signals equipment of all kinds. During the period (1937-45) when LIEBKNECHT was employed with it, it was divided into five groups and one independent Referat as follows. (A seventh group was created during the summer of 1944).

Each Group was divided into Referate, some of which often changed their personnel and the subject on which they were engaged.

Gruppe I was directed by a patent lawyer from BERLIN whose name LIEBKNECHT could not remember. Taken over at end by Min. Rat. FORSTMEYER from Gr V. A Dr. KOEPKE was Referent for Raw Materials.

Gruppe VII Director: Ministerialrat BERGAU
 (LIEBKNECHT knew nothing of this Gruppe except that its
 activities were of a highly secret nature connected
 with a secret rocket weapon A4. At the time he did not
 know whether this was V1 or V2, but now realises it
 must have been V2. Baurat SKALA (Gr. IIIe), he
 believes, transferred to this Gruppe when Gr. IIIe
 was dissolved).

Other personalities

Dipl. Ing. ROELKE

Dipl. Ing. SCHNEIDER

When LIEBKNECHT was transferred from Gr.IIe to Gr.IIIh in 1942, ROELKE remained for a short time in charge of Gr.IIe to provide a little competition. However, this arrangement did not last long as it was soon apparent that ROELKE was making no faster progress than LIEBKNECHT, and ROELKE's Referat was dissolved, ROELKE returning to LIEBKNECHT's party.

LIEBKNECHT stated that he obtained his position in Wa Pruef 7, through Oberst GRUBE whom he succeeded as Assistant in the Department of Fernmeldetechnik at the Technische Hochschule BERLIN.
