The annual report to our membership, along with, tribal budgets were presented to the General Council. The Business Committee also informed the membership of the plans for the purchase of minority shares of Buffalo Run Hotel from RHW hotel group.

It was a pleasure to see all the tribal members and their families that weekend. I want to thank the staff and Stomp Dance Committee for an outstanding day and evening. It is great to see everyone and visit with our tribal family. Once again, you may contact the office to receive any of the handouts that we made available at our meeting.

The Business Committee also announced the purchase of a tract of land

that was part of the Peoria Tribe's original allotment. This property consists of over 150 acres of land which once was the Miami County Club and golf course. The previous owner had closed the golf course and business operations before the closing of the purchase. The Business Committee is exploring all options for this property. As with any asset of the tribe, your elected officials feel that land in our original allotment is a priority and a sound investment of tribal resources.

On May 27, the end of an era has reached our friends of the Wyandotte Nation. Chief Leaford Bearskin retired. Chief Bearskin was a great leader and represented the Wyandotte Nation with pride and dignity. Many tribal leaders, myself included, were honored to attend a reception celebrating his service, not only for the Wyandotte people, but all Native Americans in our area.

As summer is approaching, I hope to see many tribal members at the various functions held by the tribes in Ottawa County. I would like to remind each of you that our Pow-Wow will be held June 24-26 and encourage you to attend or even assist during that week.

Child Care Development Fund Program

Native American Youth Camp has been cancelled for this year, 2011.

We are also planning our annual Providers Appreciation Banquet. That is a banquet to show all our providers that we appreciate the quality of care they give to our Native American families.

The child care program is funded through the Administration for Children and Families (ACF). This program is to provide childcare services and activities. The qualifications for the program are:

- There will always be a co-pay per child per month for each family.
- Live within 100 miles of the Peoria Tribal Office in the states of Missouri, Kansas, Arkansas, or Oklahoma.
- There must be an Indian in the household.
- Be under 13 years of age; or be under age 19 and physically or mentally incapable of caring for themselves; or under court supervision.
- Reside with a family whose income does not exceed the maximum net income level. There will be some deductions considered. Income level does not apply to the children that are physically or mentally incapable of caring for themselves.
- Co-pay **example**: Monthly net income of \$4,054.00 for a family of four, the co-pay would be \$105.00 per child per month. Every family will have a co-pay.
- Reside with a parent, parents or guardian who are gainfully employed or attending a job training or educational program; or receive, or need to receive, protective services.
- Adult must be at work or in class in order for the CCDF Program to assist with child care.

THE ENVIRONMENTAL CORNER

The Importance of Water Conservation and Protection

Less than one percent of all water on the planet is available for human use. The remaining 99+ percent is tied up in glaciers and oceans. This statistic emphasizes the importance of water conservation and protection even in areas where water is seemingly abundant. It is easy for water to be abused and degraded, but extremely costly and difficult to remediate once that happens. There are many things we can do as individuals to protect our water resources.

The first thing to remember is to be aware of what goes down the drain. City wastewater systems are not required or designed to completely remove all contaminants from the water before release into local rivers or streams. Household chemicals such as chlorine bleach, toxic cleaners, paint thinners, and even medications that dissolve in water can end up in the watershed even after treatment. Most communities offer services for disposal of those items that should not be dumped in the sewer systems. Septic systems are not an exception to this problem. In fact, since most septic systems have leach lines that run relatively close to the home, the contamination remains, literally, in your own backyard.

The other major system that is susceptible to unintentional contamination is the storm water drainage system. This includes gutters, ditches, storm drains, and storm sewers. The water flowing into these systems is not sent through any treatment, but instead is funneled directly to streams and rivers. Most of the contamination from this route comes from grease/oil from roads, driveways, and parking lots. However, pesticides and fertilizers from yards and/or agriculture can enter these systems as well. The best way to prevent this type of pollution is to make sure that your vehicle is properly maintained, and use good planning when applying chemicals to your lawn or garden.

NEW BOOK OF MYAAMIA AND PEORIA STORIES PUBLISHED

Developed through the Myaamia Project at Miami University in Oxford, Ohio, the first collection of Miami-Illinois texts has been published. *myaami neehi peewaalia aacimoona neehi aalhsoohkaana*, a collection of Myaamia and Peoria narratives and winter stories, edited and translated by David J. Costa, is now available for purchase through the Trading Post. The cost of the book, including postage, is \$6.00 for shipping at book rate (7-10 day delivery) or \$8.00 for priority first class mail.

Dr. David J. Costa has spent much of the past twenty-two years translating and interpreting this collection of stories. Daryl Baldwin, Director of the Myaamia Project of Miami University, worked closely with Dr. Costa on the project.

The book is presented in a bilingual format where Miami-Illinois appears on the left page and a free English translation on the right page.

To quote Mr. Baldwin, "Our elders knowingly left these stories for us, all of us, of all ages and generations. The meanings behind these stories are culturally layered and deeply seated in our history. Uncovering this knowledge will take generations of thoughtful work. As a result of that effort, we hope the stories will continue to find themselves in expected and unexpected places within our communities." He continues, providing clarity of storytelling, "Within the Myaamia community storytelling begins with *teekwahkahki* 'the killing frost' in late fall and commences with the arrival of *ciinkwiaki* 'thunder beings' in the spring. We believe it is the wish of our ancestors that we continue to follow this story telling pattern, for they warned us not to tell winter stories out of season."

This book will be not only a vision into the past for many of us, but also a look into the future as it is shared with children and grandchildren for generations to come. These stories were filled with "lessons" to be learned as we continue to create new stories.

For those who are students of language who wish to learn more about pronunciation of the Miami-Illinois words, the Trading Post has available the *myaamia neehi peewaalia kaloosioni mahsinaakani: a Miami-Peoria Dictionary*, released by Baldwin and Costa in 2005. The costs for the dictionary, including postage, is \$14.50.

Motion was made and seconded to put full control of the properties of the golf course and the hotel under the management of Direct Enterprise Development with full management control effective immediately with no additional fee other than the 30% paid out of gaming operations. Motion carried unanimously Motion was made and seconded to amend the Tribal Enterprise Budget by \$3,300,000 for the purchase of the assets of Buffalo Run Hotel from RHW Buffalo Hotel, LLC and amend the Economic Development Budget in conjunction with that amendment, and further, to transfer out of Tribal Enterprises \$175,000 to cover the losses at Peoria Ridge Golf Course. Motion carried unanimously. Motion to adjourn was made and seconded. Motion carried unanimously and the meeting was adjourned.

Motions were made and seconded to approve three resolutions and each carried by unanimous votes: (1) Resolution R-04-05-11-A, "Resolution Approving Agreement Concerning the Cooperation and Coordination Among the Tar Creek Trustee Council Indian Tribes Pertaining to Joint Legal Representation in 2011 Legal Representation: The Cherokee Nation; Eastern Shawnee Tribe; Ottawa Tribe; Miami Tribe; Peoria Tribe of Indians of Oklahoma; Seneca-Cayuga Tribe; and Wyandotte Nation"; (2) Resolution R-04-05-11-B, "Contract for Hiring the Law Firm of "Shannon D. Work, P.C." and the Law Firm of "The Cleary Law Group" for Legal Counsel Needs for Pending Natural Resources Damage Assessment and Restoration Activities"; and (3) Resolution R-04-05-11-C, "Approval for Formation of Corporation and Appointment of Director". There was no request for Executive Session. Motion to adjourn was made and seconded. Motion carried unanimously and the meeting was adjourned.

Indian Child Welfare services for the Peoria Tribe of Indians of Oklahoma are available to all enrolled Tribal members and, in most cases, to those who are eligible for enrollment.

The Indian Child Welfare Program (ICWP) is located in the Tribal Programs Building. If you should need our services, please feel free to contact us there. The office number is 918-540-2535 you can ask for Doug Journeycake, Director (Ext. 19 or Cell 918-540-4370) and/or Faye Woods, Secretary/Intake Worker (Ext. 32 or Cell 918-533-8808).

Tribal Foster Home? Open your heart and home to children in need. Give children a chance to have a new and better life. The rewards of being a foster parent are there for the adults, as well as the wonderful results for the children. The process is relatively simple, you fill out an application, and we will do a thorough Federal and State background check on anyone over 18 years of age living in the home. We will require you to provide four personal references that the Indian Child Welfare Program (ICWP) will contact, and then the Indian Child Welfare Director or his designated representative will do a home visit in your home. Once that process is completed, the ICWP may license your home as a tribal foster home in conjunction with the approval of the Department of Human Services (DHS).

FROM THE ENROLLMENT OFFICE

Since February, the Enrollment Office has received seventy-six (67) address changes, nine (9) name changes and five (5) deceased membership notifications. Thirty-seven (37) duplicate membership card applications were processed. The Business Committee has approved thirty (30) new members. Currently there are 2984 tribal members.

Is your State Certified Birth Certificate on file in the Enrollment Office?

The Enrollment Office is continuing to update all tribal membership files. Many members have already sent in their state certified birth certificates. To comply with Federal guidelines and be eligible for a CDIB card, issued through the BIA, a state certified birth certificate is required. Reminder; state certified birth certificates must show, state file number, state seal, state registrars signature and parentage. If you are unsure if you have a state birth certificate on file, or need assistance in acquiring one, please call the Enrollment Office. We have most state applications for birth certificates in the office. Currently there are 1150 members without a state certified birth certificate on file.

Is your name updated in your membership file?

The Enrollment Office will be glad to assist any member who needs to have their name changed. If your name has changed and you would like your enrollment file to reflect your current legal name please bring or send in your legal documentation (such as marriage license, court order, etc.) and the change can be made. If you are receiving the tribal newsletter with a previous name listed on the address label, please call the enrollment office for assistance or send your legal documentation (i.e. marriage license, court order, etc.) so your file can be updated. It has been observed, the postal service has been returning newsletters and other miscellaneous correspondence sent from the Tribe if a persons name does not match their postal record.

Missing or Change of Address

We still have several members (647) listed on the whereabouts unknown list. Any and all help is appreciated in finding these members. Several members have contacted the office with an update of family members. When the Enrollment Office receives a telephonic or electronic address change, the Enrollment Office will send a change of address form to the missing member with a request for completing the change of address form. Once the Enrollment Office receives the original, signed, completed form, the address is updated and the form is placed in the members file for accuracy. The Enrollment Office must have written permission from the tribal member, over the age of 18, or the legal custodial parent, for members under 18, on file for address changes. If you know someone on the list, above the age of 18, please have them drop us a letter, with their signature, requesting the address change or send them the change of address form. If you have a child under the age of 18 (and you are the legal custodial parent) who is listed on the list, please fill out the change of address form, sign and return to the Enrollment Office.

For your convenience, a change of address form has been placed in the newsletter. If anyone has knowledge of a person or persons listed on the whereabouts unknown list, sending this form to them would be greatly appreciated. The address for returning the form is:

Enrollment Ordinance Reminders

The Enrollment Office receives calls with requests for help or general enrollment information. To help members, listed below are a few reminders of the Enrollment Ordinance, which was revised and approved March 23, 2002. Below are sections of the Enrollment Ordinance of which the questions or information are typically asked.

Section 2. Dual enrollment with another Federally recognized tribe is prohibited and such prohibition shall be strictly applied; an enrolled member of another tribe shall not be eligible for membership with the Peoria Tribe. If a member of another tribe wishes to become a member of the Peoria Tribe, they must first relinquish all membership with other Federally recognized tribes.

Section 8. Each enrollment application must be completed in its entirety and must contain sufficient information to determine the applicant's eligibility for enrollment. Applicants must list the following on enrollment applications: all names by which the applicant has been known, applicant's current mailing address, name and notarized affidavit confirming applicant is not enrolled with any other Federally recognized tribe, and signature of the applicant or signature of the person filing the application on behalf of the applicant.

Section 9. Applications for enrollment must be accompanied with a State certified birth certificate. Applications received without a State certified birth certificate will not be processed. The following must be visible on State certified birth certificates:

State Seal

State File number

State Registrar's signature

State certified birth certificates must also be recorded with the State Vital Records Division of the state of birth. The following documents <u>are not</u> acceptable when accompanied with enrollment applications:

Hospital birth certificates

Baptismal certificate (even when parents' names are shown)

Heirship records

County abstracts

Approval of birth certificates issued by foreign nations or other highest-ranking governmental sub-division with jurisdiction to issue birth certificates will be at the discretion of the Enrollment Committee.

Section 18. Changes to active membership records, such as name changes due to marriage or divorce, must be made by legal documentation (i.e. marriage license, divorce decree, court order, etc.). Active members with change of addresses and other status information must notify the Enrollment Office at P.O. Box 1527, Miami, OK 74355 or by telephone at 918-540-2535 or 1-800-259-9987. Maintenance and accuracy of membership record data is the sole responsibility of each tribal member. Each tribal member is personally accountable for correct membership record information (i.e. contact information and/or name changes). The Tribal Enrollment Office will review changes to membership records to be forwarded to the Enrollment Committee; the Enrollment Committee shall certify its recommendation of approval to be approved by the Peoria Business Committee. Changes to membership records must ultimately be passed by resolution from the Business Committee and submitted to the Miami Area Agency, Bureau of Indian Affairs.


