T H E

PUBLISHER TO THE READER.

AS a Book intituled, *Valor Beneficiorum Ecclesiasticorum in Anglia & Wallia*, was printed in 1680, for the Use of the Clergy in *England and Wales*; it may not be useles to publish likewise the *Taxations* of all the *Ecclesiastical Benefices* in this *Kingdom*. It in the following *Traët*, the Names of some *Rectories* and *Vicarages* be found to differ from the modern way of Spelling them; it is a Fault, which could not be avoided in printing a true *Copy* of the *antient Names*, as well as the *Valuations* affixed to them: And the Reader may be assured that the following Account is *authentick*, being faithfully transcribed and compared with the *original Record* of the EXCHEQUER in the *Chief Remembrancer's Office*.

The *Sterling Money* is distinguished all along from the *Irish*: and in reducing *Irish Money* to *Sterling*, you do no more than subtract one fourth part from the *Irish* to make it *Sterling*; thus 20 *s. Irish* make but 15 *s. Sterling*.

There are a few *Taxations* set down to some *Living*s here, which are not charged in the *King's Books*; but these may be easily distinguished, being enclosed within these Marks () and are found in a *Manuscript Copy* of the *First-Fruits* in the *Library* of *Trinity-College, Dublin*; except two *Valuations*, which have been certified from the *Office* of the *Auditor General*.

As to the *Acts* of *Parliament* concerning the *First-Fruits*, they may be easily known from the *Abridgment* of the *Ecclesiastical Statutes*. And instead of reciting them in this place, we shall add for the Satisfaction of the *Reader*, a Continuation of his Grace the Lord *Archbishop* of *Tuam's* Account; shewing how the *Fund* of *First-Fruits* settled in the Hands of *Trustees* by the *Royal Bounty* of *Queen ANNE*, and confirmed by *Act* of *Parliament* in the Reign of his late Majesty King *GEORGE*, hath been hitherto applied

applied to the good Uses for which it was given. And here we ought not to forget, that the *right reverend Bench of Bishops* in 1726, for the further Encouragement of the same pious Design, finding the *Money* arising from this *Fund*, insufficient to answer the *Necessities* of the *Church*, (in several Parts of this *Kingdom*, where *Residentary Houses* and *Glebes* were wanting) have very liberally augmented the same, out of their *private Bounty* by Subscription, which was also much increased by the generous *Contributions* of the *Clergy*.

If the *Reader* desires to be informed of the Nature of *First-Fruits* and *Twentieth Parts*; it may suffice to know, that as the Law stood in the former part of the Reign of *Queen ANNE*, every Arch-Bishop, Bishop, Dean, Arch-Deacon, Dignitary, Prebendary, Rector and Vicar, at his first coming into such his Ecclesiastical Promotion or Benefice respectively, was obliged within a certain time, to pay to the Crown one Year's value of such his Promotion or Benefice, not according to the real Worth of it at that time, but according to a *Taxation* long before made and lying upon Record; saving only and excepting such Rectories that do not exceed 5*l.* and Vicarages that do not exceed 6*l.* 13*s.* 4*d.* according to the said *Taxation*; and this Year's Value so to be paid, was called by the name of *First-Fruits*.

Moreover, every such Promotion and Benefice stood lyable to the yearly Payment of one twentieth part of what it was valued at in the above-mentioned *Taxation*, excepting only the first Year of Incumbency, for which the *First-Fruits* were supposed to be paid; and this yearly Payment was usually called by no other Name but the *twentieth Parts*.

Queen ANNE taking into her Princely Consideration, the low Condition of this poor Church of *Ireland*, the Smallness of the Maintenance which, in many Parts thereof, is left for the Parochial-Clergy, together with the Difficulty or rather Impossibility of their residing upon their respective *Cures* for want of Glebes; and the ruinous State of most of the Parish Churches, in the Country-Parishes, which the Inhabitants, by reason of their Poverty, are not able (generally speaking) to rebuild; was pleased by her Letters Patents, bearing date the seventh day of *February*, in the tenth Year of her Reign, for herself and her Successors, to give and grant unto certain *Trustees*, in the said Letters Patents named or mentioned, all and all manner of *First-Fruits*, payable out of all Ecclesiastical Promotions and Benefices; a Sum amounting

amounting to 400 *l. per annum*, or thereabouts; to be applied by them, as they shall find to be most expedient, in building and repairing of Churches, the purchasing of Glebes where they are wanting, and of Improvements, wherever the Benefice is not sufficient for the liberal Maintenance of the Clergyman having Cure of Souls.

And by other Letters Patents of the same Date, she was also pleased, for herself and her Successors, for ever to release and forgive the yearly *twentieth Parts*, to the Payment of which, the Arch-Bishops, Bishops and Clergy were before liable; a *Fund* that amounted to the Sum of 561 *l. 0 s. 8 d. $\frac{3}{4}$ q.* or thereabouts one Year with another, as it has been computed. Both which Letters Patents are ratified and confirmed by an *Act of Parliament* made in the second Year of his late Majesty King GEORGE. And in the tenth Year of the same Reign, an *Act* passed for constituting the *Trustees*, a *Body Politick and Corporate*, by the Name of the *Trustees and Commissioners of the First-Fruits*, &c. from the 25th of *March 1724*.

For the better and more regular Management of the *Fund of First-Fruits*, in pursuance of the pious Design of the Donation, the *Trustees* found it necessary to appoint three standing Officers; which was done in *May 1712*, and are still continued.

The principal one was a *Treasurer*, whose Business it should be to receive the Money from time to time, to be paid in by the Clerk of the *First-Fruits*, and to disburse the same according to the Orders and Directions of the Board; as also to treat with the several Persons who at any time should be willing to sell Improvements Tythes, or Land for a Glebe, and to advise with Lawyers about the Validity of their respective Titles, and proper Draughts of Deeds of Conveyance to be perfected by them, according to their several Circumstances; and generally to have a prudent Inspection over every thing of that Nature; that no Purchase might be made but at a reasonable Rate, and upon a sure Foundation. Which Office was freely undertaken by the Right Hon. *Marmaduke Coghill*, Esq; till his Decease, being one of the *Trustees*, without any other Profit or Emolument to himself, but only the Satisfaction of bestowing his Care and Pains in so good a Work: and this Office is still executed by a *most excellent Prelate*, upon the same Foot.

The next Officer was that of a *Secretary*, at 40 *l. per annum*, whose Business it should be to keep a Register of all the Orders of
the

the Board and Resolutions of Committees, which from time to time should be made; and to be under the Direction of the Board, and also of the *Treasurer*; to attend upon Lawyers with their Fees; to employ Clerks for the Engrossment of Deeds; to compare the Deeds when so engrossed; to lay out such Money as the *Treasurer* should direct for Stationary-ware or any other contingent Charges; and once a Year to make up an Account with the Clerk of the *First-Fruits*, through whose Hands the whole *Fund* must necessarily pass.

The third Officer which was thought necessary to be established, was that of a *Messenger*, at 10*l. per annum*, to summon the Trustees to the Board, or to a Committee, and there to give due Attendance for the doing of what is usually incumbent upon an Officer of that sort.

In 1725, several *Rules* were made for regulating the Disposal of this *Fund*, which were afterwards partly altered, and the following ones were made the standing *Orders* of this *Board*.

Rules to be observed in augmenting poor Livings.

I. **T**HAT when any proposal shall be made, for the Augmentation of any Benefice, the Bishop shall be desired to certify the Value of such Benefice; and whether any, and what Benefice has usually been held with it, and for what reason they are, or ought to be separated; if some other Benefice commonly
went

went with it ; as also whether it is, or may probably soon be in the Bishop's power, to give it some Assistance, without troubling the Trustees about it.

II. That no Living be augmented without a prospect of procuring Personal Residence upon it.

III. That where any Person applies for Encouragement, to build a Parsonage-House, he shall at the same time, get the Bishop to certify his Approbation, the Quantity of the Glebe, and what sort of House and Improvements are designed.

IV. That the Sum be not anticipated, but upon extraordinary Occasions to be approved of by nine of this Board.

V. That whenever the Fund is out of Debt, notice be given to the several Arch-Bishops and Bishops.

VI. That no more than 100*l.* be given by the Trustees for the purchase of any one Glebe, except where a convenient Purchase offers, and the Trustees by keeping the Glebe in their Hands, can in a reasonable time reimburse the Money advanced above 100*l.* without taking any Interest.

VII. That no more than 150*l.* be given by the Trustees for the Purchase of any Tythes, except where a convenient Purchase offers, and the Trustees by keeping the Tythes in their Hands, can in a reasonable time be reimbursed the Money advanced above 150*l.* without taking any Interest.

VIII. That no Glebe be purchased for any Living exceeding 200*l. per annum.*

IX. That no Tythes be purchased for any Living exceeding 100*l. per annum.*

X. That an Encouragement not exceeding 100*l.* may be given towards building a Parsonage House, where there is a convenient Glebe, and where the Living doth not exceed 100*l. per annum.*

XI. That a Sum not exceeding 50*l.* may be given, towards reducing part of a Fee Farm-Rent of a Glebe, to be granted where the Living doth not exceed 100*l. per annum.*

XII. That for the Value of any Living, the Bishop's Certificate shall be depended upon.

XIII. That no Glebe be purchased, or Assistance given towards reducing a Fee-Farm Rent, without sufficient care being taken that a Parsonage-House be built on such Glebe.

XIV. That

XIV. That *cæteris paribus*, the augmenting a Benefice with greater Cure, be preferred to the augmenting one with less Cure; and the procuring a Glebe be preferred to the buying of Tythes.

XV. That where several Proposals are thought in themselves reasonable, such Proposals shall be first accepted, where any Persons offer to advance a Sum equal to, or greater than what the Trustees give.

XVI. That these Rules shall not be altered, unless by a Board of Seventeen of the Trustees at least; and that a Copy of these Rules be given to every one of the Trustees of this Board.

The PROGRESS which the *Trustees* have already made in purchasing *Glebes*, *Improprate Tythes*, and assisting poor *Vicars* in building *Houses*, may be seen at one View in the following Tables.

Authentick Rules and Directions to be observed in all Applications for the Union and Division of Parishes, and for removing the Scite of Parish-Churches by Act of Council.

WH E R E an Union shall be proposed to be made of two or more Parishes, or Parts of Parishes; or of a Benefice with Cure, to a Dignity or Prebend without a Cure; or of a Benefice without a Cure, to a Dignity or Prebend with Cure; the Parties praying such Union, are to produce and lay before the Council, or a Committee of Council appointed for that purpose.

I. The Advice and Approbation of the Arch-Bishop of the Province, and Bishop of the Diocess, certified under their respective Hands, and Archiepiscopal and Episcopal Seals; in which Certificates they are to set forth the Grounds and Reasons of their said Advice; and the Arch-Bishop or Bishop of the Diocess is to certify the respective yearly Value of the severall Benefices, Parishes, and Parts of Parishes, proposed to be united, and whether the severall Inhabitants will be better accomodated by such Union, and in what respects. He is likewise to certify the Distance of the most remote Part of the Union proposed, from that Church which is to be the Parish-Church of the said Union. And lastly, he is to signify whether any of the Parishes, or Parts of Parishes, prayed to be united, are part of any Union heretofore made, pursuant to an Act of the 14th and 15th of King Charles II. for the real Union and Division of Parishes; and if so, whether such united Parish-Church be more than three Country Miles, distant from some Part of such united Parish; or whether it lies in a City, or Town Corporate; or be too little for the Protestant Inhabitants.

II. The Consent of the respective Patrons, and Incumbents of every such Benefice, Dignity, and Parish, the whole or any Part whereof is to be united, certified under their respective Hands and Seals, attested by two credible Witnessses; Proof whereof must be made upon Oath, before the Council or Committee as aforesaid, by one of the subscribing Witnessses, or by some other credible Person, who saw the Certificates of the said Consents perfected.

III. If in any one or more Parishes proposed to be united, there is an Appropriate or Improprate Rectory, with a Vicarage

endowed; or if the whole Parish to be united, is Appropriated, or Impropriated, and no Vicarage endowed (the Cure thereof being supported by a Stipend or Sallary) in every such Case, a joint Return must be made, by the mutual Consent of all Parties concerned, of the respective yearly Value of every such Appropriate, or Impropriate Rectory, or Parish; that the rateable Share or Proportion, which the said Appropriators or Impropriators are to pay respectively, toward the Repair of the Chancel, or Support of the Cure of such united Church, or Benefice, may be finally settled and adjusted.

IV. Where one entire Parish is to be divided into two or more (besides the Consents afore-mentioned) there must be Proof made upon Oath, before the Council, of the respective yearly Value of the new to be erected Parishes, and of their Distance, in the remotest Parts, from the respective Parish-Churches, to be appointed for each of them.

V. Where there are distinct Patrons of the several Benefices, or Parishes proposed to be united; in order to settle their several Turns of Presentation, it will be proper to make a joint Return of the respective Value of the said several Parishes and Benefices, by the mutual Agreement of all the said Patrons, certified under their Hands and Seals, and to be proved as mentioned in the second Article.

Where the Scite of a Parish-Church is to be changed, and a new one erected in a more convenient Place, the Parties desiring the same, are to produce before the Council, or a Committee appointed for that Purpose as aforesaid.

I. The Advice and Approbation of the Arch Bishop and Bishop, with the Grounds and Reasons of their Advice to be certified, as before directed in the first Article.

II. The Consent of the Patron to be certified and approved, as before mentioned in the second Article.

III. The Consent of the Proprietor of the Ground, whereon such new Church is to be erected, to be proved by exhibiting the original Deed, whereby the said Ground is conveyed for that purpose; which Deed must be proved by the Oath of one of the subscribing Witnesses, or some other credible Person who saw the same perfected.

IV. The

IV. The Consent of the Ineumbent, Church-Wardens, and major Part of the Protestant Inhabitants, in Vestry assembled, testified by their Petition to the chief Governor or chief Governors and Council, which Petition must be signed by the said Incumbent, Church-Wardens, and Inhabitants; and Notice must be given of the said Vestry, and the Design of calling the same, two *Sundays* successively, in the Parish-Church, if there be one; and if there be no Church, the like Notice must be posted up in the next Market Town, fourteen Days before the Meeting thereof; of which Signing and Notice so given, Proof must be made upon Oath before the Council, or the Committee by them appointed, by one or more credible Witness or Witnesses.

V. The Consent of the Proprietors (or major Part of them) of the Lands within such Parish, testified in like manner, by their Petition to the chief Governor or chief Governors and Council, signed by them or their Agents duly authorised; of which Signing and the Persons so Signing, or the major Part of the Proprietors of the Lands within such Parish, Proof must be made upon Oath, before the said Council or Committee, by one or more credible Witness or Witnesses.
