EXTRACTS FROM THE MINUTES OF THE PROGRAMME COMMITTEE London, June 30, 1927.

- Pamphlet No. 51. It was decided that Dr. Garvie, Bishop Brent and the Corresponding Secretary should prepare, as a separate document, the draft rules of procedure and the proposed standing orders for the Conference, for submission to the Continuation Committee at Lausanne and eventually to the Conference itself; that there should be a further session at Lausanne of the Programme Committee to perfect the proposals with regard to the work of sections; and that meanwhile the contents of pamphlet No. 51 should not be generally circulated.
- Pamphlet No. 52. It was decided that the Material appended to pamphlet No. 47 should be printed as a separate document, with the title "Material prepared by the Subjects Committee by the instructions of the Continuation Committee," and with a foreword consisting of a sentence from the minutes of the Continuation Committee, Berne, August 25, 1926, as follows : — "The propositions presented are not to be considered as in any sense expressive of official judgments or final conclusions, but simply as suggestive of questions which must naturally arise in any thorough consideration of the general subject."
