Your 2014–2015 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, the school may ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information the financial aid administrator will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the school. The school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

B. Dependent Student's Family Information:

C. Dependent Student's Income Information to Be Verified:

1. TAX RETURN FILERS - Complete this section if you filed or will file a 2013 income tax return with the IRS.

Note: If you filed or will file an amended 2013 IRS tax return, you must contact the financial aid administrator at your school before completing this INCOME section. ***The best way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. - ☐ You are unable or choose not to use the IRS Data Retrieval Tool in FAFSA on the Web, and will make available to the school a **2013 IRS tax return transcript** (not a photocopy of the income tax return).

If unable to use the IRS Data Retrieval Tool, then you will need to make an IRS tax return transcript available to your school. To obtain an IRS tax return transcript either (1) complete a Tax Return Transcript Request Form (provided by your school), (2) go to www.irs.gov and click on the "Order a Return or Account Transcript" link, or (3) call 1-800-908-9946. Make sure to request the "IRS tax return transcript." You will need your Social Security Number, date of birth, and the address on file with the IRS (normally the address used when your 2013 IRS tax return was filed).

1. **TAX RETURN FILERS - Important Note:** If your parent(s) filed, or will file, an amended 2013 IRS tax return you must contact the financial aid administrator at your school before completing this INCOME section. ***The best way to verify income is by using the IRS Data Retrieval Tool on FAFSA on the Web.
