TAX RETURN FILERS - Important Note:** If your parent(s) filed, or will file, an amended 2015 IRS tax return you must contact the financial aid administrator at your school before completing this INCOME section. ***The best way to verify income is by using the IRS Data Retrieval Tool on FAFSA on the Web.
