

**THIRD ADDENDUM TO AND EXTENSION OF

This Third Addendum and Extension is by and between OSCEOLA COUNTY, THE CITY OF KISSIMMEE, THE CITY OF ST. CLOUD, THE OSCEOLA COUNTY SCHOOL BOARD and OSCEOLA LEGISLATIVE EFFORT, INC., and is to that certain Agreement between the parties dated February 11, 2000, amended November 21, 2001, and January 26, 2004, hereinafter referred to as "the Agreement." The Parties, in exchange for the mutual covenants contained herein and in the Agreement, agree as follows:


1. This Third Addendum expressly modifies the Agreement and, in the event of a conflict, the terms and conditions of this Third Addendum shall prevail.

4. All other terms and conditions set forth in the Agreement shall remain in full force and effect and unchanged as agreed to by the parties.



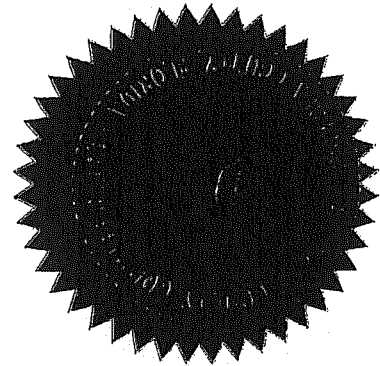


