Ground for Recall: On multiple occasions, Greg Stokes has either failed to disclose his interests in oil and gas (O&G), represent his ward's interests, address citizen's concerns (even after the 80,000 gallon January 2017 Anadarko mishap), and used his office to promote O&G to the detriment of Broomfield's health, safety, property values, and tax revenue. Critical O&G decisions prior to this November's election will have 30-year negative consequences on Broomfield's tax base with negligible benefits. Moreover, Stokes' decisions have been wrong. His recall will prevent him from continuing to pursue his personal agenda through November.

In August 2013, Stokes superseded citizens by legally binding Broomfield, via the Sovereign O&G MOU, while residents had a 5-year moratorium on the November 2013 ballot, which passed. The MOU process is preferred by the operator; the agreement could have been delayed. Regardless, a 2014 legal decision ruled this MOU exempt from the moratorium. Extraction O&G acquired Sovereign's interests; today it's using that contract against Broomfield.

In 2016, Stokes failed to support O&G local control, failed to limit new wells in the amended Extraction MOU, and blames state regulations; however, he fails to pursue viable legal options that would reduce 139 proposed wells to 24 maximum.
