Amendment No. 1: Clarification of the
Judiciary's Role in Impeachment Proceedings
Amendment

Summary of Purpose: Clarifying that courts
have no authority or jurisdiction to intercede or
intervene in or interfere with impeachment
proceedings of the House of Delegates or the
Senate; and specifying that a judgment rendered
by the Senate following an impeachment trial is
not reviewable by any court of this state.

valorem property taxation by general law.
