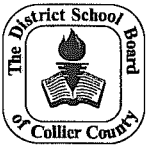

Dear Dr. Wright:

I welcome the opportunity to propose a renewal of the representation of the Collier County School District relative to governmental and legislative affairs through the 2007 Florida Legislative session. This agreement will focus on:

- Coordination with designated Board members and staff in the preparation and communication of the School Board's legislative program for 2006 and 2007, both federal and state, for School Board approval and dissemination, including presentation to the Collier County Legislative Delegation;
- Periodic written and verbal reports as requested and scheduled for Board Members and staff;
- Distribution of "FYI's" from sources available to SCGI concerning state and federal issues to the district (Superintendent or designee) on a routine basis;
- Arrangement of meetings as requested by Board Members and staff with individual legislators in Tallahassee during the session and pre-session committee meetings; and
- Wrap-up session on results of the 2006 and 2007 regular Florida sessions and as well as Congressional results for 2005 and 2006.

In turn, the District would continue to provide:

- Designated point-of-contact to be responsible to copy and disseminate documents and FYI's to School Board Members and/or appropriate staff;
- Directory of key staff (phone/email) and after-hours contact numbers for possible use during the session;
- Ability to analyze and provide feedback (immediate during the session) on impact to the district of specific bills and appropriations proposals; and
- "heads-up" on any issue(s) in which you or the School Board have a specific concern or interest.

As President and Consultant of Schoolhouse Consulting Group, Inc. (SCGI), I will continue to have primary responsibility for this engagement and will serve as your registered lobbyist for the legislative and executive branches in Tallahassee. The charge for the proposed services will continue at \$24,900 per fiscal year, payable each fiscal year in two equal installments due in July, 2005 and 2006, and January, 2006 and 2007. This agreement's term is July 1, 2005, through June 30, 2007, and may be terminated by either party within the terms of the District School Board of Collier County Educational Consultant's Services Agreement (#31101, rev. 7/2002). It is my understanding that any additional services, fees or other changes can be proposed or requested at any point upon mutual consent, but will require School Board action..
