In accordance with Article 1, Section 24 of the Florida Constitution and Chapter 119 of the Florida Statutes I would appreciate your complete and accurate response to my request for the following public records:

A copy of the current health insurance policy under which Palm Beach County School Board employees are covered, including the master agreement and subordinate agreements.

All non-exempt information (i.e. names, addresses, employment status, job title, age, gender and telephone number) for all persons covered under any health insurance plans provided by the Palm Beach County School Board, including dependents of School Board employees covered under the plan.

Please provide the information requested in electronic format (i.e. Excel spreadsheet, .txt file, etc.) if available. Should you deny this request, please provide the statutory basis for the denial, including the citation as required by F.S 119.07(1)(e).

Also, please find attached a copy of a judicial order regarding an identical request. You will note that in **Joel Chandler vs The School Board of Polk County and Gail F. McKinzie, The Superintendent of Schools** the court found that I was in fact entitled to the requested public records and my attorney's fees in bringing that suit. I am making the same public records request of you now. Please govern yourself accordingly.
