Participating teachers will also receive elementary training as Adjudicators and Scrutineers, and be licensed as Dance Teachers at the appropriate level, depending on the level of Congress they are attending.

License is recognized by the National Dance Teachers Council for use within DepED or CHED systems only. Commercial Licensing is available only under strict training and assessment guidelines.
