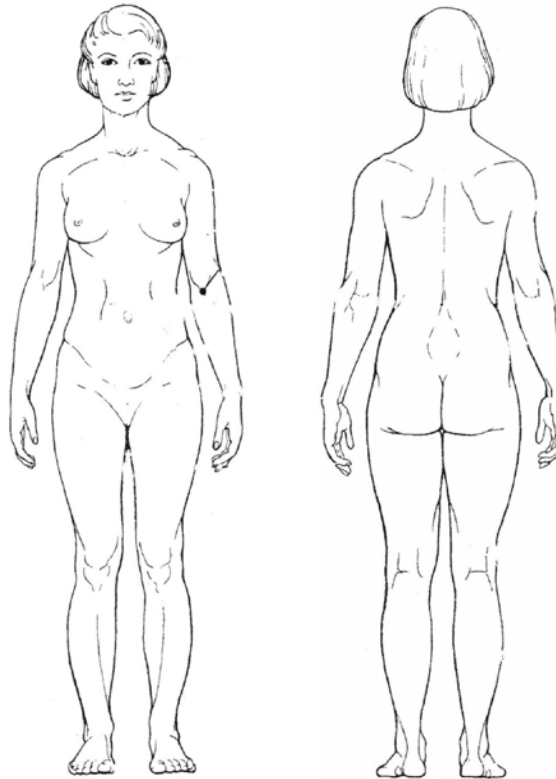

Emil Vodder (1896 – 1986)		F - Described the technique of deep transverse friction to break up adhesions and bring circulation to lesions/ injuries. Created the first comprehensive system for soft-tissue diagnosis which utilised AROM, PROM, resisted muscle testing and palpation.
Janet Travell (1902 – 1997)		G - Used the knowledge of the circulation of blood & lymph to develop a system of therapeutic movements & massage. Was a major influence on physicians throughout Europe & Russia.
James Cyriax (1940 – 1950)		H - Wrote many books & articles that helped to popularize massage in the USA.
