NEBRASKA LEGAL PROFESSIONALS ASSOCIATION SCHOLARSHIP ANNOUNCEMENT

This year, the Nebraska Legal Professionals Association will award its 14th annual \$1,250 scholarship to a Nebraska high school or college student who wishes to further his or her education in law or the legal support field at an institution of higher education and who carries a cumulative 2.5 GPA (on a 4.0 scale). We also award a second-place scholarship of \$750. An alternate candidate is also chosen.

All applications must be postmarked on or before March 31, 2012. All applicants must be enrolled full-time in pre-law, paralegal, legal secretarial, criminal justice, or any law-related program. A check for \$625 for the first-place winner and a check for \$375 for the second-place winner will be issued to the institution each semester after verifying the students are full-time and taking the required classes. If the first-place winner, for any reason, withdraws from school or does not meet the class criteria mentioned above, we will forward the first-place scholarship award to the second-place winner. The second-place winner's scholarship award will then be forwarded to the alternate candidate.

Please post the enclosed announcement in a prominent place and possibly even initiate contact with any student you think would meet our criteria. Feel free to photocopy as many application forms as you and your students may need.

Its members share a common interest in promoting continuing professionalism in the legal field. There will be a \$1,250.00 scholarship for first place and \$750.00 scholarship for second place. All applicants must be enrolled full-time in pre-law, paralegal, legal secretarial, criminal justice or a law-related program. There shall be a first and second place winner and an alternate winner. A check for \$625.00 for the first place recipient and a check for \$375.00 for the second place winner will be issued to the institution each semester after verifying the student is still enrolled and taking the required classes. If the first-place winner is unable to accept the first place award, the award shall go to the second place winner. If the second-place winner is unable to accept the second-place award, or moves up to accept the first-place award, the second-place award shall go to the alternate.
