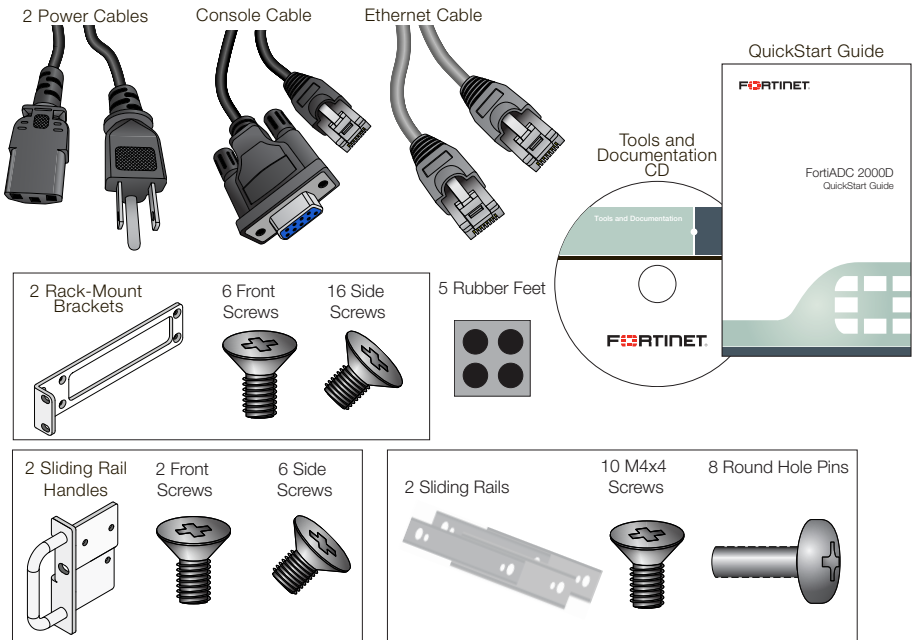
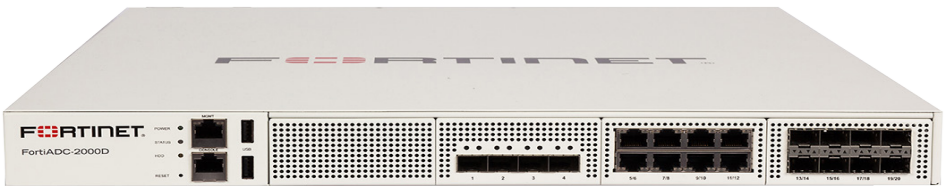

Rack mounting

FortiADC appliances should be installed in a restricted access location such as a locked data center to ensure their physical security, which is fundamental to your network security.

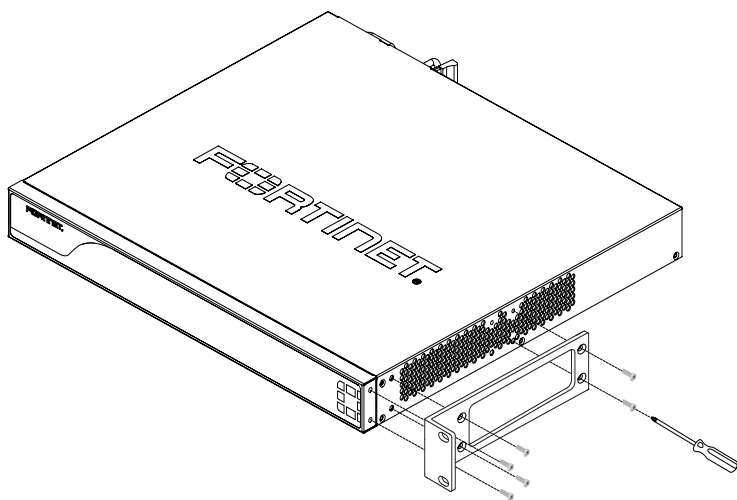
Place the appliance on a flat surface, or mount it in any standard 19 inch (48.3 cm) rack. In a rack, the appliance occupies 1U (1.77 inches/4.45 cm).

You can use rack-mount brackets or sliding rails, according to your requirements. Rack-mount kits for each type are included in your shipment.

Note: We recommend using the sliding rails when the rack does not have trays available or when there are no other units below the FortiADC unit in the rack. In these cases, the rails are a better option to accommodate the unit's weight.

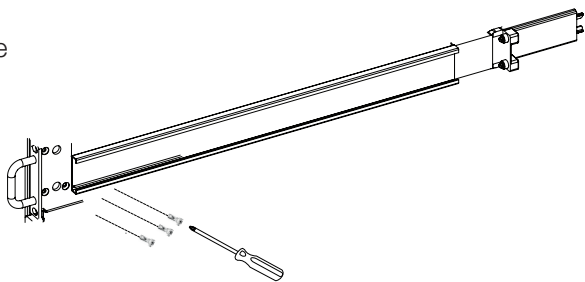
Rack-mount brackets

- **2-post rack:** Attach the rack-mount brackets to the **middle** of each side of appliance so that its weight is distributed evenly.
- **4-post rack:** Attach the rack-mount brackets to the **front** of each side of the appliance with flanges facing outwards, towards the notches in the rack.

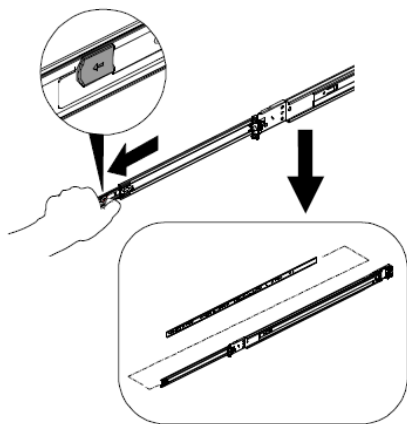


Sliding rails

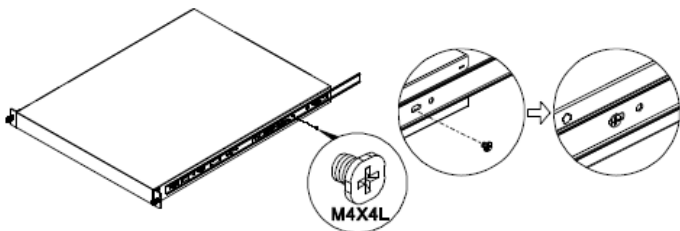
- 1. Optional. Attach the handle to the inner rail assembly.



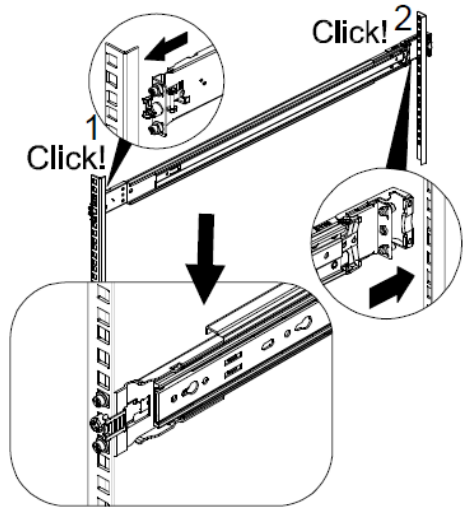
- 2. Release and detach the inner member from the slide.



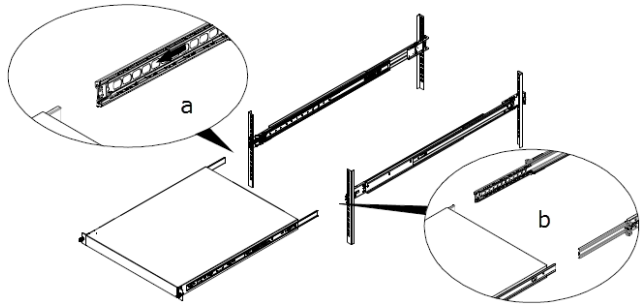
- 3. Attach the inner member to the appliance.



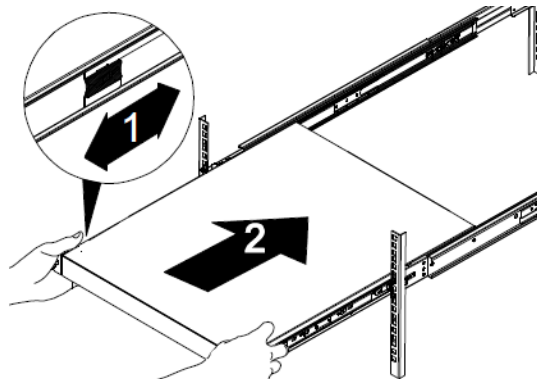
4. Attach the outer member to the rack.



5. Install the appliance into the rack:
- a. Verify the ball bearing retainer is locked forward.
 - b. Install the system half-way into the slide rail.



6. Slide the release tab and push the system into the rack.

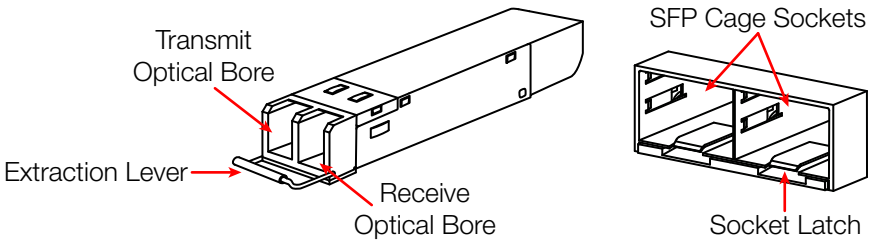


Installing SFP transceivers

If not already installed, install the transceivers that will be used to connect your appliance to the network.

Caution: Do not install or remove transceivers while fiber-optic cables are still attached. This can cause damage to the cables, cable connectors, and optical interfaces. It may also prevent the transceiver from latching correctly into the socket.

Note: Installing and removing transceivers can shorten their life. Do not install or remove transceivers more than is necessary.



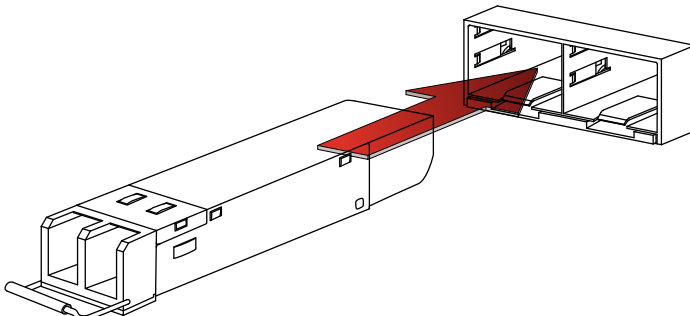
To install the transceivers

1. On the appliance front panel, remove the caps from the cage sockets.
2. Position the transceiver in front of the cage socket so that the extraction lever is level with the socket latch.

Note: Cage socket orientation may vary. Ensure that the transceiver module is correctly oriented.

3. Holding the sides of the transceiver, gently slide it into the cage socket.

Caution: Do not force transceivers into cage slots. Force can cause damage. If the transceiver does not easily slide in and click into place, it may not be aligned correctly or may be upside down. If this happens, remove the transceiver, realign or rotate it, and try again.



4. Press the transceiver firmly into the cage socket with your thumb until it clicks, indicating that it is latched.

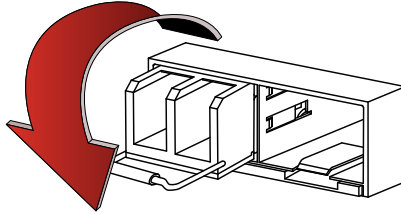
5. To verify that the transceiver is latched, grasp its sides and try to pull it out **without** lowering the extraction lever.

If you can remove the transceiver, it was **not** latched correctly, and could become accidentally dislodged. Try again.

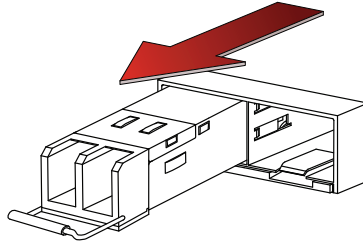
To remove the transceivers

1. Disconnect the fiber optic cable from the transceiver connector.
2. To prevent dust from entering the optical bores, insert clean plugs.
3. To eject the transceiver, pull the extraction lever out and down.

Tip: Instead of using your finger, try a small flat-head screwdriver.



4. Hold the sides of the transceiver and carefully pull it from the cage socket.



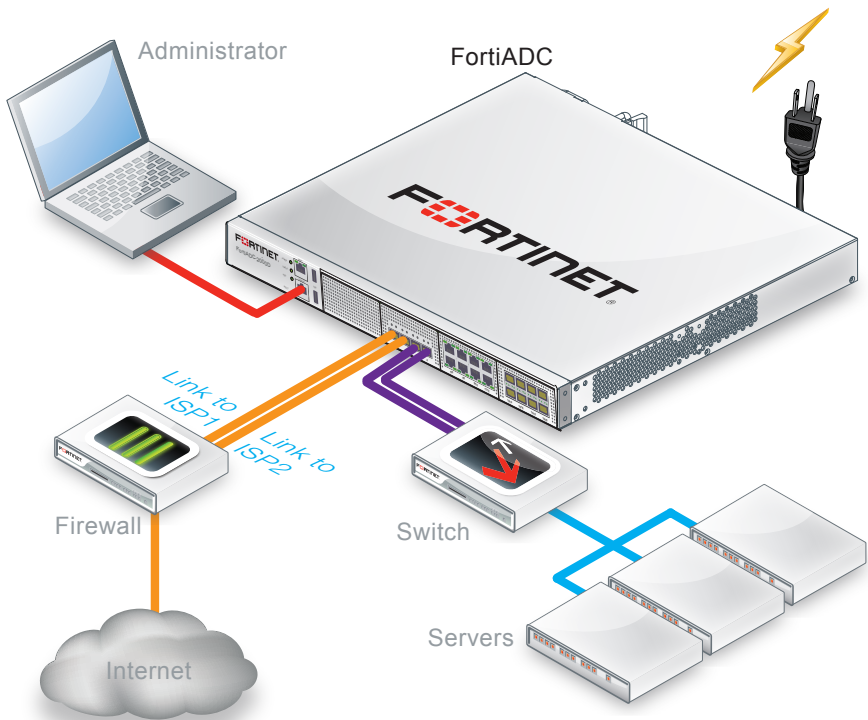
5. Replace the cap on the cage socket.
6. Put the removed transceiver into an anti-static bag.

Connecting to FortiADC

If the appliance has a redundant power supply, connect each power cable to a different power source.

You can configure FortiADC for your network through a connection to either its web UI or command line interface (CLI).

Connect FortiADC only to your computer until you finish setup. (If you place FortiADC in your network before FortiADC is set up, traffic could be interrupted until setup is complete.) **Deployment instructions are in the [FortiADC Handbook](#).** One typical, basic network topology is shown below.



To connect to the web UI

Requires: Microsoft Internet Explorer 8, Mozilla Firefox 20, Apple Safari 6, or Google Chrome 20 or newer

1. Using the Ethernet cable, connect the MGMT port of the appliance to your computer.
2. Configure your computer to match the appliance's default MGMT subnet. For example, on Windows 7, go to the Control Panel Network and Sharing Center. In Local Area Connection, click the **Properties** button. Select **Internet Protocol Version 4 (TCP/IPv4)** then click its **Properties** button. Select **Use the following IP address** and set the following values:
 - IP address: 192.168.1.2
 - Subnet mask: 255.255.255.0
3. To connect to the FortiADC web UI, start a web browser and go to <https://192.168.1.99>. (Remember to include the "s" in https://.)
4. Type `admin` in the Name field, leave the Password field blank, then click **Log In**.

To connect to the CLI via serial console

Requires: Terminal emulator such as PuTTY, Tera Term, or a terminal server

1. Using the console cable, connect the appliance's console port to your terminal server or computer.
2. On your computer or terminal server, start the terminal emulator. Use these settings:
 - Baud rate: 9600
 - Data bits: 8
 - Parity: None
 - Stop bits: 1
 - Flow control: None
3. Press Enter on your keyboard to connect to the CLI.

Shutting down



Always properly shut down the FortiADC appliance's operating system before turning off the power switch or unplugging the appliance. This causes it to finish writing buffered data, and to slow and park the hard disks.

Do not unplug or switch off the FortiADC appliance before halting the operating system. Failure to shut down correctly could cause data loss and hardware problems.

To power off the appliance via the web UI

1. Go to System > Status > Dashboard.
2. In the System Information widget, click the **Shut Down** button.
The appliance becomes more quiet when it stops its hardware and operating system, indicating that it is ready for power to be disconnected.
3. Disconnect the power cable from the power supply.

To power off the appliance via the CLI

1. Either connect to the CLI using a terminal emulator, or connect to the web UI and go to the CLI Console widget.
2. Enter the following command:

```
execute shutdown
```

The appliance becomes more quiet when it stops its hardware and operating system, indicating that it is ready for power to be disconnected.

3. Disconnect the power cable from the power supply.

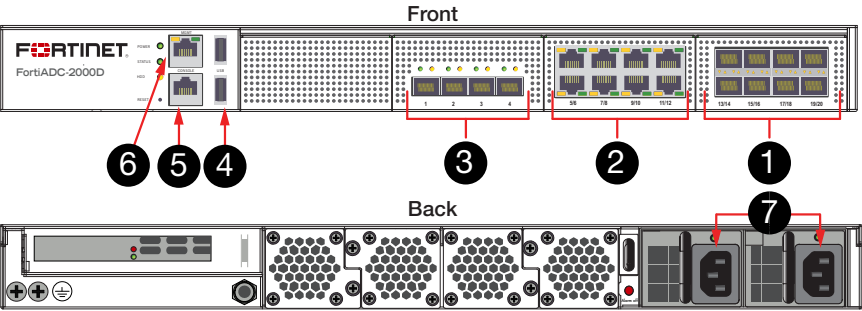

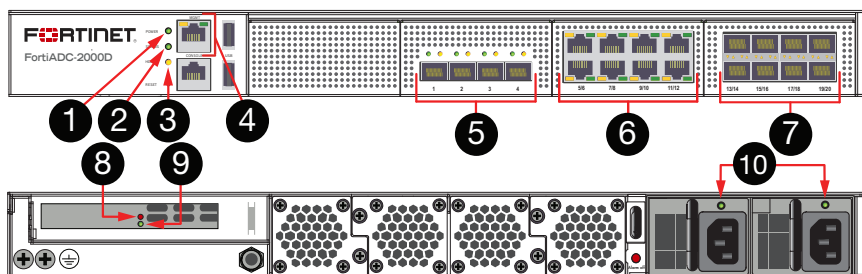

Cautions and warnings

Environmental specifications

- **Operating temperature** — If this device is installed in a closed or multi-unit rack assembly, the rack's ambient temperature may be greater than the room's ambient temperature. Make sure the rack environment is compatible with the manufacturer's maximum rated ambient temperature (Tma).

- **Air flow** — For rack installation, make sure that the amount of air flow required for safe operation of the equipment is not compromised. For free-standing installation, make sure that the appliance has at least 2 inches (5 cm) of clearance on each side to allow for adequate air flow and cooling.
Ventilation — Pour une installation dans un cabinet, assurez-vous que la ventilation nécessaire au fonctionnement de l'équipement n'est pas compromise. Pour une installation autonome, assurez-vous que l'appareil dispose d'au moins 2 pouces (5 cm) de dégagement de chaque côté pour permettre l'écoulement de l'air et un refroidissement adéquat.
- **Circuit overloading** — To avoid overloading, use the ratings on the label. Consider the equipment's connection to the supply circuit and the effect that circuit overloading might have on current protection and supply wiring. For redundant power sources, connect each to an IEC/UL Listed power source whose output rating is greater than or equal to the equipment.

- **Reliable earthing** — Make sure all rack-mounted equipment is grounded. This includes supply connections (e.g. power strips), not only direct connections to the branch circuit.

- **Interference** — If possible, use Shielded Twisted Pair (STP) Ethernet cables instead of Unshielded Twisted Pair (UTP).
Interférence — Si possible, utilisez des câbles Ethernet de paire torsadée blindée (STP) plutôt que de paire torsadée non blindée (UTP).
- **Mechanical loading** — To avoid personal injury or damage to the appliance, Fortinet recommends that 2 or more people together install the appliance into the rack. Balance the equipment to avoid uneven mechanical loading and

tipping. Do not place heavy objects on the appliance.

TERMS AND CONDITIONS FOR COPYING, DISTRIBUTION AND MODIFICATION

0. This License Agreement applies to any software library or other program which contains a notice placed by the copyright holder or other authorized party saying it may be distributed under the terms of this Lesser General Public License (also called "this License"). Each licensee is addressed as "you".

A "library" means a collection of software functions and/or data prepared so as to be conveniently linked with application programs (which use some of those functions and data) to form executables.

The "Library", below, refers to any such software library or work which has been distributed under these terms. A "work based on the Library" means either the Library or any derivative work under copyright law: that is to say, a work containing the Library or a portion of it, either verbatim or with modifications and/or translated straightforwardly into another language. (Hereinafter, translation is included without limitation in the term "modification".)

Whether this is true is especially significant if the work can be linked without the Library, or if the work is itself a library. The threshold for this to be true is not precisely defined by law.

If such an object file uses only numerical parameters, data structure layouts and accessors, and small macros and small inline functions (ten lines or less in length), then the use of the object file is unrestricted, regardless of whether it is legally a derivative work. You may not impose any further restrictions on the recipients' exercise of the rights granted herein. You are not responsible for enforcing compliance by third parties with this License.

11. If, as a consequence of a court judgment or allegation of patent infringement or for any other reason (not limited to patent issues), conditions are imposed on you (whether by court order, agreement or otherwise) that contradict the conditions of this License, they do not excuse you from the conditions of this License. If you cannot distribute so as to satisfy simultaneously your obligations under this License and any other pertinent obligations, then as a consequence you may not distribute the Library at all. For example, if a patent license would not permit royalty-free redistribution of the Library by all those who receive copies directly or indirectly through you, then the only way you could satisfy both it and this License would be to refrain entirely from distribution of the Library.
