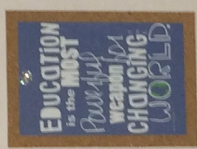
ELIGIBILITY REQUIREMENTS

- **First Year Students:** 2.0 or higher cumulative GPA on three official high school transcripts
- **Transfer Students:** 2.0 or higher cumulative GPA on 12 or more semester hours of college coursework
- **Continuing Students:** minimum cumulative 2.3 GPA on 24 or more semester hours transferred to the Office of Student Assistance

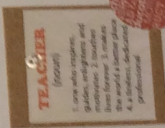
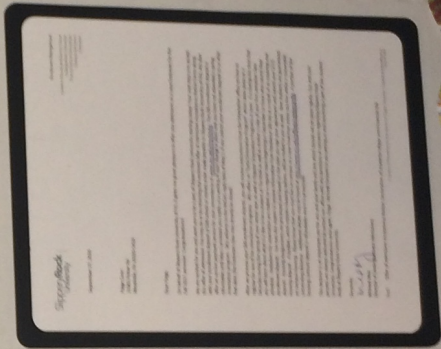

Job Outlook

Employment of human factors and ergonomics (job holders) is projected to grow by 30 percent from 2000 to 2010 as the average age of the U.S. workforce increases. Growth is expected, particularly in computer-related occupations. Human factors and ergonomics specialists will be needed to design and evaluate products, systems, and environments to optimize human performance and safety. They will be needed to develop and evaluate human-machine interfaces, such as those used in computers, telecommunications, and transportation systems. They will also be needed to design and evaluate work environments, such as those used in manufacturing and service industries.
