SUBJECT: **NCLB Administrator Technology Reporting – 2009-2010**

DATE: April 5, 2010

Administrators play a pivotal role in determining how well technology is used in our schools. The No Child Left Behind Act of 2001 (NCLB) introduced new levels of accountability tied to the federally funded programs originally authorized under the Elementary and Secondary Education Act (ESEA). The reporting requirements have been an essential part of the process for documenting progress to support continued technology funding.

## **DEADLINE**

The deadline for achieving 100% completion of Sections 1 and 3 of the NCLB Administrator Technology Reporting System is 4:30 PM on Friday, May 7, 2010. A list of campuses not complete at that time will be sent to the Area Senior Executive Directors and the Chief Information Officer for follow-up.

## **ASSESSMENT PROCESS**

All campus principals must complete SECTION 1 and SECTION 2 of the NCLB Administrator Technology Reporting System.

### **SECTION 1: NUMBER OF COMPUTERS & INTERNET CONNECTIVITY**

Section 1 will gather the number of computers and type of internet connectivity available at each campus. The USDOE now requires that the report is collected by campus; therefore Section 1 will be completed by each campus principal.

### **SECTION 3: CAMPUS PRINCIPAL TECHNOLOGY SELF-ASSESSMENT**

Section 3 will measure each campus principal's level of practice for technology through a Campus Administrator Technology Literacy Self-Assessment based upon the 5 standards from the ISTE Technology Standards for School Administrators (NETS 2009). Individual administrator assessment data will be held confidential.

## **BACKGROUND INFORMATION**

The past few years, additional data at the district level has been requested for districts receiving Title II, Part D funds. Districts receiving Title II Part D funding are required to report this additional data annually.

The Texas Education Agency (TEA) is now charged with collecting data regarding district achievement of these expectations. The additional reporting requirements consist of three

sections. The second section will be completed by the district contact identified as the district's Texas STaR Chart lead person and the first and third sections will be completed by each campus principal.

## **ABOUT NATIONAL EDUCATIONAL TECHNOLOGY STANDARDS (NETS) FOR ADMINISTRATORS**

The Technology Standards for School Administrators enable us to define what administrators need to know and be able to do in order to discharge their responsibility as leaders in the effective use of technology in our schools. The NETS can be found online at <http://bit.ly/netsadmin>. These standards are indicators of effective leadership for technology in schools.
