Letter from the Chair

Well, another year gone by and more advancement for liberty in Colorado. We have plenty of good things to report so let's get started.

We increased our total membership a little less than expected over the year but that was mainly due to an unforeseen presidential candidate's race and shows that our members believe in the state organization. There are now almost 7000 registered Libertarians in the state of Colorado. We also increased our National Sustaining Members to 460 and now rank 11th in the nation (just behind Georgia).



Per capita we have the third most National Libertarian Sustaining Members of all fifty states. We have doubled our number of Lifetime Membership Donations (lifetime membership requires Donating \$1000 in a single calendar year) since the previous year. While we truly appreciate these donations we also appreciate those who contribute to the 1776 Club. That is our primary source of operating revenue and that helps keep the Party running and growing. Please consider becoming a 1776 member and if you already are please consider increasing your donation. See the website, www.lpcolorado.org, for more information on the 1776 Club.

We are gearing up for the National Convention in May. We are very excited that it will be held in Denver and are looking forward to the opportunity to showcase Colorado as a very successful Libertarian Party State Affiliate. I hope everyone can join us at the Adam's Mark Hotel in downtown Denver over Memorial Day weekend for the big event. If you haven't signed up yet then be sure to read the ad in this newsletter for more information. If you are interested in becoming a delegate to the 2008 Libertarian Party National Convention then please attend the LPCO State Convention in Ft. Collins to get elected (See the State Convention ad for more details). We have a limited size delegation to fill (32) and if we need more I know some other states would not mind seating some of our delegates (If you are not already a sustaining member to the national party now would be a good time to donate your \$25 as this is required to become a delegate).

We held TWO strategy sessions this past year and have come out of them with a good plan for 2008. We are working on introducing the majority of Ron Paul supporters to the LPCO. We always need more help in this endeavor. Get out there and talk to your neighbors, colleagues, and family members. With more people choosing liberty we need to show them the only party that can deliver it.

On a more somber note, we lost a dear activist in 2007. Dave Meleney was an extremely energetic and effective activist for liberty and a friend to many of us. He passed away on July 12. He consistently supported the LPCO and brought a smile to many of our events. He was always open to gathering signatures or handing out quizzes. If not for Dave, I would not have made it onto the ballot to fight Nancy Doty in the Baker recall election (he gathered the vast majority of required signatures). I guess you could say Dave is one of the people responsible for my being involved in the party. We miss you Dave.

On to lighter subjects, we had another successful year of outreach events and this year is shaping up to be even bigger. The Family Day BBQ and the Breast Cancer Charity Golf Tournament (we had a booth there) were new for us this past year and we are hoping to do them again this year. We are also hoping to break into the Stock Show for early 2009. In addition, we are kicking off our New Member Orientation program. I will be holding a one hour introduction seminar for all newly registered or donating members once a quarter. Watch the web site for more details.

Before all those events, however, we need to focus on the Colorado Legislature. Our Legislative Director is keeping tabs on the people in downtown Denver and we have even found some allies to help us pass some more libertarian legislation. Our new state platform (from last year's convention) has gained much attention from several of the legislators.

Lastly, we will need to fill some vacancies at the convention this year. Mr. Randall and Mr. Thompson have decided not to seek another term, Mr. Long has taken a position as our Technology Manager, and we have appointed Ms. Kelley to the position of Treasurer. If you are interested in seeking any board position please feel free to call me anytime or contact the person currently in that position.

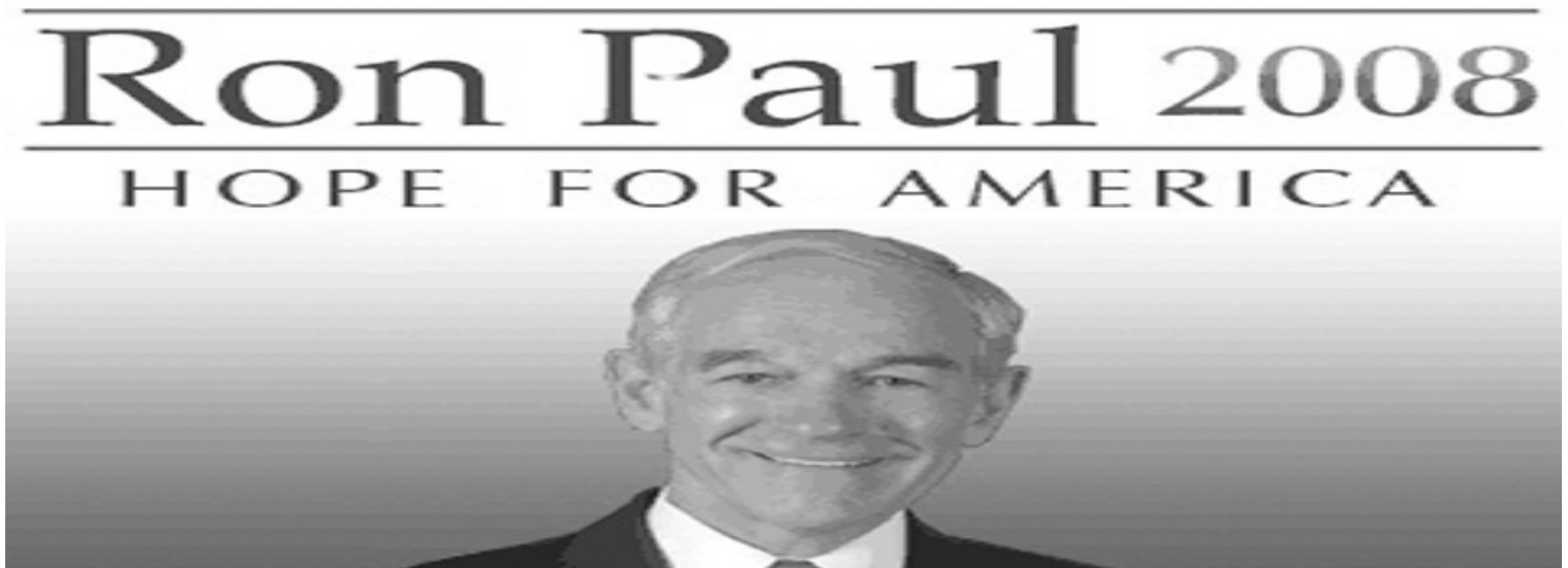
That is all for now and I will see you all in Fort Collins.

Death Penalty

According to the Colorado Department of Corrections, 78 inmates have been executed since 1890. In the past 30 years, only two have been executed. On the other hand, Texas has had nearly 400 in the past 25 years. While we are far from leading the nation in executions we should eliminate the death penalty, acknowledging that citizens do not have the right to empower the government to take the life of another human being.

Colorado courts should be examples of justice. State sponsored executions are examples of revenge. When a person is executed, justice, forgiveness and recompense for one's crimes are no longer possible. Execution, unlike imprisonment, is not reversible in the event of an error. Since 1974, 124 death row inmates over 25 states have been pardoned, had their charges dropped or been exonerated in light of evidence discovered after their sentencing. If they were sentenced to life in prison, these innocent people wouldn't have been facing their execution.

Jury Duty

The Colorado Uniform Jury Selection and Service Act mandates Coloradoans serve on a jury, or face criminal penalties. In forcing people to be a juror, the Colorado legislature has created a form of involuntary servitude. The Colorado State Constitution forbids this, stating:

"There shall never be in this state either slavery or involuntary servitude, except as punishment for crime, whereof the party shall have been duly convicted." (Art. 2, Sec. 26).

and the freedom guaranteed to Coloradoans by our Constitution.

While a trial by jury is a great asset to the United States, so is our individual freedom to choose how we live our lives. For many people, serving on a jury can cause undue hardships and potentially cost them their job. By forcing citizens to act as jurors, the principles against involuntary servitude, and the costs to an individual's livelihood, are violated. Mandatory jury service should be repealed.

Special Districts

Colorado has 31 special districts that spend big chunks of your tax money without voter oversight. Some of these districts are for fire protection and water conservation, health services and recreation districts. Surely some of these are things we have come to expect as taxpayers.

Bigger problems arise when the officials in charge of these special districts are appointed rather than elected. In many cases, those appointed then do business with the elected officials that gave them the appointment. This creates a buddy-system in politics, a practice that doesn't always have the taxpayers' best

interests in mind. As a voting taxpayer, this means that you don't have a say in how your money is spent because you haven't had a say in which officials take office, and therefore, who spends your money.

Clearly in the interests of freedom and taxation *with* representation, the officials in charge of spending your tax dollars should be elected, not appointed through a political buddy network. When elections for issues relating to these special districts are held, they should coincide with general, state or national elections, and held in familiar places during standard election hours.

Self Defense and Gun Control

Few topics elicit as passionate a debate as gun control. As it applies to individual safety and crime, Colorado is generally less restrictive than many other states and also has a generally lower crime rate. It is difficult to make a direct comparison, given the unique characteristics of each state, but areas like New York, Chicago and Washington D.C., have much higher crime rates as well as more regulations on firearm ownership.

This might sound progressive, but Colorado still could do more towards becoming the safest state in America. As statistics have shown, less restrictive gun laws lead to less crime. According to Libertarian principles, firearm possession, sale and other laws restricting the usage of this means of self defense should be repealed.

It is impossible for the police to make sure everyone is safe, all the time. Just as citizens take responsibility for their safety by buckling their seatbelts when in a car, they are responsible for their own safety against crime. Whether walking along a trail in a nearby park or locked in a home for the evening, criminals can strike at any time. A legislature that forces its citizens to rely on the police for safety does not have anyone's best interests in mind.

Specific revisions to Colorado laws include recognition of the right to self-defense and defense of one's family, property and others, including the use of deadly force if necessary, regardless of location. It is ridiculous to think that being attacked in one's home is deadlier than being attacked on a public street.

Additionally, firearms dealers should not be required to keep a database of their customers and their purchases. Intrusive paperwork, checks at gun shows and laws regarding purchase of firearms by Coloradans in other states, should also be repealed.

Marriage

In Colorado, marriage is defined as a union of one man and one woman. Legal definitions might be necessary for complicated tax schemes involving married taxpayers, but as a union of loving adults, marriage belongs in the hands of religion. It violates sections of the Colorado State Constitution for the state to have a definition of marriage. Article II, Section 4 states:

The free exercise and enjoyment of religious profession and worship, without discrimination, shall forever hereafter be guaranteed...

Having a legally restrictive definition of a religious establishment violates this section of the Colorado State Constitution. Any law seeking to define, restrict and otherwise prohibit free practice of religion should be overturned.

Most of us take for granted the legal ability to marry whomever we choose. Not everyone has that choice. However, the issue here isn't limited to marriage, but the government meddling in religious matters. Claiming the authority to regulate marriage is grounds to interfere in other aspects of religion. Given the complexities, competition and variety of religious belief systems in the United States, it is likely only a matter of time before government becomes more involved. In the interests of preserving our nation and the free practice of religion, intrusions into marriage, or any other religious beliefs, need to be stopped.

Corporate Welfare

\$71, 413,750 of Colorado's tax money was given away by the Economic Development Commission between 2001 and 2005.

In their report on 2006, \$4,593,091 was given out to businesses in Colorado.

Additionally, the Colorado Council on the Arts spent \$1,192,950 from January through August of 2007.

Practices such as these inhibit efficient business and diminish a company or organization's true service to the public. If one owned a company and was operating at maximum competitiveness and efficiency - through one's own ingenuity, having to compete against a company receiving government handouts is simply unfair. The companies given handouts are allowed to be less competitive than everyone else and still succeed. This goes completely against the

capitalist business practices that make our economy the greatest and freest in the world.

Furthermore, if a company is providing something the public wants and needs, then it would not need government bailouts and welfare. Companies, who are wasting tax money like this, are being paid by Colorado citizens to support businesses that don't necessarily serve their needs.

Government needs to be left out of private business. Free market, capitalist economics, will encourage efficiency and productivity. Companies that cannot compete will make room for those that can, and our economy will grow at a faster and stronger pace, creating more jobs, higher quality products and superior services for the public.



Annexation

One of the most blatant disregards for individual liberty facing Coloradans right now is the annexation of their homes and businesses into city property.

If the city decides it needs to expand, or wants to use a citizen's property for its own reasons, it can annex the land and make changes to it, often without the input of those who stand to lose their home or business.

Right here in Colorado, annexation issues have been in the news in Parker, Longmont, Arvada, Vail, along the construction path of E-470, and other municipalities.

While the benefits of E-470 to traffic congestion and new businesses are clear, it can sometimes come at a cost to individual property rights. When expansion encroaches onto private areas, particularly areas outside city limits, and land sales are forced, such as

the E-470 development, individual citizens are stripped of their rights, often without any legislative participation, until the annex is complete and their land is already lost.

Additionally, even in instances where the land isn't to be taken and reused for other purposes, living outside a city allows an individual the freedom to provide for their own municipal services. Once annexed, they are forced to pay whatever the tax rate is for services they were already providing for themselves, often at an increased cost.

The Colorado legislature needs to enact a law forbidding annexation without representation. When property owners can be stripped of their rights at the whim of city councils, for an ambiguously defined "common good" there is nothing preventing any of us from being forced to do the same.

Health Care Mandates

Spiraling health care costs are affecting all segments of society. As costs increase, many Coloradoans have to personally deal with these increases. To appease voters, many politicians are calling for increased employer or government sponsored medical insurance programs. But these mandates are part of the reason for the increased costs.

When government mandates employer or individual choices, competition for these choices is reduced. Without the competitive nature of free markets, prices are only going to continue to rise. Add to this the artificial demand due to the mandate, there is no incentive for medical companies to reduce costs, as their customer base is guaranteed by law.

In Colorado, our medical system includes 46 that require coverage including things like chiropractors, chiropractors and cleft palate. While medical care is important to maintaining a long and healthy life, a rational person can pursue such care without government intervention. Forbidding the individual's right to choose coverage options or no coverage at all, the government limits the sort of competition that would reduce costs. These reductions alone would allow many more affordable options to companies and individuals. As business owners are forced to cover broad health care

costs for their employees, it is common for profits to be squeezed to the last margins, sometimes forcing companies out of business. As this happens, employees that relied on their company for health care and a salary will no longer have either, causing further hardship and lack of health care coverage.

In 2002, the National Federation of Independent Businesses did a study, and found that increased health care costs are the primary concern for small businesses. In order to manage these costs, many are forced to increase co-pays and deductibles and raise the level of employee contributions, all of which decreased coverage to the minimums allowed by law.

These dramatic changes only decrease the quality of health care for Colorado citizens, and more mandates will only continue the downward spiral of medical care quality. Allowing free choice is the only way to increase quantity and quality of care.



Student Aid and the Drug War

Since the federal government passed the Higher Education Act of 1998, anyone convicted of even the most minor drug crimes is ineligible for student aid for college.

Most applicants for student aid are of high school age, trying to pursue a career and advance their life at a vulnerable time. Denying student aid for college only makes this positive progression more difficult and nearly impossible for some seriously disadvantaged students. Even the most modest of youthful experimentations could ruin a young person's chances for college, furthering the injustice of drug laws. No type of crime, violent or otherwise, is included in this requirement.

In Colorado, approximately 2,500 potential college students were denied student aid or had it revoked in the past seven years. Not included in this number is anyone who didn't request aid, presuming it would be denied.

Students would still be ineligible for federal aid because this is a federal law. However, Colorado can, and should, determine eligibility for state and private aid based on criteria that doesn't include drug convictions.

It is to Colorado's success that its citizens are able to pursue advanced educations. Dropping the drug conviction criteria is a rational and beneficial choice for Colorado.
