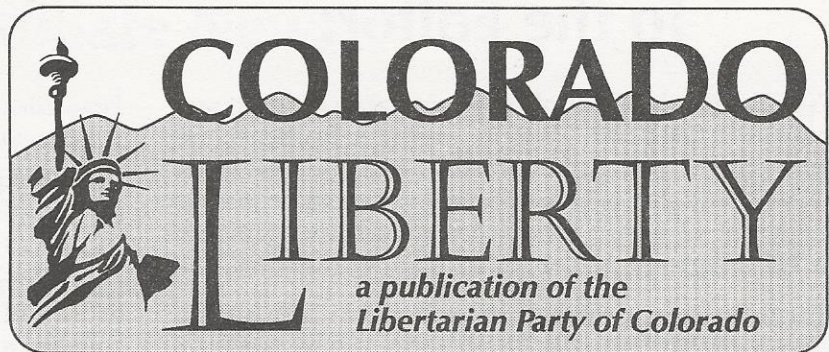

LP Condemns "High-Tech Censorship" Bill

The national Libertarian Party reacted quickly and angrily to the June 15 passage by the Senate of a telecommunications reform bill containing sweeping new censorship laws aimed at electronic communications. A June 16 press release strongly condemns the "Communications Decency Act," sponsored by Senators James Exon (D-NE) and Dan Coats (R-IN).

LP Chair Steve Dasbach described the bill as "a case of 20th-century politicians using 19th-century laws to control 21st-century technology."

The censorship amendment was added to the communications deregulation measure by an 84-16 vote of the Senate on June 14. It punishes the electronic dissemination of "obscene" and "indecent" material with fines of up to \$100,000 and prison terms of up to two years.

"Republicans and Democrats overwhelmingly lined up to support this high-tech censorship," said Dasbach. "It was bi-partisanship at its worst. Apparently there's no gridlock in Washington when it comes to gutting the First Amendment."

Dasbach dismissed Sen. Exon's claim that the measures were necessary to protect children. The marketplace is providing a growing number of ways for parents to block their children from accessing objectionable material via the Internet, and the commercial services such as America Online and Prodigy offer "lock-outs" so that parents can limit their children to certain areas of the service.

Dasbach insisted that, in any case, "parents, not Justice Department bureaucrats, should determine what children see, hear, or download. It's especially hypocritical for Republicans, who

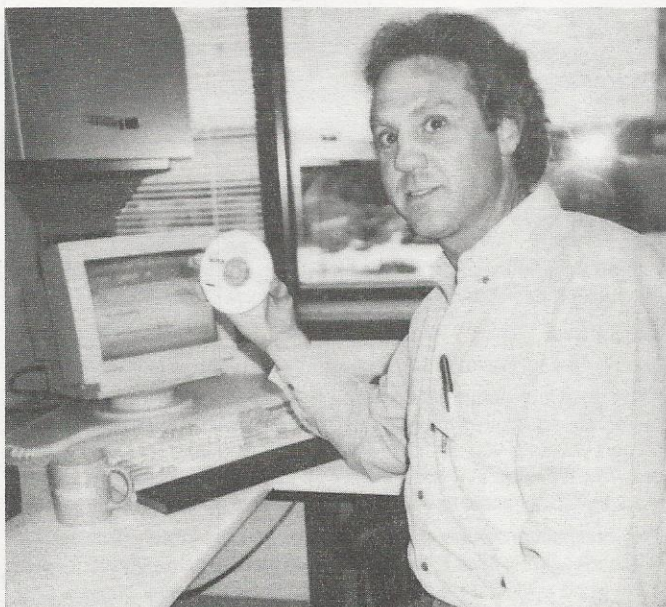

To the Editor:

It's so sad that hundreds of people, including children, were blown up in Oklahoma. It's such a tragedy, such a horror, that almost no one will see beneath the blood and gore to the greater catastrophe (and I don't say this to demean the memory of those who lost their lives) underneath—further gutting of the Bill of Rights in the name of anti-terrorism measures.

The apathy (and for some, the joy) with which our fellow citizens will give up their rights for what they perceive as safety is the third and by far the deepest tragedy of them all.

I've registered as a Libertarian every time I've registered to vote, and proclaimed myself one when asked my political affiliation, but it's sad that it takes a calamity of these proportions for me to put my money where my mouth is. Unfortunately, I fear it is a futile gesture. We both know that most people don't know that the third amendment to the Bill of Rights is the only one we'll have left in short order, and wouldn't care if they did, since they never cared what the other nine said anyway.

We also both know that both the media and the government will brand anyone who points out our continuing erosion of freedom as an extremist, as naive or misguided, or as a terrorist sympathizer. The *Rocky Mountain News* ran an article about the "Patriot" movement and lumped the libertarians right in with the militia groups that the government is blaming (and perhaps not incorrectly) for the Oklahoma City bombing. Doubtless most people don't know any better than to put us in that category also.

I once talked to this pagan girl who embraced libertarian principles, but refused to believe that Libertarians aren't a Christian conspiracy trying to establish a theocracy. When I tell people

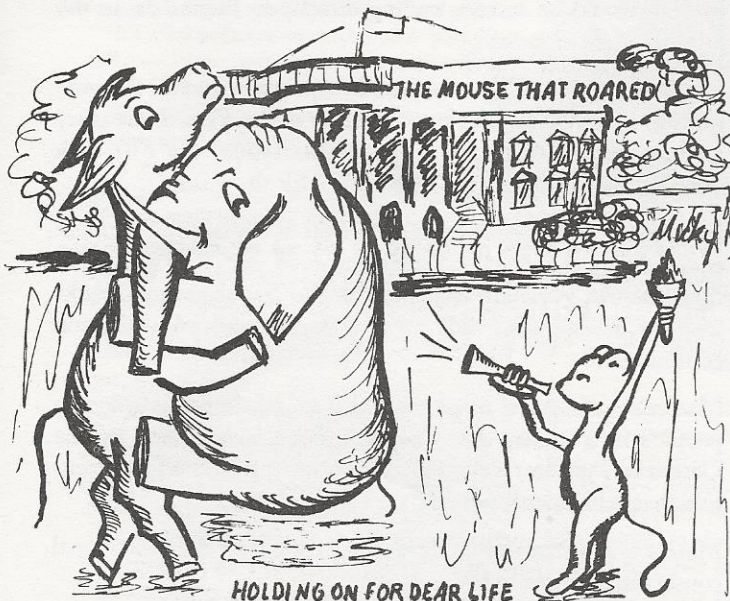

The Lost Platform Planks Have Been Found!

At the May 1995 state convention, Todd Wasserman, Ron Bain, and I were asked by the convention to serve on a committee to investigate the lost planks of the state platform. The state platform is officially defined as the national party's platform plus two planks specific to Colorado issues: water rights and the Safety Clause. But the two planks couldn't be found.

After the convention, Ron Bain found the planks in his files dated from 1987. However, we're still not sure if these are the latest versions—they may have been modified after 1987 and before being lost. It would seem prudent to consider them part of the platform for the remainder of the year and make a special point of reconsidering them at the 1996 convention.

The language that we have is as follows:

WATER

We favor the recognition of private rights to ownership of water. Any residual claims of the State to water or its use should be returned to private ownership.

As an interim measure, we advocate water user fees, rather than taxation, to finance the administration of water rights and water courts.

Public utility monopolies in the area of water storage, distribution and use must also be abolished and water as a resource returned to its proper place as a privately owned commodity in a free market. Accordingly, we call for the

bemoan other government programs which weaken the family, to vote for paternalistic laws appointing Washington bureaucrats as the family censor."

The LP is a member of an Internet coalition that has been trying to stop on-line censorship legislation. Other organizations involved include the American Civil Liberties Union, the Center for Democracy and Technology, the National Writers Union, and People for the American Way.

Contact your congressional representatives immediately and let them know that this censorship measure is completely unacceptable and mars what is otherwise a good first step toward deregulation of telecommunications.

termination of the monopoly held by the Denver Water Board and similar local government agencies elsewhere in Colorado. Since government uses tax money to finance water projects, we urge termination of such subsidized engineering jobs in Colorado as federal funded water projects and mine drainage abatement.

In addition, we oppose the exercise of federal reserve rights and interstate compacts to the detriment of any Colorado resident's water rights. To the extent that downstream water users claim the right to Colorado water, disputes should be settled through stipulation, arbitration, or litigation.

SAFETY CLAUSE

We adamantly oppose the routine attachment of a "Safety Clause" to every bill approved by the legislature.

Use of the "Safety Clause" limits or circumvents the ability of the courts or the electorate to review or reject improper or unconstitutional bills.

Retired ATF Agent Critical of Waco

Richard Mathis, a retired ATF agent, was the speaker at the Jefferson Forum on April 19. He was an agent for twenty-four years, and at retirement was the Resident Agent in Charge (RAC) of the Denver office. During those twenty-four years, he never took part in a tobacco operation and was involved with only one alcohol operation.

All the rest concerned firearms violations. One of the most common firearms violations is the crime of carrying a concealed weapon while selling controlled substances.

Mathis' subject was the ATF at Waco, and he was very critical of the way the operation was handled. He said he could have served that warrant with no loss of life on either side. The ATF disregarded their own criteria for conditions under which the warrant would be served, leading directly to the deaths in the original shoot-out.

At that point, the FBI took over the operation and all the horror that followed was the responsibility of the FBI. Same story at Ruby Ridge. After the initial confrontation, the FBI took over the operation and was responsible for the results.

Mathis has spent his entire professional life in law enforcement and clearly sees himself as one of the good guys who protect us from the bad guys. He is personable, well-spoken, good looking, knowledgeable, and quite unhappy with the Clinton administration.

Mathis stated several times that ATF agents do not infringe on people's civil rights, they simply enforce laws passed by the Congress. I got the feeling he did not understand why citizens fear that ATF agents will violate their rights.

Mathis told us the way to repair the nation is to elect additional conservative Republicans.

Paradigm Shift!

✓ **Are we seeing a historic shift in American politics towards Libertarian ideas?**

ON DECEMBER 29, 1994, President Bill Clinton said a remarkable thing. "There is a role for government in a modern society," he told the *Washington Post* in an Oval Office interview.

So what? Bill Clinton's a liberal. Of course he thinks there is a role for government.

But how long has it been since any president, liberal or conservative, felt the need to publicly champion the very *existence* of government? Not a favorite government department, or a specific policy, or the tax-increase-of-the-day — but defend, at the most *basic level imaginable*, the merits of government existing at all?

Something is happening in American politics.

It's what political scientists call a "paradigm shift" — when fundamental assumptions and beliefs undergo a profound change.

In this case, it's about the nature and role of government. A 50-year-long consensus that government can solve all our problems has been worn away by the ceaseless drip-drip-drip of higher taxes, failed programs, corrupt politicians, and arrogant bureaucrats.

The evidence of this shift is everywhere. In 1972, when the Libertarian Party first argued that numerous federal agencies should be abolished, taxes slashed, and the size of government dramatically curbed, political "experts" chortled.

Now, in 1995, American political dialogue is becoming an eerie echo of what Libertarians have been saying for years.

Here are some snapshots of this paradigm shift as Libertarian ideas enter the mainstream:

The LP Platform states: "We support the repeal of the 16th Amendment." In 1992, Andre Marrou made abolishing the IRS the centerpiece of his presidential campaign, to the cynical amusement of many reporters.

★ **June 1995:** Senator Phil Gramm calls for the "repeal of the 16th Amendment." And freshman Congressman Dick Chrysler (R-MI), on a speaking tour in May 1995, found "his biggest applause line everywhere was calling for abolition of the Internal Revenue Service."

The LP Platform states: "We oppose all government welfare . . . The proper source of help for such persons is the voluntary efforts of private groups and individuals."

★ **April 1995:** *US News & World Report* reveals: "Two-thirds of Americans believe the Salvation Army does a more effective job in providing services to the poor than the government does."

The LP's 1993 Project Healthy Choice urges: "The [FDA] should be replaced with voluntary certification by a private-sector organization."

★ **April 1995:** Congressman Ron Wyden (D-OR) urges the FDA to "accredit independent laboratories to do some of the testing that ensures therapies are safe and effective" — in effect, privatizing some of the FDA's functions.

The LP Platform states: "Pending abolition [of the government Postal Service], we call for an end to the monopoly system and for allowing free competition in all aspects of postal service."

★ **April 1995:** *Direct* magazine reports that for the first time in 12 years, calls to privatize the Post Office have reached a "serious rumble." Congressman John R. Karish (R-OH) tells industry groups "point blank that we are going to privatize the Postal service."

The LP Platform states: "We oppose all government subsidies to business."

★ **April 1995:** Democrats voice support for ending "corporate welfare" — and Republicans, surprisingly, agree. "Liberal House Democrats announced . . . they want to eliminate federal subsidies to major firms to sell their products abroad," reports the *Washington Times*. And Republican Senator Phil Gramm calls for an end to "nearly \$10 billion in SBA loan guarantees."

And the beat goes on . . .

Even the poster-boy for big-government is forced to admit that a problem exists. Mario Cuomo is quoted in the *Washington Post*, January 25, 1995: "We all know the federal government is a patient who is seriously overweight."

And the *Washington Post* itself — the house organ for bloated government — is having second thoughts. Columnist Jonathan Yardley wrote on January 2, 1995: "Liberalism isn't liberalism anymore, it's statism. The problem isn't merely that it's statism — but that it's statism that doesn't work."

EVEN CLINTON HEARS the tectonic plates of politics shifting. On January 16, 1995, Clinton said: "We know government cannot really solve problems for people . . ."

In the same breath he immediately contradicted himself, and said, ". . . but I think we know that government cannot walk away, either." But the point is made; Bill Clinton has caught the "government doesn't work" bug.

Need more evidence?

Check out the February 10, 1995 issue of *Entertainment Weekly* magazine. In a round-up of what's hot and what's not in post-Republican landslide America, they rate humorist P.J. O'Rourke "in" and humorist Dave Barry "out."

Note the significance? They're *both* libertarians. One libertarian is out; one libertarian is in. *Paradigm shift.*
