Candidates Meet the Press

CAMPAIGNS UNDERWAY

LOS ANGELES: Three top-of-the-ticket Libertarian Party candidates for statewide office held a press conference at the L.A. Press Club on March 19. Breck McKinley, running for U.S. Senate; Norma Jean Almodovar for Lieutenant Governor, and Carol Newman, for Attorney General, formally announced their candidacies to the media, then answered questions.

Norma Jean Almodovar told the press she will focus on the issues of victimless crimes and property rights. "My campaign is a commitment to personal and economic freedom," said Norma Jean, "and to individual responsibility."

In a similar vein, Carol Newman vowed that if elected she would "focus the resources of that office on the prosecution of crimes against persons and property—crimes that have victims," and declared that the goal of the justice system should be restitution to the victims of crime.

The candidates will be available to speak to various local groups around the state during the campaign, and Libertarians have a terrific chance to affect public opinion and perceptions of freedom this year—but the candidates need your help if that's to happen.

Campaign Workshops Scheduled

David Bergland, 1984 presidential candidate, is presenting a comprehensive two-day seminar/workshop for candidates, campaign managers and LP leaders to develop campaign skills. A minimum of eight, but no more than 15 participants, is required, which means the group will be large enough to cover costs but small enough to assure that participants get lots of on-camera TV experience.

That'll be April 26, 27 at a location in Los Angeles, but the exact place has not been announced as of press-time. Be sure to call David soon at (714) 751-8980 for reservations.

Tax Protests Planned

Last year, newscasters in Los Angeles commented that the tax rebellion was over because not as many protestors had shown up the the traditional midnight vigil at the downtown post office. *CLNews* is not certain what all the regions throughout the state are planning, but it has been reported that several of the L.A. County regions will be joining together at Terminal Annex. Plans are also in the works to invite a number of tax protest groups to join us as they have in past years, to send a clear message to the IRS that we're anything but finished.

Neal Donner, chair of Region 62, will take the opportunity to launch the regions's voter registration drive. He figures that the time to get folks to change their registration from Republican to Libertarian is when they're "mad as hell and won't take it any more."

Demonstrations will begin about 4:00 pm, in order to get coverage on the 5:00 news, and will continue until the cameras leave at 11:30.

Notes from the State Executive Committee

The next state Executive Committee meeting will be May 3, 4 at Lake Tahoe.

A New Direction:

At the February Convention delegates mandated an significant change in the Executive Committee and the political direction of the Party. It was briefly mentioned in last month's *CLNews*, but deserves more attention. Bylaw 9, Section 3 was modified to read:

It shall be the primary duty of the Executive Committee to develop, fund and implement (either directly or through such committees as they shall appoint) a political strategy to elect Libertarians pledged to the Party Statement of Principles and to proclaim and implement those principles into public policy.

This new Bylaw was written and introduced by Ed Clark, former LP presidential and gubernatorial candidate, and Bruce Daniel, chair of Placer County.

As Bruce points out in a memo, this changes the "fundamental nature of the Ex-Com. from one of relative passivity to that of a politically aggressive stance." But this does not mean the Ex-Com. is now to become "the grand campaign manager" of the candidates. The idea is that the Ex-Com. develop "a

dynamic and coordinated political strategy" for candidates at every level, and for propositions on a statewide basis.

Bruce is currently developing a proposal for the Ex-Com. reps to present to the central committees of their regions, which may be useful in implementing the mandate now required of the Ex-Com.

A Good Word for Bandits

A Letter to the *L.A. Times*:

'Bandit' Cabs in Los Angeles

"City Seeks to Flag Down 'Bandit' Taxicabs," said the headline in the Jan. 23 *Times*. "Bandit" taxicabs? What are these? Cab drivers who lure unsuspecting passengers into their vehicles, hold them up at gunpoint, then push them out on the freeway at 60 m.p.h.?

No, these cabbies are guilty of a far more heinous crime—giving people rides for money! The Taxi Industry Council of Los Angeles and their political henchmen down at City Hall have announced a crackdown on these fiendish interlopers who actually dare to provide a public service—brace yourself—without a government permit!

"We're going to do everything we can . . . to protect the public," says City Attorney James K. Hahn. Protect the public from what? Lower fares?

The purpose of taxi permits—as in every other licensed industry—is to freeze out any future competitors, either by limiting the number of franchises (read "monopolies") granted, or by making the cost so high as to prohibit most entrepreneurs from obtaining a license. The effect is to give the established cab companies a free ride on the backs of the taxi-riding public.

As with most government regulations, the poor end up as the main victims. Operating a taxi or jitney is one of the easiest and least expensive ways for individuals to go into business, yet this route becomes a dead end under the existing system of licensing, which shields the government-favored cab companies from such upstarts.

If drivers were allowed to operate free from government interference, cabs would be available in low-income areas where many drivers are now reluctant to go. In cities like Washington, D.C., and San Diego, where the taxi industry has been largely deregulated, other

results include shortening of response times, reduction in fares, and jobs for people who would otherwise be unemployed. As hordes of drivers compete for customers, any cab company with slipshod service or lax safety standards is weeded out in short order.

There is no such thing as unfair competition in a free market. If the members of the Taxi Industry Council can't prosper without government running interference for them, they shouldn't be in business in the first place. As for the bureaucratic meddlers down at City Hall, with their "sting operations" and "task forces," surely they can think up a more productive way to squander tax dollars than by harassing people who are just trying to make an honest living.
