Students Cheer LP Candidate RON PAUL VISITS BERKELEY

On April 20, LP presidential candidate Ron Paul visited UC Berkeley in response to an invitation to address 600 political science students (part of an ongoing lecture series on that topic). His theme: a call for withdrawal of U.S. forces from the Persian Gulf — clashes between American and Iranian forces were in the news that week.

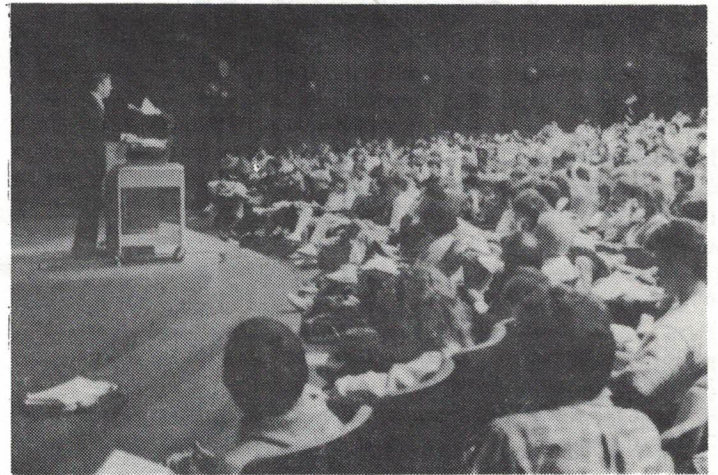
The trip was a great success. Aside from receiving rapt attention from all the students, 47 handed in their names and addresses afterwards asking for more information about the campaign. Nobody left early, applause was enthusiastic, and the speech was punctuated by occasional laughter and cheers for specific positions.

The class has a regular schedule of political speakers and public figures, and in 1984 had heard LP presidential candidate David Bergland. The prospect of speaking at one time to 600 students interested in political issues made the trip very attractive to the Paul campaign.

After a hectic trip (for example, at one point his flight was canceled), Ron arrived with literally seconds to spare, bounded up on stage and gave a strong 30-minute speech, followed by 15 minutes of questions and answers. The students cheered when he called for the elimination of drug laws, but most questions revolved around issues of national defense, showing the increasing conservatism on today's college campus.

The *Daily Californian*, the campus newspaper, carried a lengthy and very balanced report on the speech in the next day's edition. The *Oakland Tribune* was unable to send an observer, but asked for a telephone interview instead.

Libertarian Wins Council Seat

Libertarian Robert Subers, M.D., has run a successful race for a seat on the Clovis City Council. There were two vacancies on the six-seat council, one occupied by an incumbent, and a field of seven contenders. The incumbent retained his place, but Bob outpolled all of them. The final tally showed Bob with 2,300 votes against the incumbent's 2,000.

In the weeks before the April 12 election, Bob made no secret of his libertarian philosophy or party affiliation, but that didn't prevent him winning support from both Republicans and Democrats. In fact, some of his precinct workers were union men.

This is Bob's second try for the city council. The first was in 1986, and at that time he predicted success the second time around since he would work to build a strong organization. And that's what it takes. Organization and perseverance. He deserves hearty congratulations from all Libertarians. Now, if you think winning was hard — what will serving on the council be like? We'll keep you posted.

Country Fest '88

Over 100,000 people will be at Country Fest '88, May 21 and 22, at the Santa Fe Dam Recreation Center in Irwindale. The extravaganza is sponsored by the *L.A. Times* and two local country music stations, and will draw crowds from all over the western United States. Besides great music (some really big name performers will be there), you can expect great chili since there will be a major chili cookoff.

Jerry Lustig of Region 61 will have his booth, Libertarian Chili, where festival goers will find voter registration cards, Paul for President information, and other libertarian materials. This is a terrific chance for candidates to get hand out their literature and meet large numbers of people.

Then on June 5, there will be a fair out at Northridge Park, sponsored by the L.A. Parks and Recreation Dept. Besides a chili cookoff, special interest groups (that's us) are encouraged to participate.

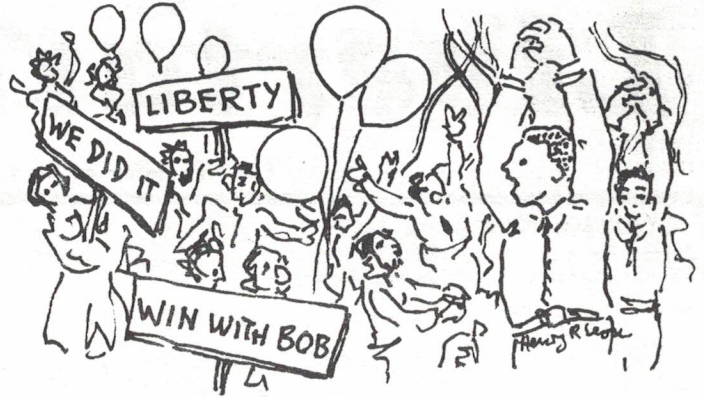
Thousands of people flock to these events. At least 25,000 attended the Long Beach cookoff on April 10, and four time that number are expected at the Irwindale festival. As Jerry points out, "There's no way the LPC can gather this many people together." Mark Denny, candidate for the 32nd Cong. Dist., came to the one in Long Beach and told Jerry, "If I had known there would be this kind of turnout I would have had my literature ready. I had no idea it would be like this." ORANGE COUNTY: Jack Dean, LPC candidate for U.S. Congress, is on the steering committee of Fullerton Citizens for Better Government. The newly-formed organization has just launched a petition which if approved by voters will limit the terms of all management level city employees to eight years. Those affected would be the city manager, the CRA director, the chief of police, and other non-elected power players. According to Jack, he's heard that the petition "hit city hall like a bomb." The Ron Paul Campaign has come up with a highly effective way of getting our presidential candidate on nationwide media. It's a kind of friendly persuasion: the persuaders — a network of dedicated letter writers — are called Eagle Pens.

Why do you think William Buckley had Ron as a guest on *Firing Line* back in February? Because literally thousands of libertarians and their allies wrote and asked that he be invited. Buckley admitted he had never received so many requests for a speaker.

There is an concerted, organized effort to generate a similar deluge of letters to the various talk shows. Three shows currently targeted are the Phil Donahue Show, the Oprah Winfrey Show, and the MacNeil/Lehrer NewsHour. Write and convince them that they need Ron on their programs. You needn't restrict your letter writing to TV and radio programs. Kevin Southwick of Campaign HQ urges writing letters to newspapers as well, suggesting that they cover Ron's appearances and pay more attention to what he has to say. Kevin reports that just *one* letter from Libertarian Andy Barniskis of Levittown, PA, convinced syndicated columnist Mike Royko (of the *Chicago Tribune*) that Ron Paul is a candidate that deserves real support. Royko wrote: "The way things are shaping up, not only may I vote for him, I might go out and walk a precinct." (March 29, 1988)

So boot up your word processors and generate, say, 10 letters a week to newspapers throughout California and the nation. That way, when Ron comes to town reporters will be interested in talking with him. You don't have a word processor? What about a ball point pen. After all, Tom Jefferson did OK with parchment and a quill.

The April 15 Tax Protest

First, the Bad News: We regret to inform you that thousands of Libertarians did not flock to post offices to protest the imposition of the income tax, nor did all the Los Angeles regions participate in the demonstrations. As a result, several million voters did not receive LP literature and do not know we have a presidential candidate named Ron Paul. Also, so far as we know, only one TV station covered the Los Angeles tax-protest activities.

Now, the Good News: We were successful in putting on demonstrations at four locations in L.A. County, and over 8,000 Ron Paul flyers were distributed, along with an equal number of a flyer promoting Libertarian candidates running in L.A. County.

In Region 64, about 20 Libertarians handed out approximately 2,800 Paul flyers and carried signs from 4:00 p.m. until midnight. In Region 63, eight volunteers, including state chair Ted Brown, southern vice-chair Kim Goldsworthy and state senate candidate Bob Scott handed out about 1,000 campaign packets at the Pasadena Post Office. Region 62 put on a successful effort, with about 17 volunteers distributing 1,500 Paul flyers and 1,500 pieces of local literature. They also gave away over 1,000 copies of the L.P. NEWS Special Outreach Issue left over from the LONG ACTIVE project.

Seventeen Region 61 volunteers were at the Van Nuys Post Office from 5:00 p.m. till midnight, and gave away 2,800 each of the Paul flyer and the Los Angeles County slate piece. It's believed that Region 61 had the youngest demonstrator, Marina Neale (age 2 years), who was carried at the protest by her father Geoff Neale.

While there were a few unpleasant experiences, such as one

individual who shouted obscenities at a demonstrator, the effort was accompanied by many happy and educational experiences. Taxpayers seemed more than eager to take LP literature, as though they were desperate to find some way out to the government's tax-and-spend treadmill.

To tally the results: About 62 Libertarians county-wide proved they are not sunshine patriots by braving the threat of rain to distribute in excess of 20,000 pieces of Libertarian literature to several thousand taxpayers. Telephone inquiries continue to come in. Thanks goes to everyone who participated and helped make the demonstrations a success.

Other Tax Protests: We don't have many details about demonstrations elsewhere in the state, except that they did take place and quantities of LP literature were handed out.

In Ventura County, the only county other than L.A. that we have any real news about, Libertarians handed out literature to voters at both Oxnard and Thousand Oaks Post Offices. The Thousand Oaks *News Chronicle* ran a great front page article, complete with quotes from our candidates and a large photo of Bob Jay handing out literature.

Is it better to concentrate forces at one location hoping for media attention or dispersing through the area to reach a greater number of voters? Bert Donaldson of Ventura County says there's "no question" Libertarians were able to hand out more material to more voters. In going to different post offices we accomplished what we intended: we got material directly into the hands of taxpayers. — Editor.

LPC Candidates for 1988

The LPC is fielding far and away more candidates (74) than either of the other two new parties: only 37 Peace and Freedom candidates and three American Independence. This is considerably more than the 50 we ran in 1984, but is not the peak reached in 1980 when there were over 100 Libertarian candidates statewide. Still, we're in a good position to give voters a choice this November. CLNews will be publishing stories about different candidates between now and election day, but for more immediate information, or to offer to help on their campaigns, they can be reached directly.

there and recognized him from last year when he testified against several pet redevelopment bills, so he immediately signaled the bailiff to clear the aisles — which is a highly effective way to silence dissent.

Although Roger was denied his right to testify, Larry was later able to take the microphone. By that time AB 4516 had been OKed and the committee had moved on to another related one, but Larry demanded his right to speak on the subject of involuntary commitment. The crowd cheered and yelled, "let him speak, let him speak," so he was able to score a few points for liberty. It won't be the last time Libertarians are heard in Sacramento.

Top Court Takes Case

On April 18, the U.S. Supreme Court announced it will hear the California Attorney General's appeal in *San Francisco Co. Central Committee vs. Eu*, case no. 87-1269. The case will probably be argued in October or November. Earlier, the Supreme Court refused to issue a stay of the lower court decision. The lower court decision ruled that it is unconstitutional for a state to tell a political party that it may not endorse candidates in its own primaries, and also that it is unconstitutional for a state to dictate how a political party should be organized.

In a related case, U.S. District Court Judge Alfonso J. Zirpoli, a semi-retired Kennedy appointee, ruled on April 15 that it is unconstitutional for California to tell political parties that they may not endorse candidates in non-partisan elections, and that if a candidate wishes to mention in the statement of qualifications (printed in the voters' handbook) the fact that he or she was so endorsed, the statement may not be censored out. *Geary vs. Renne*.

Lobbying for Liberty

On April 12, Sacramento chair Roger Pope and Lawrence Murray, a local Libertarian activist, braved the hallowed halls of the state capital to speak in defense of liberty. The occasion was a hearing on AB 4516, introduced by Bruce Bronzan (D-31), to increase the length of time "mentally ill" people can be held against their will for "treatment" (see last month's *CLNews*), and the bill was being heard by the Subcommittee on Mental Health and Developmental Disabilities chaired by Richard Polanco (D-55).

The hearing room was crowded, with all seats taken and

AJR 8 On Hold

TomMcClintock's bill to require the legislature to require Congress to call for a Constitutional Convention, if that's what it takes to get a balanced budget amendment, has been temporarily shelved. The hearing before the Assembly Intergovernmental Relations Committee was scheduled for April 20, but just before it was to begin the author removed it from the calendar.

The reason given was that certain witnesses were unable to appear. Perhaps, but plenty of witnesses on the other side were present and ready to speak, and letter writers had been deluging the committee members with their views on the subject.
