ANTI-WAR PROTESTS GROW STRONGER

Libertarians have been active in the movement to bring U. S. troops back from the Middle East since the very beginning. Polls show that only 56% of Americans support President Bush's impending military intervention. This number is quite low considering how the public has followed the flag wherever the president has thrown it in the past. The time is ripe to sway public opinion by frequent, effective demonstrations.



The Libertarian Party of California has formally joined the L. A. Coalition Against U. S. Intervention in the Middle East. The "Points of Unity" of the coalition are:

- 1) To work for a total and immediate withdrawal of U. S. forces from the Middle East.
- 2) To educate our populace as to the true reason for the U. S. involvement, namely the protection of oil capital, including that of President Bush.
- 3) To promote respect for self-determination for the peoples of the region, supporting their efforts to resolve the crisis.
- 4) To oppose all forms of racism against Arab, Muslim, and other peoples of the Middle East.
- 5) To organize non-violent activities in support of these points.

Libertarians held a protest at the Federal Building in West Los Angeles as early as September 1. Just 25 people attended then. On December 1, at least 1,000 people were on hand to hear Ron Kovic, the Vietnam veteran immortalized in "Born on the Fourth of July," passionately call for returning our troops and preventing a rerun of the trauma and carnage of Vietnam. While Libertarians were in the minority number-wise, our signs were prominent, and were carried by people who often disagree with us on other issues.

Protests will be held every Saturday from 11 a.m. to 1 p.m. until the January 15 United Nations deadline for Saddam Hussein to withdraw his troops from Kuwait. I suspect that the protests will continue long after that date. For up-to-the-minute information, call Neal Donner at (213) 477-6462.

Is there a draft in the air? I participated in a roundtable discussion December 7 (Pearl Harbor Day) at South Pasadena High School. These students

were intelligent and aware of the gravity of the Middle East situation. Their most asked question was "Why are we there?" Another participant, Cal Edinger of the American Friends Services Committee (Quakers), reported that the large war effort may cause Bush to reinstitute the military draft. Specifically, people in the health services may be drafted

to take care of war wounded (ala M*A*S*H*). Edinger states that 600,000 young men have failed to register for the draft, as they are required to do at age 18. So far, 21 have been prosecuted, and 7 have been imprisoned.

Libertarians know that "war is the health of the state." This was demonstrated by Senator Jim Sasser (D-Tennessee), chairman of the Senate Budget Committee. Mr. Sasser has called on President Bush to impose a special tax to finance war in the Persian Gulf if fighting breaks out. The tax might take the form of a "temporary" income tax surcharge, such as the 10% levy imposed in 1969 to finance the Vietnam War. The only good part of such a proposal is that it might anger people who currently support military action.

Pentagon officials estimate that "Operation Desert Shield" will cost between \$29 billion and \$37 billion this fiscal year alone! Is it possible that such a massive mobilization can be maintained without Congress reaching into our pockets to finance it? What do **you** think? Members of Congress need to know how we feel about the cost, both human and financial, of this destructive operation. Write to **Sen. Alan Cranston at U. S. Senate, Washington, DC 20510**, and to your member of Congress at **U. S. House of Representatives, Washington, DC 20515**.

One last thought: There is no cause more important right now. A war would kill tens of thousands of young Americans, ruin the economy, raise already confiscatory taxes, and give the government an excuse for wholesale violations of civil liberties. A factory in Contra Costa County has a contract to make thousands of body bags. It is rumored that the Defense Department has ordered 30,000 coffins from another vendor. This is all very real. The time is **now** to yank the props from under George Herbert Hoover Bush's "new world order."

IS A STATE TAX BOOST "INEVITABLE"?

The chairman of the California State Senate's Budget and Fiscal Review Committee says that he sees no way to balance the 1991 state budget without a tax increase.

Sen. Alfred Alquist, an 82 year old San Jose Democrat who has served in the Legislature since 1962, gave this opinion after top fiscal analysts stated that the state will be \$5.7-6.2 billion short of the money needed to pay for current state services over the next 18 months. The annual budget is \$55 billion.

Alquist has introduced **SB 85**, to raise the top rate of the personal income tax from 9.3% to 11% in order to raise \$2 billion annually. One of his allies is Bill Honig, the Superintendent of Public Instruction, who argued for a tax hike to head off cuts in school programs.

Sen. John Seymour (R-Anaheim) disagreed. He asked, "Are you suggesting . . . that 12% of the taxpayers who are currently paying 70% of the taxes should pay more? Is that what you're saying?" Honig responded, "Absolutely. Of course, they are paying more. They get most of the income."

RUSSIAN LIBERTARIAN VISITS CALIFORNIA

Evgenia Debrynskaya, founder of the Libertarian Party of Russia, visited Los Angeles on November 26 and met with local Libertarians. The Russian party was founded in Moscow earlier this year. The name was chosen by coincidence; the founders were unaware of other Libertarian Parties around the world. Evidently the word "libertarian" has a Latin base and translates directly into Russian. Ms. Debrynskaya looked in the dictionary to find a name that reflected her philosophy.

Ms. Debrynskaya believes that she is the only out-of-the-closet lesbian in Russia. She has been campaigning to legalize prostitution in the Soviet Union. The media have covered her in the past when she distributed condoms in Red Square. Condoms are not produced in the Soviet Union, and imported ones cost about \$6 each! (Abortion is the main method of birth control.)

The LP in Russia is concentrated in Moscow and Leningrad. There are 300 members now—mostly prostitutes, gays and lesbians—but there is hope for a broader based party of at least 3,000 members in the near future. Ms. Debrynskaya plans to run for the Moscow City Council. She would be an independent candidate, and believes that she can win based on her personal contacts in her neighborhood.

According to Ms. Debrynskaya, Mikhail Gorbachev has no intention of bringing true democracy to the Soviet Union. Given the political circumstances, he would be hard-pressed to do so even if he desired it. There is no tradition of democratic institutions. The long-suffering Russians went from Czar to Communism, with only one free election (in early 1917, which the Bolsheviks—Lenin's supporters—lost). There is no word for "privacy" in Russian, and thus no concept of it.

Ms. Debrynskaya has been "adopted" by Vicki Kirkland, Libertarian National Committee member from New York, who is holding a fundraiser to buy a computer for the fledgling group. Due to the uncertainty of mail service between the U. S. and the U. S. S. R., plus the threat of KGB surveillance, LP members believe that setting up an E-mail system via computer is the most practical means of communication. Once this system is operational, we will report how to get in touch with our fellow Libertarians in Moscow. **CLNews**

A STATIST SPEAKS OUT

Rep. Dan Rostenkowski, a 62 year old Illinois Democrat who has been in Congress since 1958, is chairman of the House Ways and Means Committee. He sent a letter to a number of newspapers in opposition to term limits for members of Congress. He refers to the budget package (read: higher taxes) passed in October to support his position.

He says that 60% of the members who have served more than 12 years in Congress voted in favor. Members who have served less time voted against, with two-thirds of freshmen congressmen voting "NO." If Congress had been limited to junior members, he says, it's possible that there would still be no budget in place. He says that members become more "courageous" as they become more established and secure in their districts.

To Libertarians, "courageous" in this context means "more willing to sock it to the taxpayer." Rostenkowski's statement shows that we need term limitations on the federal level as well as the state level. After all, had limits been in effect, Rostenkowski would have had to retire in 1970. **CLNews**

JUST DO IT!

REALITY. A severe word, but one we have to face. Spell it another way: OUTREACH. And yet another way: MONEY. Without money and outreach, we have no function; we have no purpose; we have no future. The question: how do we turn the Libertarian Party from a small but vocal group to a true political power?

Our assets: a unique platform, dedicated and intelligent activists, great ideas, and a will to succeed. 25%-30% of voters are potential Libertarians—if we can only reach them. We cut across and appeal to all races, occupations and income groups. Our potential: extraordinary.

Our liabilities: little money, insufficient follow-through, lack of organization, and internal bickering. In short, we are not living up to our potential.

So what now?

Before we can turn into a money gathering machine, we must first organize our human resources. If we don't, we won't be able to make our monetary goals.

There are many Libertarian activists. Most are bright and capable people. Each must carve out a niche, take responsibility for it, and execute it to the best of his or her ability. It may not be the top job. Perhaps your niche is helping to mail the newsletter once a month. Perhaps your niche is manning a booth at a county fair. Perhaps it's making phone calls to get Libertarian speakers to groups like the Rotary Club. Perhaps it's learning Spanish and recruiting Latinos into the party. Perhaps you are not afraid of asking people for money, and you can get involved in fundraising. If you don't know what to do, contact your county chair and say you want to be involved. A job will be found for you.

There is another essential function, one of the most important any Libertarian can do: run for and win election to local offices like city council and school board. These are non-partisan offices that are the training ground for future Libertarian political leaders. Even without party affiliation, these offices can become platforms for testing libertarian ideas—and influencing public policy on the grassroots level. Not only does this provide experience, it provides credentials for future political aspirations. It provides contacts. It provides allies. And it will give you access to people who are already involved.

It's a trial by the mile, it's hard by the yard, but it's a cinch by the inch! The first step? Dig into your pockets and donate \$10 to your county or regional organization and \$10 to the state party on top of your dues. That is the price of only three movie tickets, or one cheap dinner for two, or a few drinks.

We can learn from the great philosopher and novelist Ayn Rand. In an interview with Phil Donahue in 1979, she said words that have made superstar Bo Jackson famous: "Just do it."

ELECTION UPDATES

In the December issue, *California Libertarian News* neglected to mention that a Libertarian incumbent was re-elected in California. **Jerry Douglas** of Woodland Hills won a second four-year term as a director of the Topanga-Las Virgenes Resource Conservation District. Profiles of Jerry and other Libertarian officeholders will appear in future issues.

After the absentee ballots were counted, Insurance Commissioner candidate **Ted Brown's** final tally was 433,421 votes, or 6.06%. This exceeds **Ron Paul's** nationwide total in the 1988 presidential race. Ted's total was not the highest nationwide, however, as **Carol Caul** received 441,945 votes (15.1% in a two-way race) for the Texas Court of Criminal Appeals.

The absentee results changed just one Libertarian vote total substantially. We reported last month that **Roy Shimp** received 3.4% in the 27th State Assembly District (Merced and Stanislaus Counties). The final results show Roy at 5.7%, 191 votes over the margin of difference between the Democratic incumbent and Republican challenger.

Besides Roy, other "balance of power" LP candidates were **Paul Gautreau** (Attorney General), **John Wallner** (44th Congressional District), **Juanita Hendricks** (4th Senate District), **John Murphy** (75th Assembly District), and **Ed McWilliams** (78th Assembly District). *California Journal* noticed that the votes for Murphy and McWilliams may have helped defeat two incumbents. **CLNews**

LPC Field Coordinator **Jim Lewis** has resigned to take a new position as manager of the Andre Marrou for President campaign. He moved to Las Vegas in November. As you know, Jim was the LP's 1984 vice presidential candidate who later served a jail term courtesy of the Internal Revenue Service.

His weapon was the opinion survey, which asked students questions about issues ranging from drugs to guns to Social Security. Starting just before Thanksgiving, Libertarian Party leaders and ex-candidates have been receiving large quantities of mail from a bigoted ex-Marine named Stan Jaroszinski. Mr. Jaroszinski accuses us of encouraging drunkenness, drug abuse, gluttony, and the spread of AIDS. Unfortunately, he claims to be a registered Libertarian and leader of the party's "spiritual faction."

Large manila envelopes arrive covered with insults and excerpts from anti-Catholic and anti-gay tracts. There is information from Tony Alamo's fundamentalist church in Arkansas and from the Christian Workers Movement. They advocate unlibertarian positions such as raising the minimum wage to \$7 an hour and quarantining HIV-positive individuals to open up the job market to the unemployed!

Mr. Jaroszinski has also sent press clippings of his time in jail for setting a fire at a Catholic student center in Tucson, Arizona. In that city, he is known as "Stan the Sign Man" because he stands outside Catholic churches carrying signs accusing the church of dealing in organized crime and drug trafficking. He says that Tucson Libertarians "ran away" from him. (I wonder why!) Mr. Jaroszinski now lives in the Skid Row area of downtown Los Angeles.

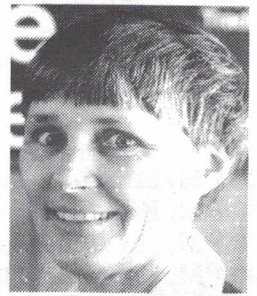

A NEW LIBERTARIAN WRITES TO THE PRESIDENT
