

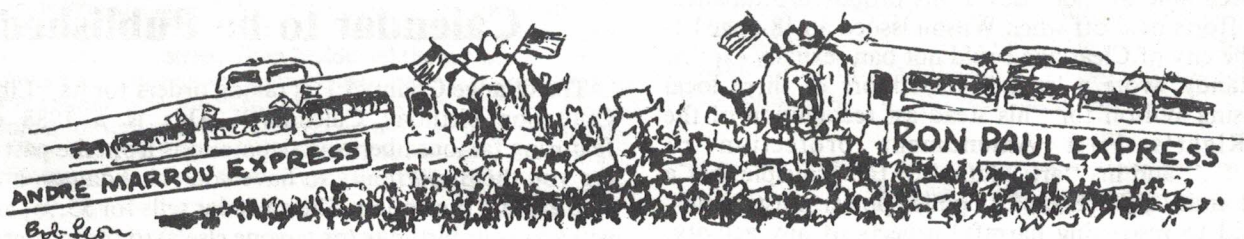

Candidates in California CAMPAIGN '88 IS UNDERWAY



SANTA ANA: LP presidential candidate Ron Paul's first press conference since the Convention was held Sept. 17 in Santa Ana at the Orange County Hall of Administration. Jack Dean, who coordinated the events of the southland visit, reports that although there was no TV coverage, the media was well represented by UPI, the *Orange County Register*, and several other newspapers. Next day Ron appeared on the Cable News Network on the Sonya Friedman Show in Los Angeles and was interviewed by Michael Jackson for KABC Radio.

The theme of the press conference in Santa Ana was in line with the festivities surrounding the bicentennial of the Constitution. Ron stressed that rather than trotting the document out every 200 years for study and reverence, it would be better to adhere to what it says and means in terms of liberty on a daily basis.

That evening Ron attended the gala celebration of the Constitution held at Knotts Berry Farm in Buena Park. James Lessard, Jack Dean's employer and one of the co-chairs of the banquet, is so excited about Ron's candidacy, he invited him to be his guest. This meant Ron was introduced to the entire gathering as a presidential candidate.

The following evening, an impromptu party in his honor was held at the home of David Bergland and Sharon Ayres in Costa Mesa. About 60 people attended, including eight or nine students, "all very enthusiastic," according to Jack, "it was a very upbeat evening. Ed and Alicia Clark were there, so we had three of our presidential candidates together."

Ron will be back in California this month. On Oct. 8 he's scheduled for a taping at the Financial News Network in Los Angeles. Next day he'll be speaking at the Gary North Conference in Anaheim about "Washington's Attack on Your Cash and Your Freedom." Marrou Plans California Weekend

Vice-presidential candidate Andre Marrou is also planning to be in Southern California the same weekend Ron Paul is, but will not be at the same events. Andre will arrive in San Diego Oct. 9, then make stops in Orange County and Pasadena (Oct. 10), the East San Gabriel Valley (Oct. 11), and Ventura County (Oct. 12). Media events and fundraising functions are being planned, but as of presstime details are still tentative. Here and There

LAKE COUNTY: Besides fighting for property rights, county chair Randy Grindle, has been engaged in a two-year battle with some fundamentalists who favor an anti-pornography ordinance. By working directly with city attorney Ken Wilson he has twice been able to shoot down this proposed ordinance. His recent efforts paid off when Wilson issued an 18-page letter saying the city of Clearlake could not ban sexually explicit material. Randy wrote a letter-to-the-editors of three local papers praising Wilson for "his steadfast recognition of the Bill of Right's First Amendment protection of expression. . ." and his "articulation of the principle that a government entity's exercise of its police power must be narrowly limited to restricting harmful aspects of any activity, while leaving any harmless aspects of an activity unencumbered. That in a nutshell is the libertarian principle of government, and we salute Mr. Wilson for his support of it."

Randy is also beginning circulation of a Property Owners Bill of Rights initiative, similar to the one being circulated in Sonoma County (see last month's *CLNews*).

REGION 64 (Los Angeles): An evening spent watching the play *Marat-Sade* at the Friends and Artists Theatre in Los Angeles resulted in an invitation to chair Ted Brown to participate in a panel debate with three communists on the topic of Revolution in America. Ted describes the competition as "two homegrown communists and one from El Salvador." It was a generally liberal crowd (about 25 attendees), but they were by no means Marxist — at least, few seemed to go for the idea of no private property or the idea that doctors should have their salaries regulated by the state. Although no vote was taken to see who "won" the debate, people were interested enough to take home some Libertarian literature, and, says Ted, "it was a good opportunity to hone my debating skills."

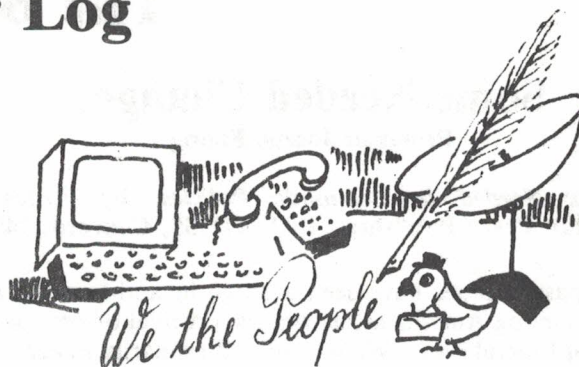

Speaker Training Manual

Bud Bates

Persuasion vs Coercion, The Case for Self Government. Speaker Training Manual #1, by Marshall Fritz. *Advocates for Self-Government, Inc.*, 5533 E. Swift Ave., Fresno, 93727, \$4.95.

Several libertarians, including your reviewer, have successfully used Marshall Fritz' "Persuasion vs Coercion" speech as a model for their first libertarian speech to a non-libertarian audience. This is a basic speech, which generates interest in libertarianism because it focuses on the benefits of a free society rather than simply outlining the features. Marshall

has recently published the text, together with advice about speaking and on getting invited to speak. The *Manual* is a small booklet with a ring binder allowing it to lie flat on a podium while the pages are turned. The text itself is printed on the left side pages, and the right side contains the key words in very large print so the speaker can refer to them inconspicuously. Although this speech is "pre-composed," the user can easily adapt the text to his or her own personality, the time allotment, and the audience.

The Book Shelf

Some Needed Changes

Professor Joseph Fuhrig

***Changes Needed in Economic Policies*, by Firdos J. Mubarak. Peace Publishers, P.O. 272535, Concord, 94527. \$5.00.**

The past decades have seen a surge in anti-taxation sentiments among Americans, as well as a revival of pro-market Classical Liberal ideas. While confined primarily to academic and intellectual circles, this movement has drawn from Populist, Conservative, and Libertarian sources to have a perceptible impact on political rhetoric in the 1980's.

It is fair to say that the thrust of the writing in this area has been educational in character and aimed at a small minority of well-educated leaders and opinion-makers. But all ideological revolutions require a popularization phase if they are to be successful, and thus we have witnessed books by popular writers such as Robert Ringer (*Restoring the American Dream*) and Harry Browne (*How I Found Freedom in an Un-free World*) which specifically focus on important aspects of the movement to wind down Big Government.

Changes Needed in Economic Policies by Firdos J. Mubarak represents another direction in the popularization phase of this ideological revolution. He attempts to persuade us of the fact that these transitional programs could be implemented by any capitalist or quasi-capitalist country to ultimately run itself without collecting taxes from the people. It is meant to convince the average reader that action is necessary and that results are achievable.

The underlying framework of his work is a combination of Friedmanian Liberalism and neo-Conservatism. He asserts, with enthusiasm, that public officials can be made to respond to popular demand to reform the existing system of taxation and regulation. He further asserts that beyond tax reform lies a pay-as-you-go system where essential services are financed by user fees. There is, in all of this, an underlying faith both in the competitive forces of the market and in the institutions of a democratic society.

This book rates high marks for energy and exuberance. The author could go a bit more carefully when trying to develop a point that might win over a critic, but the overall tract is interesting to consider simply for what it represents — an attempt by the ordinary citizen, deeply concerned for the future, to persuade his fellow citizens that something must be done.

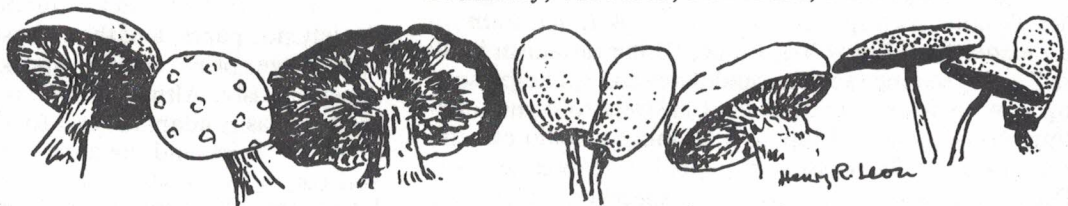

In October, 1986, the California Dept. of Health Services (DHS) prepared, under conditions of great secrecy, a draft "Law Relating to the Sale of Mushrooms." Despite the DHS' lack of expertise on mushrooms, none of the relevant experts on the subject were consulted for fear of making the proposal public. Copies of the draft were circulated to public health officials throughout California with strict instructions to keep the proposal secret from those groups with the most at stake in any proposed regulations, namely, the four amateur mycological societies in California, as well as stores and restaurants that sell or serve wild mushrooms.

After seven months, word of the proposal finally leaked out and it was immediately obvious to the parties concerned that the proposal was an unworkable mess. For one thing, it would have required that a new state bureaucracy be set up to test, license and discipline mushroom inspectors!

After several more months of wrangling over revisions of the draft law, a meeting which I attended was held in Berkeley,

July 16. It was decided to scrap the draft law completely and start over, this time with input from the affected parties.

So the 15-page draft law, written at a cost of thousands of your tax dollars, turned out to be a total waste of time and money. Eye on Washington and Sacramento

Beilenson Pushes Beer Tax

Anthony Beilenson, (D. 23rd Cong.) is sponsoring a bill, HR 2037, to increase the excise tax on beer a whopping 18%, which of course will push up the price of beer.

While this particular legislation would increase the excise tax on beer, there are other bills that deal with other kinds of alcoholic beverages. Some are only on wine, others on wine or distilled spirits — and some are combinations. If any of these bills pass, it would have a devastating effect on our already troubled industry.

We're trying to fight SB 2037 and the others, and think that with enough mail generated the proposed new taxes can be killed in committee. Our small tavern has generated about 2,000 pieces of mail. Another few hundred or a thousand letters from concerned Libertarians would be a real help.

Julie Wilson is a libertarian who owns a neighborhood bar. On the phone she described some of the problems tavern owners face today besides tax increases: "We've got massive regulations, we're one of the most regulated industries. Then besides all the various anti-booze groups, we've got cops sitting outside bars staring at customers to scare away anyone who wants to stop in for a beer."

dar after the first of the year. It won't be necessary to reintroduce the bill, it can be picked up just where it was left — that is, it can be run through Ways and Means, then the Assembly. It's already been passed by the Senate in May.

There's also the possibility that special wavers will be sought so it can be sent to the Assembly before the end of this year. Stay tuned.

The Deadliest Fungus

Steve Pencall

Libertarian Steve Pencall of Whittier is an amateur mycologist: that is, he collects wild mushrooms for study, photography and culinary purposes. His account illustrates how the spores of government embed themselves in our society. The matter he writes about is sure to come back in a more "acceptable" form; *CLNews* will keep you posted.

One of the great attractions of mycology has been the relative lack of governmental interference. Recently, however, the increased popularity of wild mushrooms as food has had predictable results — bureaucrats have found an activity that suffers from little regulation as yet, so they are moving in with new regulations to "protect the public health."

Vigilance Needed on SB 442

SB 442, the bill which would permit the formation of private land readjustment associations, is still roosting in the Subcommittee on Pensions and Bonded Indebtedness of the Assembly Ways and Means Committee, a tie-vote having prevented it from flying to the full Committee and the floor of the Assembly. The prognosis isn't clear. According to SB 442 watcher Sherry Passmore, there's conflicting stories. "Various state officials say that it's dead, buried, and put away, but unofficially it's very much alive," says Ms. Passmore.

It's not unlikely that the bill's author, Sen. Marian Bergeson (Rep., 37th District), will have it placed on the calen-
