47 States in '88 BALLOT ACCESS UPDATE

"Bells are ringing, whistles blowing," at Ron Paul Headquarters in Houston, according to Campaign staffer David James. And there's good reason. Official word has just been received that we're on the ballot in Florida, a state with really outrageously high requirements for ballot status. This means the LP is on the ballot in 47 states and the District of Columbia, with only Indiana, North Carolina and West Virginia closed to us.

Dirty Tricks in the Hoosier State: Why we lost Indiana is a disgraceful story of duplicity, conspiracy and fear. Those guilty: politicians in the state General Assembly, panicked at the idea of "third party" candidates. In 1982 enough citizens cast their votes for Libertarian candidates to assure "permanent ballot status," so the politicians passed laws making it four times as hard for the LP to retain that status. That worked for a while, but in 1988 it became clear that the Paul/Marrou ticket and the local candidates posed a real challenge this election. To offset the threat, the politicians got together and pulled a bunch of tricks out of their bag. In the middle of the time period allowed for independent candidates to collect signatures for their nomination petitions, the Indiana General Assembly changed the rules and requirements.

Special emergency legislation was passed in late March, that moved the deadline for filing signatures ahead by two weeks. This would have been bad enough at any time, but it was done *after* the Official Political Calendar for Use in 1988 had been printed and distributed to the county clerks. Nobody was properly informed about the changes, not even the county clerks let alone the Libertarian candidates, who found out after they filed their signatures in accordance with the Official Calendar.

Moreover, the new legislation changed the offices at which papers were to be filed. Again, no one was told and our candidates were filing theirs at wrong offices. These and other rule-changes successfully kept almost all Libertarian candidates off the ballot in Indiana.

One of the only exceptions is Kenneth Bisson, M.D., who discovered the tricks in time to save his campaign. In *The Trout in the Milk*, the newsletter of the Indiana LP, Dr. Bisson details this malicious subversion of the election process and comments: "I am not writing about the antics of some Banana Republic. This is happening in the State of In-

diana, in the United States of America! I used to think that controlling the voter's choices in elections was only a tactic employed by the Communist Party in the Soviet Union. There. . . the choice of candidates is manipulated by those in power. . ."

North to Oregon

During the weekend of July 30, five intrepid souls from the Santa Clara LP drove up to Ashland, Oregon to gather signatures to put Ron Paul and Andre Marrou on the ballot in that state. The five were Todd Greene, Mike Iddings, Brian Esterson, Karen Huffman, and myself. Some of us had not done serious petitioning before, and learned it is not easy to approach total strangers and ask them to write down their name and address, even for such a good cause as the Libertarian Party Ballot Access.

On the way to Oregon there was a wreck on the I-5 (not us) which tied up traffic, causing one car to arrive at 4:00 Saturday morning, and the other even later that day. Because of this we only managed to collect about 200 signatures between the five of us. Nevertheless, we had a lot of fun and made contact with Oregon Libertarians with whom we can probably have some productive exchanges of volunteer effort. For example, they are trying to have their Attorney General candidate get five percent of the vote so the Libertarian Party can have ballot status in 1990. Perhaps we can help them with money or time.

The LPC ExCom met August 13 and 14 in Los Angeles. Business included taking positions on ballot propositions (see page 4). Jerry Douglas is the new chair of the Contract Services Management Committee. Lynn Sapowsky will continue as consultant/manager for the LP office in San Jose.

The ExCom passed several resolutions: one, introduced by Steve Pencall of Region 63, declared our opposition to attempts to set up a state board that would certify gatherers of wild mushrooms; a second condemned the infamous "Ratline," officially known as The Underground Economy Hotline; and a third pledged opposition to Proposition 95. Two Things You Can Do

Write to NPR

You can help Ron Paul get national news coverage by writing to the News Director, National Public Radio, Washington, D.C., 20036 and requesting coverage of all presidential candidates who will be on the general election ballots in enough states that at least 15 percent of the U.S. voters will have the opportunity to vote for them. 15 percent is not a magic number, but offers some guideline to avoid a brush-off of your proposal on the grounds that "third" parties are too numerous and small to deserve coverage.

NPR is non-commercial, has 4 million listeners, is sensitive to criticism about political bias and prides itself on offering more complete news coverage than any other radio news source. It is unusually likely to respond to requests for coverage of "third" party presidential candidates, especially requests that mention a journalistic obligation to be truly non-partisan and to keep its audience well informed about all their possible choices for president.

NPR has already received some letters on this subject and read part of one over the air, but it apparently must receive many more to be convinced there is sufficient audience demand for coverage of "third" party presidential candidates. Even a two or three sentence letter can help a great deal, so get out your pen or typewriter and convince NPR.

Ballot Access Fundraising

A special ballot access fundraising letter mailed in July to LPC members and inquiries netted \$5,339 gross, so we were able to pass along over \$4,700 to the nationwide ballot access drive. The letter was written by Steve Alexander, Santa Clara County chair and signed by Richard Winger of the Ballot Access Committee.

Federal Matching Funds

During the past month, several Libertarians have sent *CLNews* articles and letters urging Ron Paul to accept federal funds for the campaign. Some of the arguments are admittedly very convincing — Alan Burris, author of *A Liberty Primer*, maintaining that it would be immoral not to do so. Besides the fact that most Libertarians are just as firmly convinced of the immorality of taking “the king’s penny” and Ron Paul himself is adamantly opposed to the suggestion, there is a less ideological consideration: namely, that neither the Libertarian Party nor Ron Paul qualify for the funds, according to the headquarters staff in Houston which has explored the matter. So even if we wanted to “take the money — and run,” as one writer puts it, we couldn’t. The issue is essentially closed as far as this campaign is concerned.

Keeping up with Issues

According to the New American Unabridged Webster’s Dictionary, 1968 ed., the Greeks had a word for it: *kakistocracy*, which means government by the worst men in the state. (from the Greek *kakistos*, superlative of *kakos*, bad). Therefore, Dukakistocracy would be twice the government by the worst men in the state. (*du*, in Greek means two). It’s true. Check it out.

Would it be better to have a Dukakistocracy or be Bushwhacked? Editor Lew Rockwell has done us all a service by writing a highly informative analysis of what we’re in for in either case. The lead article for the August issue of *The Free Market* is “A Plague from Both Their Houses: The Economic Advisors to Bush and Dukakis.”

This is an unusual approach in that it looks not at the candidates, but at the men who will be in key positions of influence in each administration. These advisers are “inevitably followers of John Maynard Keynes, the 20th century’s most influential justifier of state economic planning. In the Keynesian tradition, the economic advisors to George Bush and Michael Dukakis share the same intellectual premises, and advocate government power over individuals and businesses, and extensive government intervention in the economy.”

If you’re a candidate who needs specific information on the other parties, or a voter who’s thinking that maybe Bush wouldn’t be too bad, this article is **MUST** reading. The fact is, with either one, we lose. Lew Rockwell shows us why.

The November Ballot

California voters will read some really good ballot arguments this November, at least as far as the bond measures are concerned. Of the record number of propositions to vote on (22), nine are bond measures. LPC chair Ted Brown wrote arguments against all nine, which were cosigned by Southern Vice-Chair Kim Goldsworthy and one of the local candidates. Of these, the Secretary of State selected five of his arguments for the voters’ brochure. Alameda County Libertarian Bill McCord also wrote arguments against the bond measures, and three of his were chosen.

So eight out of nine measures have Libertarian arguments against them. You could say that Libertarians swept the field for the ballot handbook. Let’s hope the voters agree with us and sweep the bond measures into the wastebasket.

Look for these in your voters pamphlet: Propositions 80, 81, 82, 85, and 86 were by Ted; Bill’s are for (against) Proposition 78, 83, and 84. They cover the usual wishlist of spending measures — everything from library bonds to water bonds.

Of the other Propositions, the state ExCom voted to recommend a NO vote on all propositions except 90 and 93, which earned a YES recommendation, and 87 and 88, on which NO POSITION was taken. Proposition 90 would allow anyone over age 55 to transfer their old property tax rate onto a new home — a Prop.13 benefit; and 93 deletes a residence requirement for veteran benefits.

The Libertarian position on Proposition 95, the Housing and Nutritional Assistance Act, (see last month’s newsletter for details) was formally underscored by endorsement of an official resolution of opposition approved by the ExCom. For a copy, contact Sarah Foster, (213) 259-9580.

FPA Conference to Meet in L.A.

“Questioning Authority” is the theme of the Free Press Association’s (FPA) third annual conference, to be held Oct. 14-16, at the Pacifica Hotel near LAX. More than two dozen journalists, broadcasters, novelists and cartoonists will explore the frontiers of the First Amendment and other civil liberties issues. Subjects include censorship, media bias, a debate about tobacco advertising, media coverage of the War on Drugs, and media coverage of Election ’88.

Confirmed speakers include Alan Bock, of the Orange Co. Register; Paul Ciotti, L.A. Times; John Fund, Wall Street Journal; John Dentinger, a 1987 Mencken Award winner; Bob Poole, Reason Foundation; Marty Zupan, Reason Magazine and many others.

A highlight of the FPA Convention will be the announcement of the Mencken Awards for outstanding work in journalism and related field — to be presented at the Saturday night awards banquet. Pulitzer Prizewinner Jonathan Freedman (San Diego Tribune) and media maverick Richard Newcombe will headline this event.

Since the conference rotates between major U.S. cities, there won’t be another in Southern California for many years. Cost: \$80 for entire weekend, \$50 banquet only. Norma Jean Out of Jail, but Still Not Free

The Friends of Norma Jean Committee have good news and bad about our 1986 Lieutenant Governor candidate, who was imprisoned on trumped up charges of pandering to prevent her from publishing her book about the Los Angeles Police Department.

First, the good news. Norma Jean Almodovar is on work furlough and living in a "half-way" house in Los Angeles. She can receive visitors, but her hours limited: she works in downtown L.A. from 7:00 a.m. till 5:00 p.m., Monday through Friday. She still needs letters and loves to hear from her friends. Address letters: Norma Jean Almodovar; c/o Friends of Norma Jean Committee; P.O. Box 2037, Venice, 90294.

It's an improvement in her situation, but not a great one. She lives, works and commutes in an area patrolled by the people who confiscated her manuscript and "arranged" a three year prison term for her to keep her quiet: the LAPD. We hope there are no confrontations.

Now the bad news. We have had an application for prisoner-of-conscience status with Amnesty International since January. In July her attorney made a personal presentation in London, and was told that Norma Jean was a "borderline" case. Since Norma Jean starts parole Dec. 14, we fear AI's priorities will sink even further. Of course, the danger to her will not diminish, even with parole.

Not only does the risk to Norma Jean's life continue with parole, the opportunity for police harassment and further coercion is increased. Here's how: During this time Norma Jean and any friend she visits can suffer a reduction in their Constitutionally guaranteed rights. If she visits your home, the police may enter without a search warrant and search the premises and persons on that property. If the police find (or claim to find) any prohibited substances or even a legally registered gun, Norma Jean goes back to prison for the balance of her three year parole, then begins a new three-year felony parole.

We urgently need people to write Amnesty International in London to encourage them to adopt Norma Jean as soon as possible. In writing, you should mention that this is A.I.'s



Year of the Woman Prisoner. Also, ask why is it they can see abuses of rights in other parts of the world, but not in the United States.
