## IT'S BUSINESS AS USUAL

### Through Rain, Sleet and Nuclear Winter

Last year, newspapers picked up an account of an Internal Revenue Service report which described plans for collecting taxes in case the nation were devastated by a nuclear attack. Many Americans were stunned to the point of disbelief; Don Meyer, chair of Region 64, wrote the accompanying poem expressing his outrage.

Now a superbly researched, readable book has hit the bookstores, titled *A Law Unto Itself: Power, Politics and the IRS*, by investigative journalist David Burnham. Below are some excerpts which will make you laugh and cry. Although the threat of nuclear war seems rather remote at this time, the reports quoted show all too clearly, and for all the world to see, just what the priorities of government really are.

Mr. Burnham waded through stacks of reports that detail how the IRS and the Treasury Department plan to collect taxes after 200 nuclear bombs have dropped on the United States and killed 100 million Americans, and destroyed both property and records.

"Here, memorialized in the turgid prose of long-forgotten bureaucrats," he writes, "was stated the absolute first rule of all governments: Nothing, not even the incredible destruction of nuclear war, is more important to any government than the collection of taxes."

"The title chosen by a middle-level Treasury Department technician for his Feb. 1966 analytic report on tax policy in the postattack period tells it all: Fiscal Planning for Chaos. One has to be truly upbeat to develop a tax plan for chaos."

As Burnham points out, the bureaucrats' main concern was not the horror wreaked on society, but the difficulties it would cause the government. A quote from the report:

"Because the post attack period would be one of chaos and disorganization of the revenue service, emergency tax proposals for individuals, corporations, and bank and nonbank financial institutions should be required to meet two standards. They are (1) revenue yield adequate for defense, short-term emergency needs and rehabilitation, and the quick restoration of services and damaged industrial facilities essential to national survival, and (2) simplicity of administration even to the exclusion of considerations of equity."

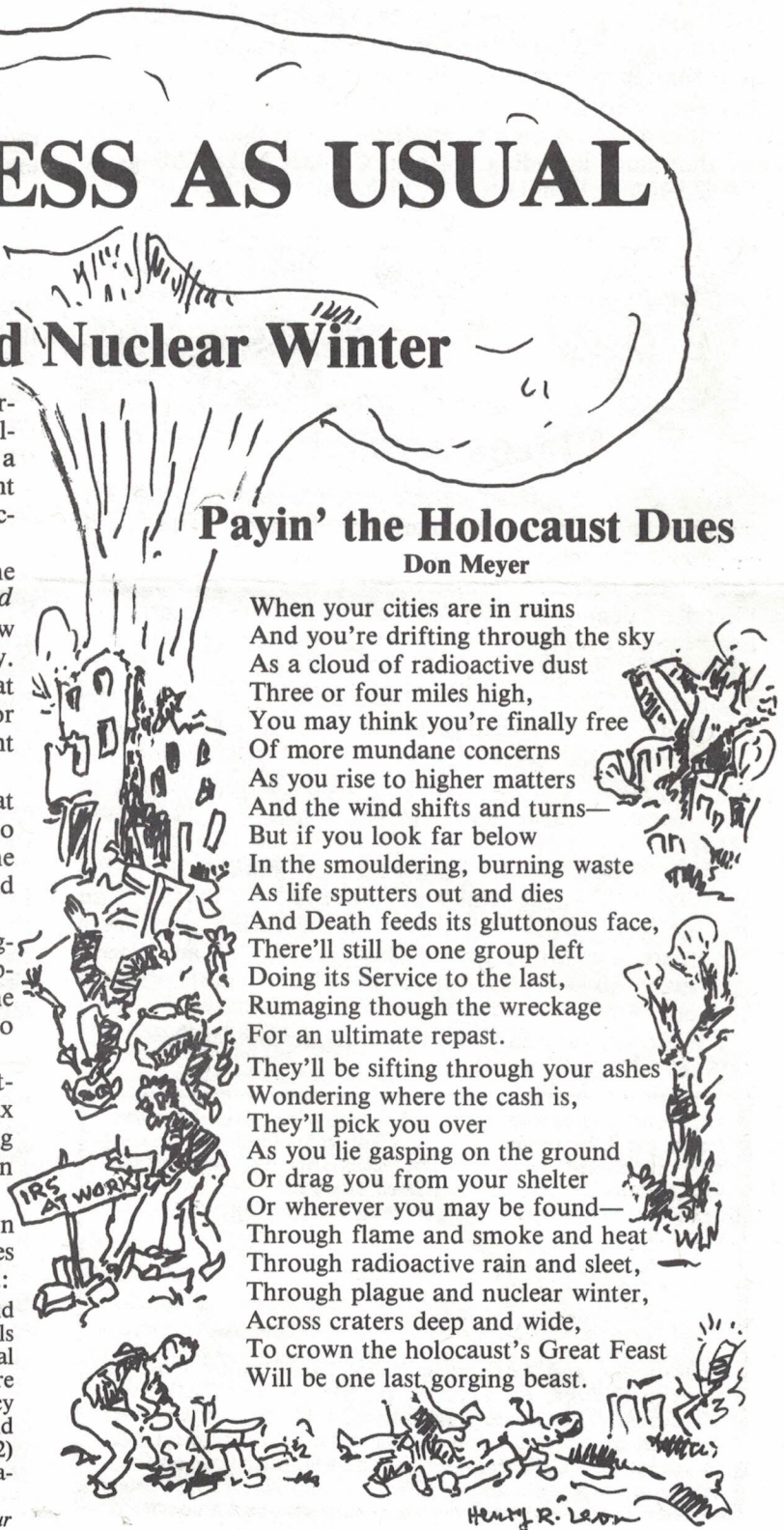

Will be one last gorging beast.





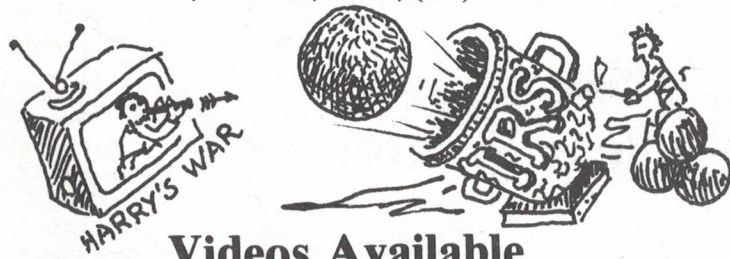
# News and Events from the Regions

## Operation New Broom Update

Bill Sullivan, chair of Operation New Broom, has been on radio talkshows all over the state, and reports "overwhelming" support.

# Libertarians Fight City Council Land Grab

Recently the city of Santa Clarita announced its intention to annex an unincorporated area of Los Angeles County. This annexation was made by resolution of the Santa Clarita city council. At no time did they ever intend to allow the residents to vote on whether they wanted to be annexed.

Bruce Bell, a long-time Libertarian activist from Canyon Country, is one of the residents being annexed. He decided that something could be done. Under state law, if more than 15 percent of the registered voters or property owners in an area to be annexed protest the action, an election must be held. Bruce sent out 400 letters to his neighbors asking them to write and protest the annexation. He talked with other angry neighbors and found many allies. He wrote letters to the editor of the local newspaper. And he also came to Region 61 asking for help.

The Region 61 Executive Committee authorized the printing of form letters protesting the annexation. Bob Leet made a sign. Ernst Ghermann manned a table outside a local market. Geoffrey Neale and Jordan Zimmerman went door-to-door. It's hard to say just how much help we were to the local activists, but it's safe to say that many of the locals were greatly encouraged by our gesture of solidarity.

Those local Libertarian activists joined local residents in battling the city of Santa Clarita. Perhaps the most encouraging action took place at a table that was set up alongside a major road in the area. The table was manned by local



residents, and large numbers of people people stopped by to add their protests.

The city of Santa Clarita had given just 18 days notice of their intent to annex, but in that short time enough people—over 950—had come forward. The city council has decided a special election will be held to determine whether annexation will occur.

The victory is small, but a victory it is. The principles of libertarianism need not be grand to be worthy, and our activism can make a difference.

## It's Time to Draw the Line

This year, April will be marked by more than the annual Income Tax deadline. The first of the month—April Fools' Day—is the deadline for all census forms to be filled out and mailed back. After that date, census takers will begin visiting non-responsive households and interrogating residents.

Over the years since this country was founded, the census effort has far exceeded the requirement of a simple numerical headcount of residents of the U.S., which is mandated by the Constitution. Instead, each household is sent an official census form of prying, impertinent questions. Failure to fill this out is punishable by stiff fines and even imprisonment. The government demands that you reveal how many babies the females in your household have had, the number of times you have been married, how you heat your home, the name of your roommate or household partner, your ethnic background, what crops you raised on your land (if any), how you travel to work, your income, and on and on and on.

The reason is simple. Originally, the idea for a head-count was to determine representation in Congress. Now it is to determine how to divvy-up the money from Washington—what districts get how much money, and for what purposes.

That is why with each passing decade the list has grown longer, the questions more prying. The 1990 census questionnaire is far worse than that of 1980, just as 1980's was worse than that of 1970.

"Government gone berserk!" is how long-time Libertarian activist Don Ernsberger describes it. Don is presently working as Special Assistant to the LP chair Dave Walter. He and Dave were the co-founders of the Society for Individual Liberty. Planning and coordinating opposition to the Census are among Don's many projects.

The Libertarian Party has taken a formal position of opposition to the Census and established the Committee for Census Privacy. In a letter announcing the formation of the Committee, Don writes:

"The 1990 Census effort will be spending an estimated \$1 billion to violate your rights. We believe the line must be drawn here and now. The time has come to take a stand against further intrusion into our private lives has arrived. With the help and advice of a distinguished advisory board, we have formed the Committee for Census Privacy as a vehicle for this effort. CCP has three basic purposes:

"First, we will work with like-minded legislators in Congress to pass legislation which makes non-head count questions strictly voluntary for all Americans; second, we will bring the problems discussed in this letter forcefully to public attention, through the means of advertising, mailings, publicity, demonstrations, and organization of local groups; third, if legislation is not passed by Congress to make the 1990 Census voluntary, we will help provide adequate legal defense for a number of persons who will test the constitutionality of the compulsory census by refusing to answer questions which go beyond the constitutionalist headcount."

The Committee recommends that you write letters right now to the two senators and your member of Congress demanding that they support and encourage those bills already introduced in Congress that would make non-head count questions strictly voluntary. You should also urge your friends to do the same, and of course letters to the editor of local papers are also in order. Check your phone book for the name of your representative. ## ExCom to Meet

The state Executive Committee will meet in San Luis Obispo May 19 and 20. Details next month, but Gail Lightfoot wants to let everyone know that all reports, resolutions, and other matters that are to be presented to the committee for approval or inclusion in the record must be in writing. This is to enable the committee to deal with them expeditiously.

## The Liberty Amendment

From time to time Libertarians talk about the Liberty Amendment, knowing it has something to do with getting rid of the Sixteenth Amendment, but not sure just what. Libertarian Party support for the Liberty Amendment was pledged in the first Platform when the Party was founded back in the early 1970s, and has been there right along. It has also been formally ratified by nine states. Will California be the tenth? Here is what it says:

Section 1. The Government of the United States shall not engage in any business, professional, commercial, financial or industrial enterprise except as specified in the Constitution.

Section 2. The Constitution or laws of any State, or the laws of the United States shall not be subject to the terms of any foreign or domestic agreement which would abrogate this amendment.

Section 3. The activities of the United States Government which violate the intent and purposes of this amendment shall, within a period of three (3) years from the date of ratification of this amendment, be liquidated and the properties and facilities affected shall be sold.

Section 4. Three (3) years after the ratification of this amendment, the sixteenth Article of amendments to the Constitution of the United States shall stand repealed and thereafter Congress shall not levy taxes on personal incomes, estates, and/or gifts.

Burnham learned that the possibility of nuclear attack and what to do about it was a concern through most of the cold war. For example, a few months after the 1966 report, on the day after Christmas 1967, Treasury Secretary Henry H. Fowler sent a confidential memo to Price Daniel, director of the Office of Emergency Planning, which reads:

"For emergency planning purposes, the estimate is widely used that a nuclear attack on U.S. metropolitan areas could result in 100 million casualties. Property damage would be incalculable in monetary values. That such devastation is considered a serious possibility forces us to the conclusion that no matter what form of tax system is adopted, one basic problem will be simplifying tax administration."

The experts were also concerned about the emergence of a market economy as Americans began to rebuild:

"Problems arising out of wide income differentials would not exist and the refinement of an income tax would not be necessary.

"Nevertheless, it would be desirable to have on the books a personal income tax at the outset of the emergency. The reasons for the very early establishment of a personal income tax, even though the private economic sector may have ceased to function, are that (1) the Revenue Service should have time to plan the administration of the tax. . . and (2) liability should be established at the earliest phases of the emergency to tax illegal gains made by speculators and black market operators."

This kind of planning continued into the 1980s, and a 1981 report concluded it might be necessary "to scrap the income tax system as we know it. . . Instead of an income tax, one

The initiative reads in part:

. . . (1) In all civil suits and criminal prosecutions, the jury has the responsibility to determine the facts, the right to judge the applicable law and the right to consider the motives of the defendant.

Before any civil or criminal case is heard by a jury, and again prior to jury deliberation, the court shall inform jurors orally in writing of the responsibility and rights specified in subsection (1). . .

could design a general sales tax which would raise the revenue required."

David Burnham is not a Libertarian, as is evident in his selection and discussion of IRS targets. He scarcely mentions the conservative and libertarian opposition to the IRS which has been going on since its inception. There's no mention of the Liberty Amendment, which nine states have ratified; no mention of any of the heroes and heroines of the anti-tax movement, such as Vivian Kellams or Jim Lewis. Industrialist Kellams, in the 1940s, took a stand by refusing to collect withholding tax from her employees. The case went to the U.S. Supreme Court; she lost. Jim Lewis, LP vice-presidential candidate in 1984, unsuccessfully fought the tax in court on constitutional grounds and was imprisoned for a year a year in the federal pen. People like Kellams and Lewis, although they lost, did fight the good fight and should be recognized in a book of this kind. Also, there's no mention of the Libertarian Party, not even a footnote.

Burnham seems to cherish a hope for possible reform, if only there were an infusion of "new blood." That's definitely not a libertarian position. We hold that the income tax is immoral in principle. Reform has nothing to do with it.

Despite these shortcomings, Libertarians and their allies will enjoy large parts of this book. The part about planning for chaos is in the first few pages. It gets funnier, and more depressing, from there on if that's possible. Published by Random House, 1989. \$22.50.

## For a State of Emergency

Assembly Member Richard Mountjoy (R-Arcadia) has introduced a very important bill in Sacramento—one which deserves Libertarian support. With anti-gun legislation popping out of the hoppers in every legislature and at the federal level, this represents a heroic effort to salvage some of the remnants of the tattered Second Amendment.

The bill, AB 3342, deals with possession of firearms during natural disasters or states of emergency. The Legislative Council writes:

"Existing law, with limited exceptions, requires persons to be licensed to carry concealed or loaded firearms. This bill would add to those exceptions any person who otherwise lawfully possesses a firearm and who resides within the area of a natural disaster for which a state of emergency is proclaimed by the Governor, as specified, or for which an emergency or major disaster is declared by the President of the United States, provided that the possession of the firearm is for the protection of that person or that person's property during the period of that state of emergency, emergency, or major disaster."

The bill also provides that "any person engaged in any lawful business, including a nonprofit organization, . . . from having a loaded firearm within that person's place of business, or any person in lawful possession of private property from having a loaded firearm on that property."

*CLNews* has only learned of AB 3342 and does not have information on its status. It was introduced Feb. 27, 1990, so it is just beginning its trip through the labyrinth of committee hearings. ## Gun Owners Caucus Report

The Gun Owners Libertarian Caucus met at the LP Convention in San Diego, Feb. 17. The consensus of opinion was that our goals for the National Rifle Association convention (June 8-12) would be to:

1. Secure endorsement of Larry Dodge's Fully Informed Jury Amendment;
2. Secure endorsement of Libertarian candidates for public office; and,
3. Secure a disavowal by the NRA of the fascistic views of former NRA executive vice-president Harlon Carter—expressed in the Sept. 1989 *American Rifleman*. Carter advocated that the U.S. government establish concentration camps where those accused of drug offenses would be imprisoned incommunicado and without trial for the duration of the "War on Drugs."
