## Voting on June 7 AN ACT OF SELF-DEFENSE

On June 7, in addition to choosing candidates for the November election, Californians will be voting on twelve ballot propositions. While none of our candidates are in a contested race, and in some districts we do not have any candidates, it is still vital that we get the vote out. A look at those ballot propositions shows why. Most are so outrageous that voting is an act of political self-defense. At its May meeting the LPC Executive Committee voted recommendations, and these are pretty easy to remember. For Proposition 66, it's yes — on all the rest a resounding no. Here's the analysis.

Proposition 66 is to ensure that county assessors are elected instead of appointed. Elected officials tend to be at least somewhat more answerable to the electorate since they can be voted out of office. Also, their actions are more easily monitored by those interested in doing so. Appointed officials are an especially privileged class.

Proposition 67 increases the penalty for the second-degree murder of a police officer from 25 years to life, while leaving it the same (15 years) for the second-degree murder of a private citizen. It was the sense of the Executive Committee that the life of a police officer should not be regarded as being of greater value than the life of anyone else.

Propositions 68 and 73 would impose limits on campaign contributions. Proposition 68 limits contributions to candidates to the state legislature while setting up a system of matching funds to be paid by the state. It also sets spending limits. Proposition 73 denies public funding, but limits contributions to all candidates, legislative and statewide. It sets no spending limits. *Santa Clara Libertarian* editor Jeff Smith sums it up: "We don't doubt the sincerity of the proponents of these propositions, but the recommended solutions are in gross violation of the First Amendment, will help political insiders at the expense of challengers. . . A better idea would be to reduce the ability of legislators to make such far-reaching decisions over people's lives. Let's treat the disease and not the symptom." Amen to that.

Proposition 69 is this election's LaRouche AIDS initiative. It provides for possible quarantine of 500,000 Californians who have AIDS virus in their bloodstream. Clearly a violation of the rights AIDS victims and others.

Propositions 71 and 72 seek to ease the Gann spending limit

imposed by the voters in 1979. Proposition 71 is supported by just about every government-loving special interest group you can think of. It would alter the method for calculating the allowable increases in state spending to allow for higher annual increases and cost \$700,000,000 the first year, going up every year thereafter. Gann wrote 72 himself in an attempt to deflect criticism from his original measure. It exempts transportation from the limit. There are some good parts of the bill, but the nefarious override these. Why tamper with the Gann limit anyway? It should be stricter if anything.

Proposition 70 and 74 through 77 are bond issues. Need we say more. California voters have not rejected a bond issue

## Here and There

**SAN JOSE:** San Jose residents are fighting construction of a proposed sports arena which is strongly supported by Mayor Tom McEnery and big business interests. The subsidized boondoggle will cost of \$1,000,000 in tax dollars. It's an uphill battle. First, it was necessary to collect enough signatures to place the issue before the voters so they can say whether or not they actually *want* a sports stadium. The petition drive was predictably strongly opposed by the the mayor, but was successful despite his opposition. Lending active assistance as signature gatherers were LPC members Casey Fuller and former state chair Mark Hinkle.

The next step, which is the hardest, is to convince enough residents of San Jose to understand the nature of this white elephant and to get the vote out. A grassroots political action group has formed called No Blank Check on Arena, and Casey is active in it. 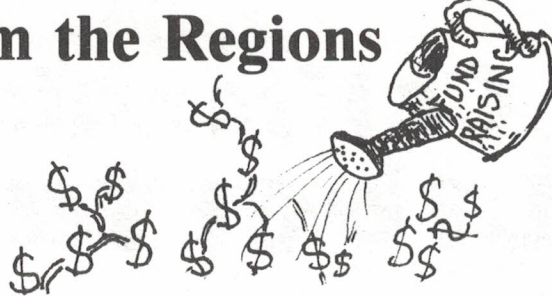

The LPC has a real chance for growth in the near future. The state excom's decision to hire a full-time office staff (one person to start) for our San Jose headquarters will not be a panacea but it will show our commitment to move ahead.

Many tasks have gone undone without consistent availability of personnel, including follow-ups on inquiries and fundraising, sending news releases to the press, and devising new strategies for making our positions better known to the public. These tasks and many others will be the responsibility of the office staff. I expect great things from this project.

A new life membership category has been created. This means that for \$500 you will never receive another renewal notice! Please consider becoming a life member, and note that \$300 will go to your local county organization and \$200 to the state LP.

We unfortunately have not been maintaining our voter registration figures. From a high of 80,000 following our successful 1979 ballot drive, we have dropped to 48,000 registrants in California. Please urge your family and friends to check our box on the registration form. You might remind them that registering doesn't necessarily mean the same degree of commitment to the cause that becoming a dues paying member does. Forms are available at most post offices and at your county registrar of voters.

There will be a drive to organize the LP in all 58 California counties. Currently we have organizations in 28 counties and members in 46. If you are interested in starting an organization in your county or are frustrated by a lack of activity on the part of an existing one, please call me a (213) 257-8922 to see what we can do.

Last but not least, please vote on June 7, and urge your friends no matter what their party affiliation to vote yes on Prop. 66, no on Props. 67 through 77.

# There's No Silver Bullet

There is considerable debate on what needs to be done to achieve a free society, and unfortunately most efforts to describe an effective strategy fail. This is due to a problem I call the "silver bullet syndrome."

The silver bullet syndrome is the illusion that all that is necessary to bring about a free society is to concentrate all our efforts on a single activity. This may be targeting a weak point in the government. It may be the search for a magic argument or method of persuasion which will instantly persuade large numbers of currently uninterested people to the libertarian cause. It includes the insistence that there's some previously ignored group of people to target who will solve all our problems.

Instead of actually doing something, these searchers waste time seeking for (and arguing about) a "silver bullet" to kill the werewolf of the state. Therefore, the LP and other libertarians should see the error of their ways and abandon everything else in favor of one activity.

My initial reaction is simple: Don't talk about it, do it. If your plan is as good as you think, then get started. Libertarians will join and support projects which prove effective. What they do not need is another "idea" about what everybody else ought to do.

The flaw in the silver bullet syndrome is the notion that there is one right way to achieve victory. It means that every other approach must be opposed or second guessed. The silver bullet approach generally calls for a strong, centralized Libertarian Party. This leads to struggles for control which often degenerate into factionalism.

The alternative is the decentralized or "capital market" approach. This involves creating a variety of self-sustaining and self-financing projects. Each project competes in a kind of resource capital market for the time and money of libertarians. Successful projects will attract more time and money, while unsuccessful projects will be revised or disbanded. The role of the LP in this model is more one of a stock ex-

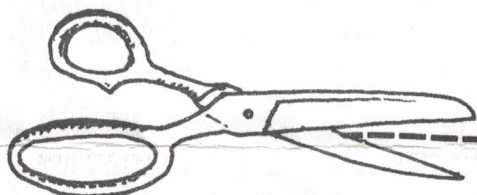


change where project entrepreneurs try to attract resources. The role of the chair is one of venture capitalist and broker, rather than someone who tries to do everything.

The decentralist model does not waste time trying to find a silver bullet. It stresses experimentation and innovation. The decentralist model appears to some to be "chaotic" because it is like the free market. If something doesn't work, then people try something else. If the project's entrepreneurs do not seem to be effective, then others can set up a competing project.

The advantages of decentralism are simple. It stresses flexibility so that opportunities can be responded to easily. It avoids the risk of placing all or even most of our organizational eggs into one basket. The responsibility for the success of failure of a project is clear. Each project can be as democratic or authoritarian as the situation requires. And finally, decentralism is the only approach which is compatible with the psychology of most libertarians. (As an aside, it makes it extremely difficult for anti-libertarian infiltrators to do much damage.)

There is no silver bullet or simple solution to our problems. It will take hard work and an ability to take advantage of opportunities while communicating a consistent message. To those people who are not satisfied with what has been done so far: don't complain about it. Do it!

# Rat Line Established

Throughout history governments have tried to get citizens to turn each other in, in part because the job of enforcing immoral laws is a big one. In the Venice of the Doges a special box was provided in St. Mark's Square for this purpose. Someone's name on a slip of paper was all that was necessary to ensure that that person would not be seen again. In Ray Bradbury's book *Fahrenheit 451* a similar device was set up to make it easy for people to inform on anyone suspected of possessing books. In Stalin's Russia (and maybe today) if you coveted your neighbor's apartment, his wife or anything that was thy neighbor's, you turned him in. He went to the camps and you were rewarded.

Now we too may enjoy this convenience. As part of something called the Underground Economy Taskforce, nine agencies of the state and federal governments — including the DEA, the INS, and the IRS — have established a special 800 number called the Underground Economy Hotline, where you can snitch on your neighbor without having to identify yourself. Just dial, and a voice will ask you to give the name and address of the violator, the nature of the violation, and the date and year it was committed. At the sound of the beep, inform.

Does your neighbor babysit without reporting her earnings? Does he repair cars in his garage without state permission and without paying the assorted fees and taxes for the "privilege of working"? Did you overhear someone say that the undocumented aliens they hired were their hardest



workers? Turn 'em in. Call the Rat Line. Of course the danger exists that some irresponsible citizens might call this number and give bogus information, thus reducing its effectiveness. If you know anyone who does this, turn 'em in. The number to call is (800) 822-4557.
