

Winchester Indoor Soccer is a start-up league for girls ages 7-10 and boys ages 6-8 designed to allow players to develop their soccer skills through indoor games. Games will be 5 vs. 5 at Lynch gymnasium with indoor size goals and referees.

The **girls'** league will be held on **Wednesdays** with games lasting 1 hour, starting either at 4:00 or 5:00. The league will run 15 sessions with a possible one week extension for playoffs. Game dates are Dec. 2, 9, 16; Jan. 6, 13, 20, 27; Feb. 3, 10, 24; and March 3, 10, 17, 24, 31.

The **boys'** league will run on **Tuesdays** with games lasting 1 hour, starting either at 4:00 or 5:00. The league will run 15 sessions with a possible one week extension for playoffs. Game dates are Dec. 1, 8, 15; Jan. 5, 12, 19, 26; Feb. 2, 9, 23; and March 2, 9, 16, 23, 30.

In order for this league to run, we need a parent volunteer/coach for each team. The coach's main role is to help with substitutions, goalie changes, and keeping order on the sidelines – no soccer knowledge is required and parents can switch off or share coaching duties.

Cost: \$100 per child (includes Winchester Indoor Soccer t-shirt, rental fee, and cost of referees)
