

PARENTAL ACTION REQUIRED!

ALL students in grades K-12 must have all immunizations required per Pennsylvania state law. **According to Pennsylvania regulations, your child will be excluded/not allowed to attend school unless documentation of the required vaccinations is provided to the school nurse.**

If your child has received the required vaccinations, you must provide your child's vaccination records to the school nurse.

If your child needs vaccinations, call your healthcare provider immediately. If your child is unable to get his/her vaccinations with their healthcare provider, please pre-register for one of the Montgomery County Health Department **FREE** clinics at www.health.montcopa.org (under Spotlight titled, "Required School Immunizations for Students K-12: Free Clinics").
