 9. There will be 2 pools of 4 teams, playing a round robin. Matches will be 2 out of 3 games to 21. If a third is necessary it will be to 15. The two teams from each pool with the best match records advance to the finals. If teams are tied at the conclusion of pool play the winner will be determined by the following criteria:
 - 1) head to head
 - 2) won/loss % based on 1st two games of each match
 - 3) defensive points – 1st two games of each match
 - 4) coin flip
 10. The semi-final and championship match will be 2 out of 3 games to 25 with the 3rd game 15 if necessary.
 - There will be a ten minute warm-up for your first match of the day (4-4-2).
 - All remaining matches – 5 minute warm up.
