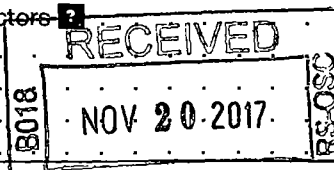



In 2016, Omni Oakland Commons determined that it would be unable to purchase the building which it had been leasing as well as subleasing to other non-profit organizations at affordable rates. Sudo Room, a non-profit that had been sub-leasing, was able to make the purchase in December of 2016. It was agreed to do this in order to preserve the space for public benefit.

Omni Oakland Commons' directors are designated by the resident organizations, each organization designating 1 director. Sudo Room's directors agreed to modify their bylaws to adopt this process to be able to expand their mission to include the management of the property. To facilitate the transition, most organizations designated the same director. The transfer of these assets were required to continue operating the space in a similar manner.
