Specifics and diminutions of walls

Section one:

This section shall be dedicated to LCp. J.D. Walker, his life and service.

This is the inside wall of the entrance to the building where the door to the meeting room is located. It is a block wall about 20' long X 10' high.

Section two;

This section shall be dedicated to the American Legion and the five branches of service allowing areas so that past, present, and future members may be added at a later date. This wall is the inside wall of the entrance to the building, to the left of the entrance to the main part of the building. This wall is a brick wall about 13' long X 10" high.

The designer / artist may sign their name on the wall murals.
