Race is limited to the first 4,000 entrants so register early. There will be no race day registration.

FEES: \$20 total. Includes \$15 Entry Fee and \$5 T-shirt fee. 100% of Entry Fee will be donated to the Greater Denver Area School of your choice.

TRAINING

FAMILY TRAINING RUNS: Train with NIKETOWN at Special Family Training Runs 4/12 and 4/26 (9-10:30 am). Geared toward kids but fun for the whole family. Simply lace up and show up at NIKETOWN at Denver Pavilions.

NIKE RUN CLUB: Train year-round with the free NIKE Run Club Tuesdays at 5:30pm.

RACE

MANDATORY PACKET PICKUP: Pick up your race packet at NIKETOWN. Located at Denver Pavilions.

- Thursday, May 1 (2-7pm)
- Friday, May 2 (2-7pm)
- Saturday, May 3 (10am-6pm)

COURSE: Choose between a certified 5K (3.1 miles) or the Let Me Play 1 Mile. Both distances start and finish at NIKETOWN at Denver Pavilions.

PARKING: Off-street parking is available in the area.

TIMING: 5K entrants who would like to receive an official time and be eligible for age group awards must pick up a timing chip on race morning and return it at the finish line. The Let Me Play 1 Mile is not timed.

I acknowledge and agree that:
