

**FOURTH ADDENDUM TO AND EXTENSION OF  
AGREEMENT FOR JOINT LEGISLATIVE EFFORT  
WITH OSCEOLA LEGISLATIVE EFFORT, INC.**

This Fourth Addendum and Extension is by and between OSCEOLA COUNTY, THE CITY OF KISSIMMEE, THE CITY OF ST. CLOUD, THE OSCEOLA COUNTY SCHOOL BOARD and OSCEOLA LEGISLATIVE EFFORT, INC., and is to that certain Agreement between the parties dated February 11, 2000, amended November 21, 2001, January 26, 2004, and July 6, 2006, hereinafter referred to as "the Agreement." The Parties, in exchange for the mutual covenants contained herein and in the Agreement, agree as follows:

1. This Fourth Addendum expressly modifies the Agreement and, in the event of a conflict, the terms and conditions of this Fourth Addendum shall prevail.
2. Section 2 of the Agreement is amended to read as follows:  
  
The term of this Agreement shall extend until September 30, 2009.
3. This Agreement shall become effective on the last date on which it is approved by a party hereto.
4. All other terms and conditions set forth in the Agreement shall remain in full force and effect and unchanged as agreed to by the parties.
