Mr. Crawford,

We receive Slosberg Funds from the County Commissioners office in quarterly payments. This year we received from July - September \$237,276, from October - December \$247,599 and from January - March \$273,303. We have not received the April - June payment. We receive 93% of the monies collected.

The School District of Palm Beach County receives the funds and then transfers the money to the Safety Council of Palm Beach through our purchasing department. The school district provides curriculum instruction for our students and the Safety Council provides the behind the wheel driving.

The monies are used by the safety Council for driver salaries, gasoline costs, purchasing new vehicles, maintenance of existing vehicles, insurance and liability coverage.

This year the school district has collected \$758,178 and has held back 10% to upgrade technology and curriculum in our classrooms. Due to budgetary constraints and the cancellation of driver education being offered for summer school we are using the 10% to hire school district teachers to keep the summer program alive.
