

# Conspiracy Theory of 9-11

911: "Okay try to calm down so you can conserve your oxygen, okay? Try to.. try to.."

On September 11th, 2001, the North and South World Trade Center were hit by American Airlines Flight 11 and United Airlines Flight 175. These passenger flights were hijacked by five al-Qaeda members who deliberately crashed the planes into the Towers causing the buildings to burn to the ground. This so-called terrorist attack took 2,996 peoples lives, including 19 hijackers. But was this chilling event really a terrorist attack on America or was it our own government? The possibility exists with many forms of evidence that 9-11 was a conspiracy done by our own government.

Mostly everyone believes that the government is a place we can rely on and be trustworthy of. But facts proving that 9-11 was an inside job done by the government could change that. After the planes crashed into the towers there were many reports of people hearing and seeing explosions from the buildings. The possibility that bombs were placed in the buildings before the planes hit is very high. It was said that fires from the jet fuel burning melted the iron and steel rods of the buildings and thats what caused the buildings to fall to the ground, but burning jet fuel can't get hot enough to melt iron and steel. An engineer and architect that has been studying the attack said " Jet fuel and office fires cannot melt iron or steel. They don't get half as hot as that and so something else was there, very energetic material that had to be placed throughout the building" (Press Tv and Robert n.p). This evidence shows that physically it's impossible for the buildings to have collapsed just from fire. The engineer and architect that has been studying the event says that other energetic material had to be involved only means one thing, bombs were involved. After the buildings had collapsed and the debri was being cleaned up, melted steel and iron rods were found throughout the rubble. This physical evidence proves that bombs or explosives were involved in the attack. But who knew about the attack before any of us did? The government did, the

possibility that the government secretly placed explosives in the Towers before the attack and planned to have the planes crash into the buildings to set them off is very likely. The buildings fell symmetrically down two hours after the attack. For the buildings to fall symmetrically down from the planes hitting it is nearly impossible. Theologian David Ray Griffin gave a speech saying that recently revealed evidence seals the case that The Twin Towers were destroyed by controlled demolition with explosives. Griffin said “ They fell straight down into their own footprint at free-fall speed, meeting virtually no resistance as they fell a-physical impossibility unless all vertical support was being progressively removed by explosives serving the core columns. The towers were built to withstand the impact of a Boeing 707 and 160 mile per hour winds, and nothing about the plane crashes or ensuing fires gave any evidence of causing the kind of damage that would be necessary to trigger even a partial or progressive collapse, much less the shredding of the building into dust and fragments that could drop at free-fall speed” ( Before It’s News and Dr.Griffin n.p). Griffin said that the towers were built to withstand a Boeing 707, which is a 336,000 pound plane with a wingspan of 146 feet, if a plane that large hit a building as tall as the World Trade Center, it would fall just like a tree would fall after you cut it. But after American Airlines Flight 11 and United Airlines Flight 175 hit the North and South towers the buildings remained standing symmetrically. After both planes hit the towers and people stood and watched in terror, the towers slowly began to fall symmetrically down and reports of hearing and seeing explosions were reported. Before the planes hit the North and South towers bombs and explosives were secretly placed in the towers by our government. Making 9-11 a controlled demolition.

There were people on the inside of the government that knew about the planned demolition of the Twin Towers, but stayed quiet to protect themselves and the government from harm. But Deborah Palfrey didn’t want to stay quiet about information she had involving

the government and the Twin Towers. Deborah had information exposing the government through her escort service, Pamela Martin and associates, she also claimed to have information about 9-11 being a government staged attack. Deborah was deep in with the feds and planned to expose them in court, but she was afraid that she could be “suicided” by the government. Suicided means that the person with the information against the government is killed and the crime scene is staged to look like a suicide. In an interview on the Alex Jones show, Deborah explicitly stated “I’m not planning to commit suicide” and made her intentions clear that she was going to present her case at trial. She said “I plan on exposing the government in ways I do not think they want me to expose them.” About a year later Deborah was found hanging in a storage shed, dead. Deborah was killed by the government so that she wouldn't leak their secrets and they could keep the truth a secret (Molon Labe n.p). Some may say that Deborah being found dead a year later was just a coincidence, but her case wasn't the only case where someone involved with the government was “suicided” for knowing too much information. A man named Barry Jennings was also found dead because of his knowledge about the truth of 9-11. Jennings was a Deputy Director of Emergency Services Department and the New York City Housing Authority. On September, 11th, 2001, Jennings saw and heard explosions before the Twin Towers fell, while attempting to evacuate the building with NYC corporation counsel Michael Hess. Jennings was going to go public with the information he had, proving that he had in fact heard explosions before the Twin Towers fell.

After the planes crashed into the North Tower of the World Trade Center, America was too distracted to see Building 7 collapse to the ground. Building 7 had not been hit by a plane but was damaged by fire. "The planes were just a distraction," says Professor James Fetzer, a recently retired philosopher of science at the University of Minnesota. "The evidence is so

overwhelming, but most Americans don't have time to take a look at this"(Christina Asquith and Professor James Fetzer). Like before, facts have proven that fire alone couldn't bring down the towers, so there must have been explosives placed in the buildings before hand. Building 7 fell just like the North tower did, it fell symmetrically to the ground. Proven like before, it is impossible for fire to melt the steel and iron bars to bring the building down. The planes hitting the North tower was a distraction so people wouldn't see the other tower fall from explosions.

Many people are convinced that 9-11 was in fact a terrorist attack, but they haven't looked into the hard evidence that proves it to be an inside job. Its hard to believe that our government would do such a thing to us, but you can't always trust everyone. Christopher Pyle a professor of constitutional law said "To plant bombs in three buildings with enough bomb materials and wiring? It's too huge a project and would require far too many people to keep it a secret afterwards"(Christina Asquith and Christopher Pyle n.p). But then how do you explain all the physical evidence that proves that to be false. The government planned this controlled demolition for a very long time and had the best people go to plant the bombs in the Towers. Bomb-sniffing dogs were removed from the Twin Towers five days before the attack. Also The Twin Towers had been evacuated a number times in the week preceding 9-11. This suspicious behavior gave the bomb carries time to go inside the building to plant the bombs before the attack. There would be no other reason for bomb-sniffing dogs to be taken out or for random evacuations of the Twin Towers before the attack. Also anyone involved with the government and the controlled demolition wanted to keep quiet so the government wouldn't suicide them. The government holds a lot of power, and they know how to use it to get what they want.

September 11th 2001, will always be a big significant event that happened in America. It impacted and change many peoples lives. This event will be taught to future generations in their history classes, they'll hear the story that terrorists attacked the World Trade Center which brought both the North and South Towers down, and also including Building 7. We can only hope that there will people who are able to see the evidence of the story that know that it is impossible for the event to have been terrorists. People shouldn't be taught the wrong information about the serious even of September 11th. I wish I could say that this chilling event was done by terrorists and not our own government, but 9-11 was a controlled demolition conducted by our government. I believe that a lot of people have questioned if 9-11 was really a terrorist attack or not, and they couldn't grasp why the government would want to do something like this to us. President George W. Bush used the event of 9-11 as an excuse to begin militarization of America for the purpose of world conquest. The government gives us many reasons to trust them, but how can we trust in someone who lies to us? September 11th, 2001, is still a day we remember each year, we take a moment of silence that day for the many people who lost their lives from burning in the fires, jumping out of the windows, or from breathing in too much smoke from the fires.
