Children will definitely need an accompanying parent if flight is to MBS. No direct flights. Unaccompanied minors is only on direct flights.

I considered your rationale keeping the children beyond your court ordered parenting time and refusing the travel arrangement I purchased for the children.

The November 7 custody DECISION stated that on odd years we share cost of transportation for the Christmas vacation. By my interpretation, a one-way-ticket for each child, with the additional support of the "unassisted minor" service, to return to their home state of Michigan meets that requirement.

In a text message yesterday you stated "we will return to the standard order". While that is not within your right to mandate, I considered what you'd suggested. The standard order states that the person who is starting parenting time must provide transportation. Please refer to the final sentence of the previous paragraph.

In addition, the Standard Order says "the rules of the airline must be followed." According to Southwest Airline, Rocco and Mia were within the age range to travel as "unassisted minors". I believe you were the one to point this out to me verbally the first week of November. Interestingly, if there was a chance of the plane being re-routed, Southwest Airline would not allow the children to travel. That decision would have been taken out of our hands.

Finally, the Standard Order states that children must be transported by the nearest airport. While Flint Bishop may be closest to your parents home, MBS Airport is closest to mine. Please use this airport when transporting the children from now on.

The children need to be returned home immediately. During your October Contempt of Court hearing, Judge Borchard asked me directly if I wanted you to spend time in the Saginaw County Jail. As a social worker in this community, I've heard horror stories about the Saginaw County Jail and I vehemently said I did not, concerned for

your well-being as you are unaccustomed to the violence you will find there. If asked again I will have a different answer indeed. You are not in charge. You have to follow the rules. Maybe some time in Saginaw County Jail is the only way you are willing to let this life lesson sink in. We all have choices, Tony.
