**Rocco vomiting at 3:30am and has been making suicidal comments**

Yes Melissa, it is a full month's worth of Strattera. That probably is an additional 30 pills/doses to the 18 Rocco came to me with. I will send whatever pills are remaining, my immediate concern is the health and well-being of our son that was vomiting at 3:30am this morning.

There is a real possibility that the Maryland doctor might think the present dosage of Strattera is inappropriate for Rocco's declining body weight. Which decision makers need to be involved so that Rocco has a smooth transition of care between parents.

Does Rocco's prescribing physician have your medical history, especially of: heart problems (such as irregular heartbeat), family history of heart problems (such as sudden cardiac death, irregular heartbeat), high blood pressure, liver disease, and personal/family history of mental/mood disorders (such as bipolar disorder, depression, psychosis, suicidal thoughts).

Melissa,

Someone from Saginaw, MI deactivated Rocco's patient status at pavilion pediatrics, canceling his 2015 appointment. This was only done to Rocco, not to Mia.

I learned this on Friday when I spoke to Amy Jordan (now Amy Marshall). They are trying to schedule another one of their Johns Hopkins providers (an MD) who has earlier availability.

They have provided an emergency script to treat Rocco's physical addiction to stratera, but have zero medical records from Saginaw. They do not have any medical observations showing medical benefit that outweighs Rocco's stunted weight gain, vomiting, and

suicidal thoughts. Rocco has been otherwise playful with neighborhood children (sledding down grass hill on cardboard boxes).

I have cautiously enrolled children in summer camps, but have had zero input from you. Aunt Nancy is on call and is within 15 minutes of Rocco and Mia. My CMS office at the United States Department of Health and Human Services is 30 minutes away.

Lastly, Rocco vomited this morning at 3:30am as a clear side effect of the poison Judge Borchard has ordered me to feed him. Rocco doesn't want to take this poison, but I told him that the judge will take him away from me forever if he stops. Rocco promptly swallowed the "medicine" with appropriate resentment of Judge Borchard's consistent disregard for children's health and safety.

I am upset with the dangerous lack of transparency and inadequate medical care in rural Saginaw, MI.

I expect to receive complete medial justification for this poison so that professional medical practice can properly examine Rocco and offer a genuine opinion.

The non-mediated Mia is similarly playful, but isn't experiencing the negative side effects of the Stratera that the government is jamming down Rocco's throat. Cool thing yesterday, Mia modeled to Lucy how to bravely jump off a 3 foot spring diving board. Lucy is now able to confidently walk to the edge of the diving board. Our daughter is becoming a little leader and I can tell she must be thriving in her swimming lessons in Michigan.

Mia has been playing with Bella (8 y/o) and Lucy (8 y/o). Rocco has been playing with Josh (8 y/o), Mathew (9 y/o), Henry (? y/o) and Ben (9 y/o).

Some younger siblings have been there (Isaac and Andrew), but were more limited.

Here are some pictures of the summer we are attempting to salvage from what tyrannical destructive powers Saginaw, MI.

Looks like today is going to be on short rest. Hopefully we can work together to improve the medical care of a resilient Rocco Calice.
