# CODE OF CONDUCT AGREEMENT

To be Read and Agreed to by Camper and Parent

Coppermine Fieldhouse is committed to making our camp environment safe and fun for everyone. All campers and their parents are asked to sign the "Summer Camp Code of Conduct" to demonstrate their understanding of, and compliance with, Coppermine's expectations from every child. We urge you to review the following information closely with your child. This form must be signed by all parents and/or guardians.

## SUMMER CAMP PARTICIPANTS ARE REQUIRED TO:

1. Be active listeners, cooperate, and follow directions given by camp staff, counselors, and guests at all times.
2. Treat fellow campers, staff, supervisors, guests, lifeguards, public and private property, and the environment with the utmost respect. We expect every camper to exercise goodwill toward others, our camp activities, and our natural surroundings. Courtesy and respect are requirements of our camp community.
3. Refrain from using rude, offensive, or generally bad language. Harsh verbal words, tone of voice, foul language or gestures will not be tolerated.
4. Keep their hands and bodies to themselves. If physical contact is made with another person, it must be a welcome gesture and appropriate. Unwelcome teasing, horseplay, pushing, kicking, hitting, fighting, bullying or harassment will not be tolerated and may be grounds for removal.  
*1st offense – child will be removed from the current activity and parents are notified.*  
*2nd offense – child will be sent home for the day (no refunds).*  
*3rd offense – child will not be allowed to come back to camp for the summer (no refunds).*
5. Stay with the camp group, and/or their buddy, at all times. No child is permitted to leave the camp group without his or her counselor's permission and direct supervision.
6. Know and understand the general camp rules, regulations and guidelines.
7. Absolutely any child that bites will immediately be removed from camp. Coppermine has a zero tolerance policy for this action.

*NOTE: It is not possible to anticipate every possible situation that may arise. In the absence of a particular situation or activity not listed above, COMMON SENSE AND COURTESY SHALL PREVAIL.*

## CONSEQUENCES:

Our staff will immediately investigate all incidents. Should a child's behavior be deemed inappropriate, the camp staff will handle the situation with appropriate discipline practices. This may include removing the camper from the group and notifying the parent(s). In addition, any child who does not or cannot respect his or her fellow campers, our staff, the environment, and/or the entire camp community - and who does not respond to our intervention - will have their parents called, dismissed from camp for one day, or dismissed from Coppermine Fieldhouse Summer Camp permanently at the discretion of the camp director. Dismissal from camp does not constitute a refund.

## PLEASE NOTE:

Any child that takes medication during the school year is asked to maintain usage while at camp. Any child that has an aide, IEP, or 504 plan must notify us at [camp@copperminefieldhouse.com](mailto:camp@copperminefieldhouse.com) prior to attending camp.

- **Premium After Care at Coppermine Fieldhouse:** Instruction 4:30-5:30pm Monday-Thursday. Additional \$50 per week extra to traditional aftercare. Swim School, Archery, Rock Climbing and Soccer available.
- When picking up a child from after care please visit the front desk with your dismissal card so we can radio your child down to the lobby. **All After Care children must be signed out.**
- Consider packing a small snack, or we have snacks that start at \$1.00 each.
- If you are over 15 minutes late picking up your child there is a \$10 charge for After Care services.


# CAMP DROP OFF AND PICK UP

## MORNING DROP OFF AT FALLS ROAD:

- All campers are to be dropped off in the front of the building. We have three lanes for morning drop off and we ask that you maintain a safe driving speed when pulling up the driveway.
- For those parents that need to walk their campers in, please park along the curve of the parking lot (away from the main drop off) and walk your child in.
- For those campers that can be dropped off, we ask that you please pull as far forward in the carpool lane to the car in front of you and follow the traffic directions from staff. We will greet your child at your car and escort them safely inside.

## PICK UP AT FALLS ROAD:

- Print dismissal cards for your vehicles and write camper's first & last name as large as possible. One for each sibling.
- General dismissal is at 4:00pm from the Main Entrance. (See map below)
- Lil' Miners dismissal is at 1:00pm from the Back Entrance. (See map below)
- For **Early Pickup** you must let the front desk know in the morning, or as soon as possible.
- When arriving for general dismissal please **have your dismissal card placed in the front right passenger corner of your dashboard**. An attendant at the property entrance needs to see the dismissal card to radio it to staff inside the building. Please stay in car for regular pickup, we will escort your child(ren) to your car. Half Day programs operate the same way, excluding an attendant at the property entrance.
- If you arrive without a dismissal card, please park along the far curve of the parking lot and go to the front desk with identification. Be sure you have listed any authorized pick-up persons on the Health History, Emergency Medical & Pick-up Authorization form.
- If you arrive 15 minutes late for dismissal, please enter building for pickup.
- If you are picking up a child for a friend, please display both your dismissal card and the card for your friend. If carpooling, please display all dismissal cards for each family. Each sibling needs a dismissal card.
- We can only recognize Coppermine dismissal cards. No verbal names or personal photo copies accepted.
- We have three dismissal lanes for the general 4pm pickup. This is the most efficient method for the number of cars in our carpool lane. **We ask that you demonstrate patience as we shuttle children from the building to the cars. Please maintain a safe driving speed for dismissal while we are loading children. We will do the best we can to get children to you quickly.**
- Please pull up as far forward in the carpool lane to the car in front of you and follow the traffic directions from staff.
- Please remain in your vehicle at all times during carpool.






# ADVENTURE CAMP DROP OFF & PICK UP THURSDAY ONLY

## DROP OFF/PICK UP

- On the following **Thursdays**, Adventure campers will be spending the day at Robert E. Lee Park:

- DROP OFF your camper any time after 9:15am at the MAIN ENTRANCE to ROBERT E. LEE Park (off of Falls Road near Pepe's & the Light Rail). Please turn into the Light Rail driveway and make an immediate right onto Lakeside Drive and follow all the way to the main parking area of Robert E. Lee.
- For any camper that uses EARLY DROP OFF in the mornings (7:30am) you can bring your child as normal directly to Coppermine Fieldhouse & we will get your children to the park to meet up with the other campers. If your camper is in after-care we will bring them back to Coppermine for late pick up.
- PICK UP IS AT THE SAME LOCATION as DROP OFF at the park. Between 3:40-4pm.


