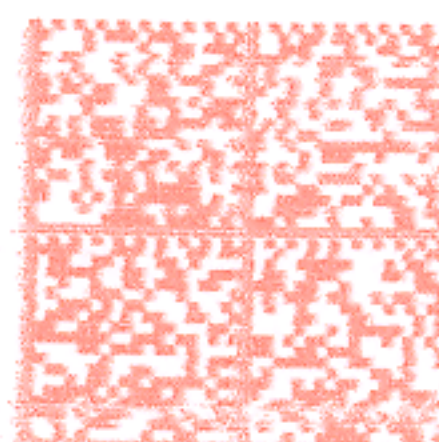

YOUR MOST RECENT PAY STUBS or PAY STATEMENTS which show your current AND YOUR year-to-date income; as well as documentation of **ALL OTHER SOURCES OF INCOME**. If you are self-employed, you will need your tax returns covering the last three tax years.
2. VERIFICATION AND COST of any health insurance coverage available to you through your job or business. VERIFICATION OF WORK-RELATED CHILD CARE EXPENSES which are paid by you (a sworn affidavit by the child-care provider of the amount paid, or a tax return which shows the federal child care tax credit).
3. If you intend to hire an Attorney to represent you on the date of the hearing, please contact that Attorney immediately and advise him/her of this hearing date.

FAILURE TO BRING THE REQUIRED DOCUMENTATION MAY REQUIRE YOU TO REAPPEAR ON ANOTHER DAY AND YOU MAY BE REQUIRED TO PAY THE OTHER PARTY'S COSTS FOR DELAYING THE CASE, OR YOUR REQUEST FOR RELIEF COULD BE DENIED.

ADJOURNMENTS FOR GOOD CAUSE MAY BE SUBMITTED FOR CONSIDERATION TO THE REFEREE OFFICE IN A TIMELY MANNER, WITH PROPER NOTIFICATION TO THE OPPOSING PARTY OR ATTORNEY OF RECORD.
