The signing of the Agreement between the Government of The Russian Federation and the Government of the Republic of Guinea-Bissau on cooperation in the field of Fisheries

In accordance with paragraph 1 of Article 11 of the Federal Law "On International Treaties of the Russian Federation" approved presented Rosrybolovstvo agreed with the Foreign Ministry and the Russian other federal bodies of executive power and pre-researched with the Guinean side of the project Agreement between the Government of the Russian Federation and Government of the Republic of Guinea-Bissau on cooperation in the field of Fisheries (attached).

Instruct Rosrybolovstvo hold talks with Guinea Party and by reaching an agreement to sign on behalf of Government of the Russian Federation said Agreement, allowing to make changes in the attached draft without a fundamental character.

The Government of the Russian Federation and the Government of the Republic of Guinea-Bissau, hereinafter referred to as the Parties,
Aware of the importance of fisheries to the economy of both countries,
on the basis of mutual interest in the development of fisheries,
protection of living marine resources from illegal, unreported and Unregulated Fishing

Taking into account the United Nations Convention Law of the Sea of 10 December 1982, and recognizing, in particular, provisions relating to marine fisheries and trade in live marine resources,

Desiring to establish and develop cooperation in the field of Fisheries on mutually beneficial terms,
Have agreed as follows:

Article 1

The purpose of this Agreement is cooperation between The Russian Federation and the Republic of Guinea-Bissau in the fisheries economy.

Article 2

The Parties undertake to promote cooperation in the following main areas:
conservation and management of living marine resources and management;
prevention, control and eradication of illegal, unreported and unregulated fishing of marine living resources;
exchange of information and documentation concerning fish

Exchange of information and documentation concerning fish management of mutual interest;
 conduct fisheries research, development and implementation of scientific and technical programs;
 development of aquaculture;
 training and skills development for the fishing industry, the direction of experts to exchange experiences;
 development and implementation of joint projects on the Sea fisheries, processing and marketing of fish products;
 development of mining technology (catch) and processing of fish and other target species, including the quality and safety fish products;
 development of related species fisheries production activities, in particular, shipbuilding, ship repair, Construction of freezing, refrigeration and processing capacity;
 allowing the use of Russian Guinean fishing vessels in port for repairs, maintenance maintenance, procurement, replenishment of food, replacement and crew rest, and for other purposes related to fisheries and research activities;
 Promoting cooperation between fisheries organizations of the Parties;
 Bilateral colloquia, symposia, seminars, consultation, case studies and exhibitions in the field of fish the economy;
 determine the conditions of the Russian fishing vessels fishing in the exclusive economic zone of the Republic Guinea-Bissau;
 Other areas of cooperation in fisheries management of mutual interest.

Article 3

1. In order to ensure compliance with the provisions of this Agreement, the Parties shall establish Russian-Guinea-Bissau Fisheries Commission (hereinafter - the Commission), which considers all issues related to the implementation of this Agreement.
2. Each Party shall appoint a representative to the Commission and his deputy, and shall inform the other Party on diplomatic channels.
3. The Commission shall meet alternately in Each State Party shall, at least once a year.
4. The Commission's findings documented in minutes.
5. At the first session, the Commission shall adopt its rules of procedure.

Article 4

On request, the Commission considers the Russian Party providing Party of Guinea Russian fishing vessels licenses to fish in the exclusive economic zone Republic of Guinea-Bissau, the rates for which are fixed in the relevant minutes of the Commission.

Article 5

In order to implement the provisions of this Agreement, the Parties, if they deem it necessary, the office will open Federal Fisheries Agency and Representation the relevant departments in charge of fisheries Guinea-Bissau, respectively, in the territory of the Republic of Guinea-Bissau and the Russian Federation on the conditions to be agreed between the Parties.

Article 6

1. In the event of any dispute or disagreement between the Parties concerning the interpretation and application of the provisions of this Agreement, the Parties resolve these disputes through consultation within the Commission.
2. Consultations referred to in paragraph 1 of this Article, held immediately at the request of either party.

Article 7

Nothing in this Agreement shall be construed as prejudicing the rights and obligations of each of the Parties under other international treaties.

Article 8

1. This Agreement is valid for 5 years and shall enter into force on the date of receipt of written notice of fulfillment by the Parties of internal procedures necessary for its entry into force.
2. This Agreement shall automatically be extended the next 5-year periods, unless one of the Parties notify in writing through diplomatic channels, the other Party not later than 6 months before the expiry of the 5-year period of its intention to terminate it.
3. Termination of this Agreement shall not affect rights and obligations under the agreement (contract) between the Parties under this Agreement during the period of its validity.
