

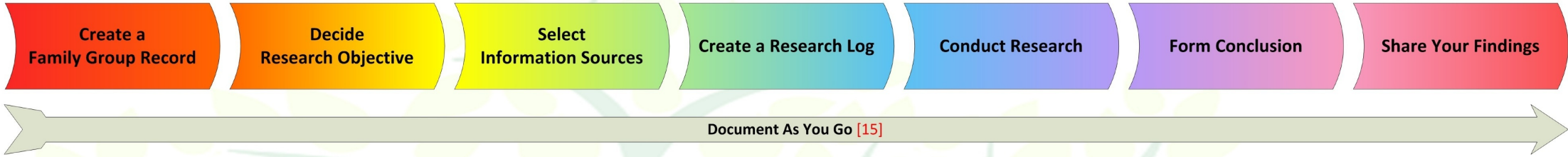
Identifying Your Ancestors, and Overcoming Hurdles

- Decide on one of your ancestor's to be researched [9]
- Identify all of the facts that you already know about your ancestor, along with any guesses
- Gather additional facts and guesses about your ancestor, from both family members and others
- Enter all of your ancestor's facts and guesses into a Family Group Record [1,8]
- Create at least one source-footnote for each fact and guess in the Family Group Record [7]

- Decide your research objective [9]
- Identify the single easiest fact that you want to find out about your ancestor *e.g.:* *place of birth* [2]

- Identify available information sources held in your ancestor's country or locality *e.g. census records, death records* [5]
- Understand both the strengths and the weaknesses of each information source [3]
- Select information sources for researching your ancestor

- Review the Genealogical Proof Standard [4]
- Create a new Research Log for your ancestor [6]
- Enter selected information sources into your Research Log, **before** starting your research [2,7]

- Undertake research using your Research Log, updating it as you go [6]
- Broadly search each selected information source [10]
- Research your ancestor in a community context [10]
- Consider name variations [11,16]
- Apply advanced research strategies [2]
- Transcribe handwriting [12]
- Assess evidence reliability [13]

- Correlate results [14,18]
- Resolve contradictory evidence [17]
- Form your conclusion
- Write a "proof statement", using the Genealogical Proof Standard [4]

- Share your findings and conclusions with both FamilySearch, and others
- Cite all information sources in FamilySearch, using the appropriate citation format [7]
- Add notes to FamilySearch, as needed

Some Important Research Principles

- Start with yourself, and then work backwards through your ancestors.
- Do not skip an ancestor, until you have completed reasonably exhaustive research.
- Do the easy research first.
- Focus on researching one new fact at a time *e.g.:* *place of ancestor's birth*.
- Document everything as you go.
- Collect multiple records for each ancestor, especially primary records. They are eyewitness accounts of events.
- Review the entire record, as it may contain important additional information.
- Do not trust transcriptions, as they can often contain errors.
- Proximity implies relationships *e.g.:* *a minister who performs your ancestors' marriage, may be related to your ancestors*.
- Ask lots of questions about your ancestor, such as why they immigrated. Imagine all the possible reasons, and then attempt to disprove or prove each reason.
- Cite all information sources.
