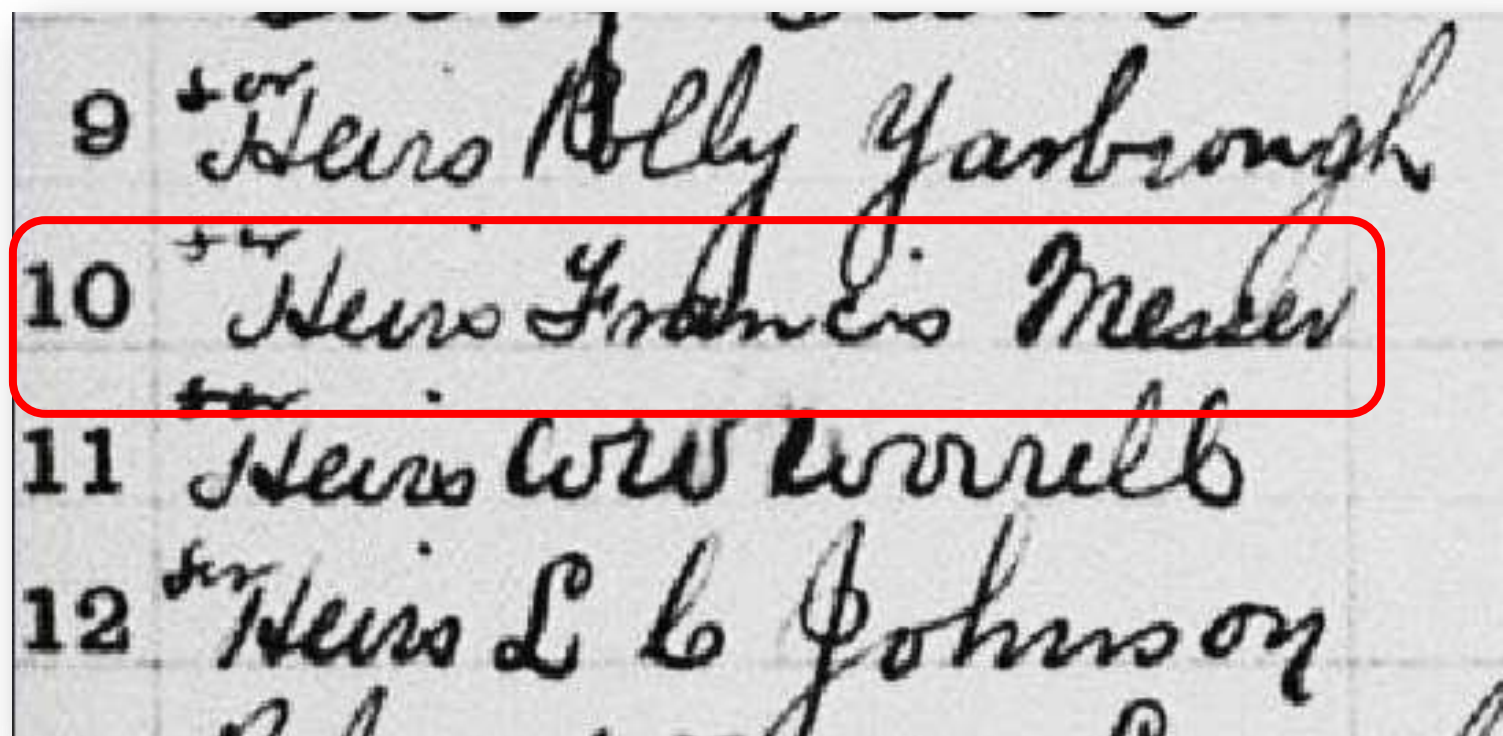
Column 2 contains the names of the Original Grantees. We do not index these names.

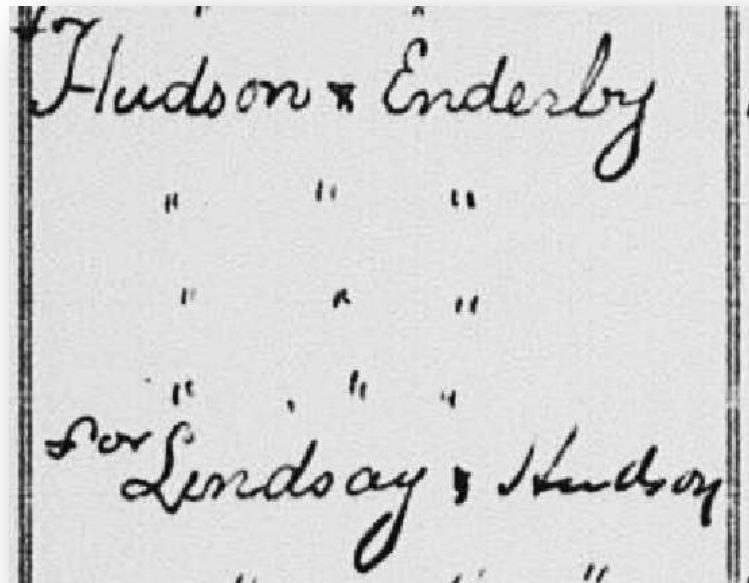

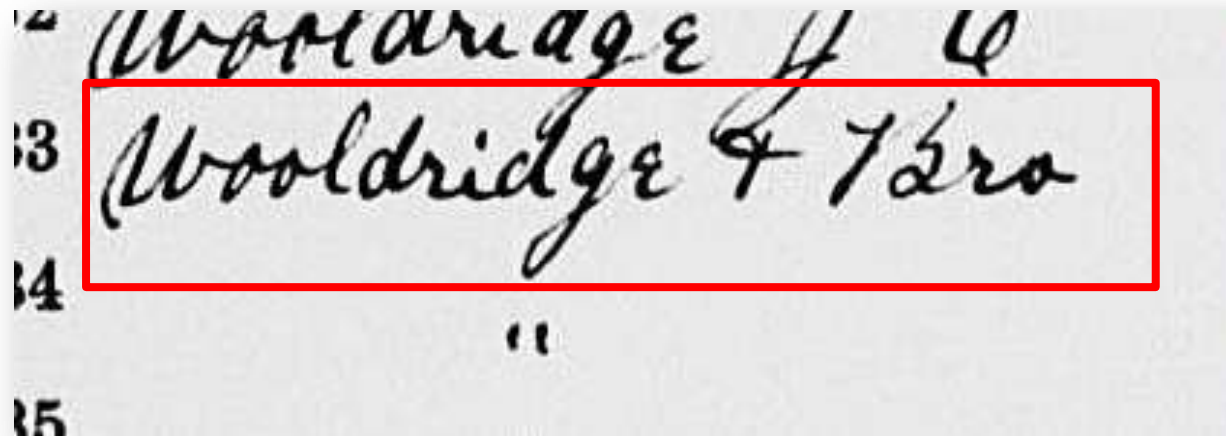


The terms *For* and *Heirs* are not captured.

If two or more names are listed as a single entry on the record, index each name individually as separate records. (Please note that these are Surnames and not considered Companies).



Do not index Agent, only the person they represent. In this case you would index Scott, J


Skip W N Craddock (note that he is an agent) and index the next name of Scott, Abner
