Translation: Holy Archdiocese of Athens. No.542. The Archbishop of Athens certifies that as shown in the Archbishopric's archives of marriages, on the 28<sup>th</sup> of the month April of the year one thousand nine hundred six (1906) a marriage license was issued, by which the reverent Ioannis Zisimopoulos, pastor of the Parish of Agia Foteini, was permitted to perform the marriage of Filippos Stalounis, son of Georgios, age 45, and Dafni Vlahopoulou daughter of Dimitrios, age 35, in matrimony for the first time, both of them. According to the declaration of the above mentioned priest the marriage was performed in accordance with the holy order of the Eastern Orthodox Church of Christ, on the 28<sup>th</sup> of April 1906.
